1) any NHS Trusts;

2) any other NHS entity;

3) any government department agency or other statutory body (for the avoidance of doubt including local authorities) and/or 4) any private sector entity active in the UK healthcare sector.

For supplies and/or services identified as Direct Contract Products 1) NHS Supply Chain 2) any NHS Trust; 3) any other NHS entity; 4) any government department agency or other statutory body (for the avoidance of doubt including local authorities) and/or 5) any private sector entity active in the UK healthcare sector will be able to enter into a direct contract with the Supplier for any of the supplies and/or services under the Framework. For these contracts the Supplier will be required to report to and pay a direct management fee to NHS Supply Chain as set out in the tender documents.
