AHDB would like to note this is work outside of the original contract and end date of the contract, but due to an STA (STA10167) being raised for this additional and unexpected work, AHDB require TwoEarsOneMouth to continue with this extra project for consistency.

The LEB pre-post work and Pork creative testing is confirmed work, with the pork pre-post work as an optional bolt on by AHDB.

A contract modification could not be completed due to being over 50% of the original contract value, so by AHDB raising an STA, we remain compliant.

The following variations to the contract terms are agreed between the Parties upon signing of agreement.

1. AHDB is authorised to use the Deliverables including any Supplier Proprietary Materials and Project Specific Materials to produce abbreviated summary reports from any full presentation report/debrief for use to present to external parties. It is agreed that the IPR in the Supplier Proprietary Materials remains with the Supplier and is commercially sensitive. Any publication thereof is only as agreed between the Parties or with the prior written consent of the Supplier.
2. A full report/debrief together with the questionnaire and results may be shared or published externally for purposes such as an external tender process by AHDB or similar discussions with external third parties.
3. Where data forming responses to questionnaires, results and other reports produced solely by the Supplier is to be shared or published externally, as a summary, AHDB will submit their summary report to the Supplier for prior comment.
4. AHDB may share or publish extracts of any Project as quotations, charts, tables, graphs or similar presentations to enable AHDB to support any findings, analysis or claims by the Supplier.
5. Any public statement, marketing material, press release or similar communication shall be disclosed by AHDB after prior notification to the Supplier and will include an acknowledgement of the Supplier's work where appropriate.
6. Subject to the variations agreed above and to any statutory requirement AHDB will not disclose any services provided under any Project including any full survey analysis tool and questionnaires developed by the Supplier which could damage harm or affect the Supplier's reputation or business in any way whatsoever including any commercial sensitivity and AHDB will not use any data in any manner which may exaggerate, distort or misrepresent the findings or the data provided by the Supplier.

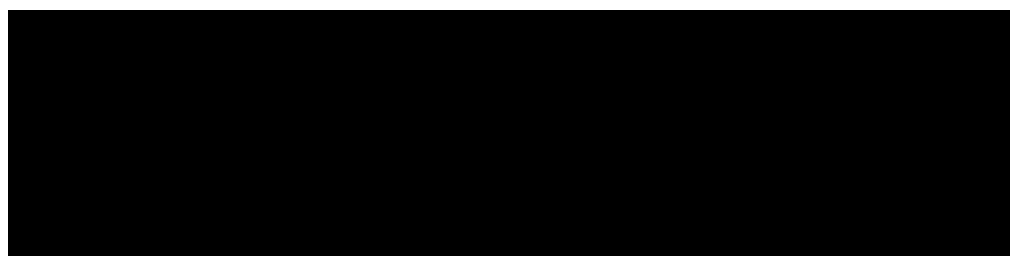

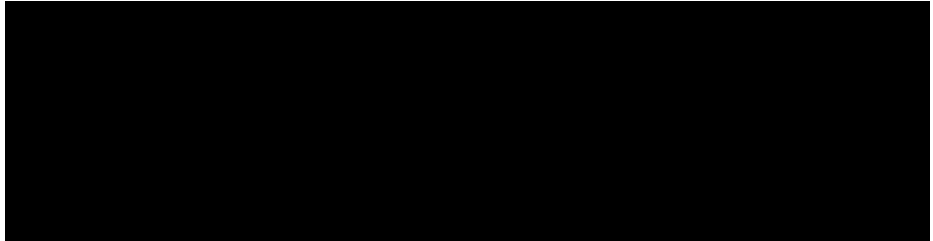
