Section 1 - FORM OF CONTRACT

CONTRACT FOR : Strengthening Government capability for delivery in

Punjab

THIS CONTRACT is made

BETWEEN: The Secretary of State for International Development at the Department for

International Development, Abercrombie House, Eaglesham Road G75 8EA

("DFID");

AND : Delivery Associates Limited ("Supplier")

(together "the Parties").

WHEREAS:

A. DFID requires the Supplier to provide the services as defined in Section 3 (the "Services") to the Government of Punjab (the "Recipient"); and

IT IS HEREBY AGREED as follows:

This Contract constitutes the entire agreement between the Parties in respect of the Suppliers obligations and supersedes all previous communications between the Parties, other than as expressly provided for in Section 3 and/or Section 4.

2. Contract Signature

If the Original Form of Contract is not returned to the Contract Officer (as identified in Section 4) duly completed (including the applicable Purchase Order Number at the top of Section 1), and signed and dated on behalf of the Supplier within **15 working days** of the date of signature on behalf of DFID, DFID will be entitled, at its sole discretion, to declare this Contract void.

No payment will be made to the Supplier under this Contract until a copy of the Form of





Contract, signed on behalf of the Supplier, is returned to the Contract Officer.

3. Commencement and Duration of the Services

The Supplier shall start the Services on 17th November (the "Start Date") and shall complete them by 16th May 2018 (the "End Date") unless this Contract is terminated earlier in accordance with its terms and conditions.

4. Financial Limit
