1. Introduction

- 1.1. This invitation to tender relates to the simplified competition to award a Contract for the Provision of VTC Equipment.
- 1.2. This simplified competition is being conducted under the CCS RM6068 Technology Products and Associated Services Framework Agreement Lot 4.
- 1.3. Authority: UK Strategic Command, The Ministry of Defence.

2. The requirement

- 2.1 A quantity of fifty Cisco Webex VTC units are required to replace an aging fleet of VTCs and provide new users access to video teleconferencing facilities.
- 2.2 The requirement involves the purchase of the exact CISCO UK part number and quantity of VTC units, accessories and licences. Exact specifications can be found in Call-Off Schedule 20 (Call-Off Specification).
- 2.3 Failure to provide a tender for the exact CISCO part numbers will result in the Authority rejecting the tender.
- 2.4 The Smart Licences and learning vouchers must be aligned to the following Cisco Smart Licensing domain and name: deands.mod.gov.uk and DE&S.

3. Delivery Information

- 3.1. Required delivery date: From Contract award, the equipment must be delivered within 2 months.
- 3.2. Delivery location: UK Mainland exact location released to successful Supplier.

5. Questions and clarifications

- 5.1. Potential Providers may raise questions or seek clarification regarding any aspect of this simplified competition at any time prior to the clarification deadline.
- 5.2. Potential Providers should raise clarification questions via the eSourcing portal.
- 5.3. The Authority will not enter into exclusive discussions regarding the requirements of this simplified competition with Potential Providers.
- 5.4. To ensure that all Potential Providers have equal access to

- information regarding this simplified completion, the Authority will publish all its responses to questions raised by Potential Providers on an anonymous basis.
- 5.5. Responses will be published in a questions and answers document to all Potential Providers who were invited to tender.

6. Submitting a tender

- 6.1. A draft Master Contract, showing CCS Core Terms (version 3.0.6), Joint Schedules and the relevant Call-Off schedules will be provided alongside this ITT document.
- 6.2. Potential Providers should submit a tender via the eSourcing Portal by populating Call-Off Schedule 5 (Pricing Details) to provide a quotation.
- 6.3. The quotation should clearly show a price breakdown for each part number and the associated quantity as detailed in Call-Off Schedule 20 (Call-Off Specification). The quotation must clearly show the total price, including any UK Mainland delivery charges.
- 6.4. Failure to populate Call-Off Schedule 5 (Pricing Details) to show this price breakdown per part item and the total price may result in a tender being rejected. The Authority reserves the right to reject any further material outside Call-Off Schedule 5 (Pricing) submitted as part of the tender.
- 6.5. The Authority reserves the right to reject any quotations that cannot provide the requirement in full.
- 6.6. All prices on the quotation must be in GBP and be Ex VAT.
- 6.7. A quotation must remain valid and capable of acceptance by the Authority for a period of 30 days following the tender submission deadline. A tender with a shorter validity will be rejected.

7. Tender evaluation

- 7.1. The Potential Provider who can provide the requirement in whole at the cheapest price will be awarded the Contract.
- 7.2. A price-only evaluation will be conducted whereby price will account for 100% of the tender score. A quality score will not be assigned.

8. Contract award

- 8.1. The maximum mark available for price will be 100. This mark will be awarded to the lowest priced Potential Provider. Remaining Potential Providers will receive a mark out of this maximum mark on a pro rata basis dependent on how far they deviate from the lowest price.
- 8.2. The calculation below describes how the mark will be calculated:
- 8.3. Score equals the lowest Ex VAT tender price divided by the tender price and times by 100 (maximum mark available).

9. Outcome letters and call off contracts

- 9.1. Upon contract award Potential Providers will be notified of the outcome by letter via the eSourcing portal.
- 9.2. Upon submission of outcome letters, a standstill period of 10 calendar days will commence.
- 9.3. The Contract will be issued to the successful Provider for signature via email once the standstill period has ended and no objections have been received.
