## **INTRODUCTION**

North East London NHS Foundation Trust (NELFT) are looking to purchase Key Management Cabinets within the secure facility where Clinical and Non-Clinical staff members will use this on a daily basis, prevent staff from taking off-site, misplacement, keep keys in a secure environment, deny unauthorised access.

The secure Cabinet is to ensure that Keys do not go missing and the system allows the trust to ensure keys are positioned back before the end of the shift. The Keys must be allocated to the staff member and cannot be transferred over to another staff without replacing the keys back within the secure cabinet.

The secure cabinet must have a software to allow the trust to track the keys and whom they are allocated to. The software and any updates will be a part of the cabinet at no additional costs. The software should be installed on the trust device and not on personal devices. This will only be allowed with the oversight of NELFT's IT Department.

NELFT requires a system that can securely store individual lots of keys and individual alarm fobs which will be easily accessible to assigned employees through a pin number and or a biometric detection.

The System will need to meet as a minimum the following criteria:

- Provide the status of asset (location/who has them time date of removing and replacing)
- Hold assets securely
- Provide a fully auditable record of assets that is accessible to the custodian of the system
- Ability to run audits
- Simple to use from both user and administrator perspective
- Intuitive software and meet Trust IT requirements
- Remotely accessible on the Trust network with security access levels
- Quick access to assigned keys
- Reliability of system both mechanically and electronically
- Require minimum maintenance (easy accessibility should power shut down)
- Programmable so that contractors or bank staff first time attending site can have access to an asset with biometrics of user taken for future use.

NELFT are considering approximately 16 secure key management cabinets to be delivered and installed on site, the sites can be found in the table below, please note within the site the location may vary:
