**CONTRACT FOR: Access to Primary Care in the Democratic Republic of Congo**

**CONTRACT NUMBER: PO 6096**

With reference to the contractual letter dated 5 October 2012 (as most recently amended by the letter dated 3 June 2013) whereby your firm was engaged to undertake the services as stipulated in the Terms of Reference, I confirm that the UK Government wishes to make the following further amendments to the letter of 5 October 2012:

**Contract Section 1 – Form of Agreement**

Delete Paragraph 4 and replace with the following:

“Payments under this contract shall not, in any circumstances, exceed £185,699,846 exclusive of any government tax, if applicable (“the financial limit”).

**Contract Section 2 – General Conditions**

Delete and replace with the attached updated standard DFID terms and conditions.

**Contract Section 3 – Terms of Reference**

Delete and replace with the attached updated terms of reference (dated March 2016).

**Contract Section 5 – Schedule of Prices (Cover Sheet)**

Delete Total Management Costs of “£12,260,620.65” and insert “£12,419,111”

Delete Total Project Delivery cost of “£170,639,225.52” and insert “£173,280,735”


Delete “£182,899,846.18” at “Sub Total”, “Total” and “The amount to be paid for the completion of the services is fixed at” and insert “£185,699,846”.

**Contract Section 5 - Proformas**

Delete the current proformas 1 to 5 and replace with the attached updated proformas 1 to 4 (dated March 2016).

2. These amendments relate to additional funds of £2.8m to cover three additional work streams: implementation of a system to better manage human resources, implementation of a health information management system and technical assistance and capacity building on public financial management.

3. Please confirm in writing by signing and returning one copy of this letter, within **15 working days** of the date of signature on behalf of DFID that you accept the amendment[s] set out herein.



4. Please note the provision in the contractual letter that the financial limit of the UK Government's liability to the Supplier under this engagement shall not exceed the sum specified unless the amount of any such excess has been agreed by the Department for International Development in writing before the Supplier takes any action which might result in the financial limit being exceeded.
