The inclusion of an invitation to tender submission of proposals, if agreed, may provide an opportunity to assess the level of understanding of the Council's requirements and design expertise of the tenderers. It includes a period for modification of the package on offer, before the formal process of inviting tenders, based on final proposals from each tenderer, takes place.

The Programmes aims at a 1st September start date from a 1st August award. It is predicated on a final Council decision being taken on 17th July, prior to the Council's summer recess. It takes account of the additional Coronation Bank Holiday in May. Subject to the above, these dates can be subject to changes at this stage to allow for resource availability within the Council.
