### **CONTRACT AWARD LETTER**

#### **CONTRACT FOR KEY GROUPS TRAINING - Lot 3; Modern Slavery**

1. The documents listed below form a binding contract (the “Contract”) between Hestia Housing and Support with offices Maya House, 134-138 Borough High Street, London, SE1 1LB (the “Contractor”) and the Secretary of State for the Ministry of Housing, Communities and Local Government (“MHCLG”):

2. In the event of conflict between any of the documents forming the Contract, the conflict shall be resolved by giving precedence to the documents in the order set out above.
3. In consideration of the full and proper performance by the Contractor of this Contract and subject to the other terms of this Contract, MHCLG shall pay the prices, rates and expenses specified in the Price Schedule (Appendix E).

#### **Contract Term**

4. Subject to any termination provisions within the Contract, the initial term of the Contract shall commence on 17 June 2019 (the “Effective Date”) and shall terminate on 31 March 2020. *MHCLG reserves the right to extend the term of the Contract by up to 12 months by giving the Contractor not less than two weeks written notice. MHCLG cannot guarantee any extension.*

#### **Prices and Invoicing**

5. The *firm price* for the initial term of the Contract is £49,047 (exclusive of VAT).
6. All invoices are to be submitted to: **REDACTED**.
7. Invoices must quote MHCLG’s contract number and purchase order number (to be confirmed) and an appropriate description. Failure to do so may result in a delay in payment for which MHCLG cannot be held responsible.



8. Invoices must also quote MHCLG’s vendor number. If the Contractor has not received a vendor number, the Contractor should complete a SAP7B form (available on request) and send it to MHCLG’s Commercial Representative.
