SOCIAL VALUE COMMITMENT

The Supplier agrees, in providing the Deliverables and performing its obligations under the Call-Off Contract, it will comply with the following social value commitments as were provided for in its Tender:

Reliance High Tech are committed to reducing carbon emissions, we have actions on how to achieve environmental objections, objectives, and planning to achieve them, and plans on how and when it will be done. Results are evaluated annually, in accordance with BS EN ISO 14001:2015 clause 9.1.1. We have several objectives for the period 2020-2024 along with our target aim, plans to achieve this and how we will measure it.

Objective number 1 is to capture CO2 emissions from all company vehicles and reduce these by 10% to meet government standards. This will be done and measured over a 5-year period. (2020-2024) To do this, we will gather vehicle type and travel distances over the month, and report on diesel and unleaded fuel in KgCo2 and KgCo2e measurement and then provide accurate carbon dioxide emission footprint for Reliance High-Tech from leased, personal and contractor vehicles. The aim is to achieve a reduction in quantitative value. Our environmental advisor acts on this data and is held accountable to our CEO.

Another objective is to account for Water resource use with a view of reduction by change to more efficient systems. Our target is to reduce the water usage figure once captured by 5% across the organisations over a 5-year cycle 2020-2024.

To do this, Reliance will capture water used in cubic meters for Reliance High-Tech over a 5 year cycle and aim to reduce consumption of natural resources water. These measurements form part of the greening government commitments which focus on key outcomes for reducing greenhouse gas emissions, waste and water consumption. The greening government commitments are the government's commitments for delivering sustainable operations and procurement. Water use - This could be metered mains supply or water extracted on site through boreholes or water courses. The aim to reduce overall usage by 5%.

Another objective is minimise power usage of equipment across office estate.
