Appendix 2 - Award Criteria Guidance

The Award Criteria will be evaluated as follows:

Technical Criteria

The technical criteria will be evaluated as stated in Annex 2 – Award Criteria.

Commercial Criteria

The Commercial criteria will be evaluated as follows:-

- The lowest priced compliant tender will receive a score of 4.
- Prices within 5% of the lowest priced compliant tender will receive a score of 3.
- Prices within 10% of the lowest priced compliant tender will receive a score of 2.
- Prices within 15% of the lowest priced compliant tender will receive a score of 1.
- Prices that are over 15% of the lowest priced compliant tender will receive a score of 0.

NTS reserves the right to disqualify any tenderer whose price exceeds 100% of the lowest price compliant tender.

Excepting those items identified under the Agreement as "to be supplied by the Contracting Authority", the Tenderer shall include in its Tender and shall bear under the Agreement all costs required to fulfil the obligations of the Procurement.

The following is a non-exclusive list of those items which the Tenderer is expected to bear the cost of and consequently be reflected within the tendered price:

Travel disbursements.

All applicable taxes of whatever character and description, with the exception of value added tax which will be added as appropriate to the charges included in the Tender.

All necessary plant and equipment necessary to deliver the Procurement.

Your price submission in this tender will form the basis for future pricing.
