Good morning Jackie,

I hope you are keeping well?

I've been contacted by Corona Energy in regard to the Mains Gas contract. It appears that the document title for the bespoke terms and conditions has not pulled through from Adobe Sign and is not clearly referenced; therefore, we need to make sure that the contract explicitly refers to the correct additional document to avoid any ambiguity.

We have agreed with Corona Energy that changes are to be made via manuscript amendments, whereby the changes are made on the current contract (already signed by yourself for SYP) then dated and initialled. This I believe is acceptable at this stage of contracting due to the amendments not being material changes but purely for the purposes of clarity.

The amendments specifically are:

*In relation to the Mains Gas Contract between the Police and Crime Commissioner for South Yorkshire Police and Corona Energy (SYP contract ref 2204-2020, Corona Energy Contract Reference 40675043)*

1. Deletion of the wording "Special Conditions" at the top of page 1 of the Bespoke Terms and Conditions document.
2. Insertion of the wording "Mains Gas Supply – Bespoke Terms v1" at the top of page 1 of the Bespoke Terms and Conditions document.
3. Deletion of the wording "Bespoke Conditions 2020 v6" from the footer of the Bespoke Terms and Conditions document.

If you are comfortable with the above proposal, please could I request confirmation of authorisation to proceed with these amendments via email from yourself as the original contract signatory, as I will need to forward that authorisation email to Corona Energy to evidence authorisation / acceptance.
