	Institute of Workplace & Facilities Management (IWFM) Training
1.2	Summary
	Provision of IWFM training to nominated staff across the Estates & Corporate HS&EP Group.
1.3	Background
	IWFM training consists of blended learning consisting of face to face training, followed by vocational learning modules which need to be completed over a 2 year period.
1.4	Requirement
	The DSTL requirement is for all nominated staff to have completed IWFM training at a level commensurate to their job role. This is to enable staff members to perform and realise their best potential and to enable supported learning. Also to enable the organisation build team capability, improve confidence and enhanced credibility to deliver operational and customer requirements.

	<p>The learning provider must be IWFM accredited with the ability to provide blended learning, including face to face on site as required.</p> <p>The learning provider must be able to provide mentoring throughout the delegates learning journey.</p> <p>Initial provision is for IWFM L3 & L4 Award however there may be a future requirement to provide a range of training as per the IWFM Qualifications Framework.</p>
