DEFINITION OF SCOPE OF SERVICE FOR PRE-CONSTRUCTION STAGE

The Employer requires that the Contractor provides to the Employer during the Pre-Construction Stage those matters identified in the Framework Agreement Process Map, the Contractor's tender stage proposals, the Method of Operation and additional items in accordance with the Agreed Scope which is attached as a schedule to this Project Order.

The Employer shall pay for such costs properly and reasonably incurred by the Contractor during the Pre- Construction Stage provided that they have been incurred in accordance with the Agreed Scope and the terms of this Project Order details of which (including costs) are set out in Part C of this Project Order. The Employer shall pay such costs at completion of work stage activities identified within the Framework Commercial Model or when agreed by the Employer on a monthly basis (choice to be indicated in section C), in all cases within 30 days of receipt of a valid invoice by the Contractor.



EMPLOYER OBLIGATIONS AND ACTIONS

The Employer accepts that the Contractor will need certain assistance from the Employer to fulfil its obligations in Part A and the Employer shall use its reasonable endeavours to:

- Confirm the detail of the brief including the insurance requirements
- Confirm the Delivery Agreement to be used together with the options and discretionary amendments as Clause 8.6 of the Framework Agreement
- Act as a designer (where applicable)
- Appoint a Principal Designer*
- Employ a Project Manager/Quantity Surveyor to ensure that the processes are being carried out in accordance with the Framework Agreement
- Bring the Employer, design team and Contractor together and ensure that the Employer and end user are fully engaged in the process
- Continue to monitor performance and design quality indicators
- *Where the Contractor is not required by the Employer to undertake the **Principal Designer** role the Principal Designer is:

If required, the Employer may instruct the Contractor to prepare or place a subcontract package for:

DESIGN SERVICES

The Employer requires the Contractor to undertake professional design services during the pre-construction stage.



If the Employer requires the Contractor to undertake professional design services during the Pre-Construction Stage, as stated above, a Pre-Construction Activities Delivery Agreement (Professional Services Contract) or Pre-Construction Activities Short Delivery Agreement (Professional Services Short Contract) must be executed for these services. Such a delivery agreement is not required where design is being commissioned by the Employer via third parties. Similarly, such a delivery agreement is not required if the Contractor is engaged for any professional design services to be undertaken only during the construction stage of the project (these services are to be included within the construction Delivery Agreement).
