With reference to the contract dated 8 august 2018, as most recently amended by the letter dated 29 May 2020, both Parties have in principle agreed to the following variations to the Contract:

Calldown Contract, Paragraph 1, Commencement and Duration of the Services

Delete: "The Supplier shall start the Services no later than 08 August 2018 ("the Start Date") and the Services shall be completed by 31 May 2021 ("the End Date") unless the Call-down Contract is terminated earlier in accordance with the Terms and Conditions of the Framework Agreement".

Insert: "The Supplier shall start the Services no later than 08 August 2018 ("the Start Date") and the Services shall be completed by 30 April 2022 ("the End Date") unless the Call-down Contract is terminated earlier in accordance with the Terms and Conditions of the Framework Agreement".

Calldown Contract, Paragraph 3, Financial Limit

Delete: "Payments under this Call-down Contract shall not, exceed £1,247,740 ("the Financial Limit") and is exclusive of any government tax, if applicable as detailed in Annex B. There is a potential, additional sum of £249,548 for Government Tax (to be paid on actuals)".

Insert: "Payments under this Call-down Contract shall not, exceed £1,579,852 ("the Financial Limit") and is exclusive of any government tax, if applicable as detailed in Annex B. There is a potential, additional sum of £315,971 for Government Tax (to be paid on actuals)".
