- (a) a systematic description of the envisaged Processing and the purpose of the Processing;
- (b) an assessment of the necessity and proportionality of the Processing in relation to the Deliverables:

- (d) the measures envisaged to address the risks, including safeguards, security measures and mechanisms to ensure the protection of Personal Data.
- 6. The Processor shall, in relation to any Personal Data Processed in connection with its obligations under the Contract:
- (a) Process that Personal Data only in accordance with Annex 1 (*Processing Personal Data*), unless the Processor is required to do otherwise by Law. If it is so required the Processor shall notify the Controller before Processing the Personal Data unless prohibited by Law;

 - (ii) it takes all reasonable steps to ensure the reliability and integrity of any Processor Personnel who have access to the Personal Data and ensure that they:
 - (A) are aware of and comply with the Processor's duties under this Joint Schedule 11, Clauses 14 (*Data protection*), 15 (*What you must keep confidential*) and 16 (*When you can share information*);
 - (B) are subject to appropriate confidentiality undertakings with the Processor or any Subprocessor;
 - (C) are informed of the confidential nature of the Personal Data and do not publish, disclose or divulge any of the Personal Data to any third party unless directed in writing to do so by the Controller or as otherwise permitted by the Contract; and
 - (D) have undergone adequate training in the use, care, protection and handling of Personal Data;
- (d) not transfer Personal Data outside of the UK or EU unless the prior written consent of the Controller has been obtained and the following conditions are fulfilled:
 - (i) the Controller or the Processor has provided appropriate safeguards in relation to the transfer (whether in accordance with

- (ii) the Data Subject has enforceable rights and effective legal remedies:

- (iv) the Processor complies with any reasonable instructions notified to it in advance by the Controller with respect to the Processing of the Personal Data; and
- (e) at the written direction of the Controller, delete or return Personal Data (and any copies of it) to the Controller on termination of the Contract unless the Processor is required by Law to retain the Personal Data.
- 7. Subject to paragraph 7 of this Joint Schedule 11, the Processor shall notify the Controller immediately if in relation to it Processing Personal Data under or in connection with the Contract it:
- (a) receives a Data Subject Access Request (or purported Data Subject Access Request);
- (b) receives a request to rectify, block or erase any Personal Data;
- (c) receives any other request, complaint or communication relating to either Party's obligations under the Data Protection Legislation;
- (d) receives any communication from the Information Commissioner or any other regulatory authority in connection with Personal Data Processed under the Contract;
- receives a request from any third Party for disclosure of Personal Data where compliance with such request is required or purported to be required by Law; or
- (f) becomes aware of a Personal Data Breach.
- 8. The Processor's obligation to notify under paragraph 6 of this Joint Schedule 11 shall include the provision of further information to the Controller, as details become available.
- Taking into account the nature of the Processing, the Processor shall provide the Controller with assistance in relation to either Party's obligations under Data Protection Legislation and any complaint, communication or request made under paragraph 6 of this Joint Schedule 11 (and insofar as possible within the timescales reasonably required by the Controller) including by immediately providing:
- (a) the Controller with full details and copies of the complaint, communication or request;

- (b) such assistance as is reasonably requested by the Controller to enable it to comply with a Data Subject Access Request within the relevant timescales set out in the Data Protection Legislation;
- (c) the Controller, at its request, with any Personal Data it holds in relation to a Data Subject;
- (d) assistance as requested by the Controller following any Personal Data Breach; and/or
- (e) assistance as requested by the Controller with respect to any request from the Information Commissioner's Office, or any consultation by the Controller with the Information Commissioner's Office.
- 10. The Processor shall maintain complete and accurate records and information to demonstrate its compliance with this Joint Schedule 11. This requirement does not apply where the Processor employs fewer than 250 staff, unless:

- 11. The Processor shall allow for audits of its Data Processing activity by the Controller or the Controller's designated auditor.
- 12. The Parties shall designate a Data Protection Officer if required by the Data Protection Legislation.
- 13. Before allowing any Subprocessor to Process any Personal Data related to the Contract, the Processor must:
- (a) notify the Controller in writing of the intended Subprocessor and Processing;
- (b) obtain the written consent of the Controller;
- (c) enter into a written agreement with the Subprocessor which give effect to the terms set out in this Joint Schedule 11 such that they apply to the Subprocessor; and
- (d) provide the Controller with such information regarding the Subprocessor as the Controller may reasonably require.
- 14. The Processor shall remain fully liable for all acts or omissions of any of its Subprocessors.

The Relevant Authority may, at any time on not less than thirty (30) Working Days' notice, revise this Joint Schedule 11 by replacing it with any applicable controller to processor standard clauses or similar terms forming part of an applicable certification scheme (which shall apply when incorporated by attachment to the Contract).

16. The Parties agree to take account of any guidance issued by the Information Commissioner's Office. The Relevant Authority may on not less than thirty (30) Working Days' notice to the Supplier amend the Contract to ensure that it complies with any guidance issued by the Information Commissioner's Office.

Where the Parties are Joint Controllers of Personal Data

Proposed approach for evaluation of Safety Tech Challenge Fund 2

1. Background and Rationale for Requirement

- 1.1. The second Safety Tech Challenge Fund (STCF2) has been focused on tackling the sharing of links to child sexual abuse material (CSAM) online.
- 1.2. STCF2 is supporting innovation and collaboration to address this problem by distributing over [REDACTED] in grants to three selected projects that are specifically looking at detecting and disrupting the practice of link sharing. The projects are running from June 2023 until 29 February 2024, with DSIT and its partners the Home Office, GCHQ and the ICO offering support and guidance to fund recipients.
- 1.3. The three projects are as follows:
 - 1.3.1.Centre for Factories of the Future aims to enhance online safety by addressing the modification and distribution of CSAM links through the utilisation of advanced machine learning-based models.
 - 1.3.2.Vistalworks is building on its previous work detecting online illicit trade and will focus on tackling the sharing of CSAM links on the open web where links are traded, offenders are sign-posted elsewhere, and potential abuse targets are identified.
 - 1.3.3. CameraForensics is developing a system that can automatically analyse the context, routing and destination content of shared links to identify features that are potential indicators of CSAM sharing.
- 1.4. Evaluation of the projects and programme provides an opportunity to identify and share project specific and cross-cutting lessons around how to tackle link sharing of CSAM. Lessons learned from STCF2 will be harnessed to influence future rounds of the challenge fund or similar initiatives by providing transferable learnings.
- 1.5. Innovate UK, as the delivery partner for STCF2, is contracted to provide a close-out review of each of the three funded projects as part of its standard project monitoring process. These will take the form of bilateral meetings conducted between Innovate UK's sub-contracted Project Monitoring Officer and each project. They will cover progress made against the project milestones that were set out by the projects upon the submission of their initial bids.
- 1.6. Innovate UK's close out review does not, and was not designed to, meet the requirements set out above for a full evaluation of STCF2 and its projects. We are consequently commissioning a separate-but-complementary external evaluation in parallel to deliver additional insight and information.

2. The Requirement

2.1. We are seeking to commission a small-scale evaluation to assess the impact of the projects, the wider lessons learned, the value for money of the intervention and the effectiveness of STCF2's processes. This would draw from independent technical evaluations of the project's end products, bilateral interviews with each of the projects and cross-government stakeholders involved in the challenge fund. This will add to the assessment of the projects themselves by contextualising the outcomes of the projects, showing how the projects' tools were developed and providing a wider evaluation of the effectiveness of the challenge fund

- 2.2. It is important that the evaluation contractor has the knowledge and expertise to be able to carry out the independent technical analysis of these projects and the tools they have produced. This analysis will providing a technical overview of how the output of the projects work and their efficacy in tackling link sharing of CSAM.
- 2.3. This evaluation will seek to give a fair and balanced assessment of the projects themselves and recognise the limitations of the challenge fund timescale.
- 2.4. The evaluation will focus on responding to two key areas related to STCF2 set out below:
- 2.5. A reflection on the key issues raised through the projects that focuses on the potential solutions and lessons brought about by the projects' outputs. This would include what the projects have practically demonstrated through their time in the programme, any hurdles, issues or concerns that have been raised, and advice on how lessons learned might be taken forward and applied in the field.
- 2.6. An assessment of the effectiveness of STCF2's processes and its value for money. This would consider the views of the interviewed cross-government stakeholders involved in the challenge fund and documentation provided to the contractor. This will culminate in an assessment on the efficacy of the challenge fund programme and how it can be developed in future rounds. This will be set against the original aims of STCF2.
- 2.7. We anticipate that a single external contractor will carry out this work.

3. Expected Outputs

- 3.1. The output from the evaluation process will be a short document (~15 pages) that outlines the collated findings, with reference to both Innovate UK's formal monitoring processes and the external contractor's independently conducted work. HMG will look to publish this report externally, following relevant revisions and approvals. We would expect to initially receive a draft of the report to review and comment on before agreeing on a finalised version.
- 3.2. The findings will be as detailed as possible whilst remaining succinct and focused on the criteria set out above, including key issues identified through projects, effectiveness of STCF2 and value for money.
- 3.3. We aim for the final evaluation report to be completed on or before 17th April 2024.

4. Approach

- 4.1. In producing the outputs, the contractor will maximise their understanding of the Safety Tech Challenge Fund and the issue of link sharing of CSAM.
- 4.2. The contractor will be able to attend the Innovate UK close out reviews, which will be arranged for the middle of March and will be provided access to the findings from these sessions to inform their own work on STCF2 and the projects.
- 4.3. The contractor will arrange and undertake interviews with a representative from each of the government stakeholders involved in running STCF2 and each of the projects to enable indepth exploration of the intervention with participants and to allow a technical analysis of the projects' tools.
- 4.4. Using the information from the technical analysis, the interviews with the projects and stakeholders and the close out review, the contractor will lay out an evaluation of the projects' progress and output in the context of tackling CSAM link sharing. This would draw out issues and solutions that were raised during the challenge fund and what lessons this provides for tackling CSAM link sharing.

- 4.5. The contractor will be provided with documentation that provides details on the cost and processes of STCF2 that were submitted during the project set-up and throughout its running to provide an insight into the challenge fund's value for money.
- 4.6. The successful bidder will follow the evaluation guidance, as set out in the HM Treasury Green Book.

5. Service Levels & Performance

- 5.1 The successful bidder must have one lead project manager responsible for all components of the project who will act as the primary contact point. An evaluation analyst will act as lead project manager for DSIT and will provide advice and guidance on any questions arising from the Supplier during the project.
- 5.2 The final written reports will be signed off at Deputy Director level within DSIT. The project will only be considered complete when this sign off has been achieved and DSIT are content that all outputs of the project listed in Outputs/Milestones have been delivered to a satisfactory standard.
- 5.3 Should any members of the initial proposed team be changed then a replacement member must have comparable experience and expertise and should also be approved by DSIT's contract manager.

6. Reporting

- 6.1 Meet initially with the DSIT lead project manager and Project Steering Group for a kick off meeting.
- 6.2 Hold weekly update meetings with the lead project manager and relevant stakeholders. This should include a highlight report providing an update on project status, key milestones and issues, facilitating discussion of the top risks facing the project and mitigations for these.
- 6.3 Ensure all outputs are delivered to schedule with appropriate time to allow DSIT to comment. The Supplier is expected to present findings from the draft and final reports to key stakeholders.
