Section 4 – Specification and about this procurement

Executive Summary

UK Shared Business Services Ltd (UK SBS) on behalf of The Department for Business, Energy and Industrial Strategy (BEIS), wishes to establish a Framework for the provision of **Office for Product Safety & Standards (OPSS)** Strategic Research Programme as per the specification below.

UK SBS is managing this procurement process in accordance with the Public Contracts Regulations 2015 (as may be amended from time to time) (the “Regulations”).

This is a Services Framework being procured under the Open Procedure regulations.

This tender seeks to find a supplier to provide ad-hoc consumer research on a call-off basis as required by OPSS. The contract is for four years (from award until Friday 3rd October 2025, providing the budget cap has not been reached.

It is intended that there will be 3 suppliers awarded to this Framework. These awarded suppliers will be ranked 1st 2nd and 3rd based off the scores awarded from the completion of this procurement. For clarity the supplier ranked 1st in this procurement process will be ranked 1st on the framework, the supplier ranked 2nd in this procurement process will be ranked 2nd on the framework and the supplier ranked 3rd in this procurement process will be ranked 3rd on the framework.

Quotation Process:

As and when requirements are identified, Call-Off Contracts will be awarded based on the Framework ranking, with Supplier 1 being offered first, then moving to Supplier 2, and finally supplier 3. Movement to the next ranked supplier is on the basis that the previous supplier cannot complete the services or meet the requirements or does not submit their quotation form within 5 working days.

As and when a requirement is identified, a completed Appendix B quotation form will be issued to the supplier ranked 1. The supplier ranked 1 will have a maximum of 5 working days to submit their quotation. If the supplier ranked 1 cannot complete the services or meet the requirements or does not submit their quotation form within 5 working days, then a quotation form will be issued to the supplier ranked 2. The supplier ranked 2 will have a maximum of 5 working days to submit their quotation. If the supplier ranked 2 cannot complete the services or meet the requirements or does not submit their quotation form within 5 working days, then a quotation form will be issued to the supplier ranked 3. The supplier ranked 3 will have a maximum of 5 working days to submit their quotation.

Call Off Award is also subject to satisfactory mandatory pass/fail requirements outlined in **Appendix B – Call-Off Quote Template**. Please note. there is no opportunity to negotiate on any terms post contract award.

1. Background

This contract is being commissioned as part of the **Office for Product Safety & Standards (OPSS)** Strategic Research Programme. OPSS was established by BEIS in

January 2018 in order to enhance protections for consumers and drive forward increased productivity, growth and business confidence. The OPSS strategic research programme provides high quality, strategic, science-based research to strengthen the evidence base for OPSS policy development, delivery and enforcement.

As an evidence led organisation, OPSS places a great importance on research which gathers consumer insight. This insight plays a key role in the development of policies, guidance and campaigns.

In recent months it has been necessary to seek consumer insight on a number of issues such as the recall of large white goods and purchase and use of certain consumer products in relation to Covid-19. It is expected that further issues will arise where consumer insight can help shape the OPSS response. In addition to this OPSS has recently taken on regulation of construction products, presenting a new research area where consumer insight could add value.

This tender seeks to find a supplier to provide ad-hoc consumer research on a call-off basis as required by OPSS. The contract is for four years until September 2025, providing the budget cap has not been reached.

Whilst the specific research requirements are currently unknown, there will be a sole focus on consumers. It is expected any ad hoc research conducted under the contract may involve, but is not limited to, online surveys, depth interviews and/or focus groups/online collaborative forums. The outputs of any research will be used to inform the evidence base for a specific emerging issue, helping the decision-making around policy and communications.

2. Aims and Objectives of the Project

The aim of this contract is enable consumer insight and evidence to feed into emerging consumer issues relevant to OPSS in a timely manner.

The contract will be used as a resource for small discrete pieces of consumer research. Whilst the research requirements are currently unknown, example projects from the last year that could have been carried out using a call-off contract include:

- *Covid-19 consumer survey.* A three wave survey in which each wave approximately surveyed 1,250 consumers.
- *Survey on awareness and action taken in response to product recalls of large white goods.* A contractor led online survey of over 5,000 respondents, followed by an OPSS issued survey to gain more information about fire incidents related to white goods from those who reported to have experienced them.
- *Fire safety furniture labels.* A research project comprising of eight focus groups which sought consumer views on information and design of furniture fire safety labels. The findings were needed to inform changes to regulations.

3. Suggested Methodology

Due to the nature of this contract the specific policy areas and research needs are currently unknown, though all research will be focussed on consumer insights. Based on recent projects, research areas could include, but are not limited to, consumer insights on Covid-19 related products, product registration and recalls, inclusive design and construction products . It can be expected that there will be a requirement for multiple, small scale research projects that arise on an ad-hoc basis in response to emerging policy

issues. We expect the methodologies that may be required include, but are not limited to:

- Online surveys
- Depth interviews
- Focus groups/online collaborative forum

In response to new research requirements, OPSS will welcome methodology suggestions from the contractor. It is expected each project under the contract will have a proposal, agreed by OPSS, research materials, data analysis and in some circumstances, a write up of the research.

In order to provide a fair and transparent process for awarding Supplier(s) to this Framework we will be asking for potential Suppliers to provide 'approach' response to the following (note work is not guaranteed under this framework).

1. How you would go about supporting each of the four broad points: i) How would you work with us to understand the research needs? ii) How would you approach the design of research to ensure it met research needs? iii) How would you ensure the research ran effectively? iv) How would you ensure the quality of the final product?
 2. How you would approach the following three hypothetical projects. For each project, we require a summary outlining: i) proposed methodological approach; ii) sample source and recruitment; iii) research design; iv) approach to analysis of findings and quality assurance processes; v) cost estimates; vi) data protection processes and assurances
 3. Staff to deliver: demonstrate knowledge of the skills and expertise that are essential to the successful delivery of the project
 4. Understanding the project environment: demonstrate understanding of the project environment
- 1 – OPSS analysts want to expand on current findings from a recent product recall and registration evidence review that indicated consumers tend to not engage with instruction manuals. To gather data on consumer habits surrounding instruction manuals, the suggested methodology is an online survey, comprising 10 closed questions and 2 open questions, along with demographic questions, issued to 2000 consumers. The survey questions will be initially drafted by OPSS. The sample should be nationally representative. It is expected that the survey will be cognitively tested before being issued to the sample. Specific questions which the team are interested in including how often consumers are reading product instructions before use, and whether the type of product affects the likelihood of engagement. A report will not be required but an anonymised dataset will need to be shared with OPSS for a report to be produced internally. The project should not last more than 4 weeks. The estimated cost for the project is £5,000-£10,000.
 - 2 – OPSS is currently involved in a number of diversity and inclusion projects, with a recent focus on how product safety issues may change in an ageing society. As part of a new project, OPSS is interested to learn more about products which have been adapted to meet the needs of consumers with physical disabilities. To allow OPSS to gain detailed information on consumer experiences of purchasing and using such products, the suggested methodology is to use face-to-face depth interviews of 8-10 consumers, representing different physical disabilities. The sample should also be demographically diverse. OPSS will provide broad themes for the interviews, but it is expected the supplier will draft the topic guide. Interviews should last for around 1 hour each. Interview summaries and a report will be

required. The project should not last more than 2 months, and the estimated cost is £15,000-£22,000.

- 3 –OPSS is considering launching a consumer campaign highlighting the precautions consumers should consider when purchasing second-hand goods. For this, OPSS is interested in exploring current consumer thinking when it comes to the safety of second-hand products. The suggested methodology to explore this, is to use 6 face-to-face focus groups of 6-8 participants. OPSS will provide broad themes for the focus groups, but it is expected the supplier will draft the topic guide. The participants should be demographically diverse, with each focus group grouping participants of similar ages. Each session should last for 1 hour. There will be a specific focus on whether where the product is purchased from affects safety opinions (i.e. from social media vs. online auctions). Summaries of each group and a report will be required. The project should not last more than 3 months, and the estimated cost is £20,000-£40,000.

Due to the range of research projects which could arise during this contract, tenderers will be expected to be able to apply expertise to consumer insight gathering, with skills and expertise applicable to a wide variety of social research techniques. An understanding of product safety and standards is also desirable.

The tenderer should be willing and able to work flexibly, begin new projects at short notice, and work to tight timescales where required.

OPSS is unable to guarantee the volume and value of allocated projects as part of this contract. Individual projects will be commissioned on fixed costs and not estimated rates or day rates as per usual government procurements. OPSS reserve the right to commission consumer insight research outside of this contract.

The contract will have an overall maximum value cap of £245,000 across its duration, with individual projects being capped at £60,000. However, as noted above, there is no commitment from OPSS that it will spend this or any amount of money throughout the contract time.

4. Deliverables

For each project OPSS will provide a project outline with the aims and objectives, and in some instances a suggested methodology. The supplier should then produce a short proposal for the project, including details on timelines, methodology, recruitment and cost, which will require sign off from OPSS before the project can begin.

Outputs produced through individual Call-Off Contracts will vary on a project by project basis. It is anticipated that all findings will be published as per our commitment to transparency, but the supplier will not always be required to produce the written report. It will be specified in each individual project outline stage whether the supplier will be expected to produce the written report.

When the supplier is required to deliver a report, it should be produced to a quality assured, publishable standard and adhere to accessibility guidelines. Whilst the nature of each project will inform the reporting process, where traditional reports are appropriate, they are expected to include an executive summary, key findings and detailed analysis including charts and tables, if applicable.

It is also expected that each quantitative project carried out as part of this contract will

require an anonymised dataset to be provided to OPSS.

OPSS may also wish to request quality assurance logs. The supplier is required to be able to provide this at request.

Terms and Conditions

Bidders are to note that any requested modifications to the Contracting Authority Terms and Conditions on the grounds of statutory and legal matters only, shall be raised as a formal clarification during the permitted clarification period.

Section 5 – Evaluation model

5.1. Introduction

- 5.1.1. The evaluation process will be conducted to ensure that Bids are evaluated fairly to ascertain the bidders who can demonstrate the required skills qualities, technical ability and capacity, commercial stability and experience to ensure successful performance of the Contract.

Award Evaluation of criteria

Non-Price elements

Each question will be evaluated on a score from 0 to 100, which shall be subjected to a multiplier to reflect the percentage of the evaluation criteria allocated to that question.

Where an evaluation criterion is worth 20% then the 0-100 score achieved will be multiplied by 20%.

Example if a Bidder scores 60 from the available 100 points this will equate to 12% by using the following calculation:

$$\text{Score} = \{\text{weighting percentage}\} \times \{\text{bidder's score}\} = 20\% \times 60 = 12$$

The same logic will be applied to groups of questions which equate to a single evaluation criterion.

The 0-100 score shall be based on (unless otherwise stated within the question):

0	The Question is not answered, or the response is completely unacceptable.
10	Extremely poor response – they have completely missed the point of the question.
20	Very poor response and not wholly acceptable. Requires major revision to the response to make it acceptable. Only partially answers the requirement, with major deficiencies and little relevant detail proposed.
40	Poor response only partially satisfying the question requirements with deficiencies apparent. Some useful evidence provided but response falls well short of expectations. Low probability of being a capable supplier.
60	Response is acceptable but remains basic and could have been expanded upon. Response is sufficient but does not inspire.
80	Good response which describes their capabilities in detail which provides high levels of assurance consistent with a quality provider. The response includes a full description of techniques and measurements currently employed.
100	Response is exceptional and clearly demonstrates they are capable of meeting the requirement. No significant weaknesses noted. The response is compelling in its description of techniques and measurements currently employed, providing full assurance consistent with a quality provider.

All questions will be scored based on the above mechanism. Please be aware that there may be multiple evaluators. If so, their individual scores will be averaged (mean) to determine your final score as follows:

Example

Evaluator 1 scored your bid as 60

Evaluator 2 scored your bid as 40

Evaluator 3 scored your bid as 80

Evaluator 4 scored your bid as 60

Your final score will $(60+40+80+60) \div 4 = 60$

Once the above evaluation process has been undertaken and the scores are apportioned by evaluator(s) this will then be subject to an independent commercial review and moderation meeting, if required by the commercial lead, any and all changes will be formally recorded relative to the regulatory obligations associated with this procurement, so as to ensure that the procurement has been undertaken in a robust and transparent way.

Price elements will be evaluated on the following criteria.

The lowest price for a response which meets the pass criteria shall score 100.

All other bids shall be scored on a pro rata basis in relation to the lowest price. The score is then subject to a multiplier to reflect the percentage value of the price criterion.

For example - Bid 1 £100,000 scores 100.

Bid 2 £120,000 differential of £20,000 or 20% remove 20% from price scores 80

Bid 3 £150,000 differential £50,000 remove 50% from price scores 50.

Bid 4 £175,000 differential £75,000 remove 75% from price scores 25.

Bid 5 £200,000 differential £100,000 remove 100% from price scores 0.

Bid 6 £300,000 differential £200,000 remove 100% from price scores 0.

Where the scoring criterion is worth 50% then the 0-100 score achieved will be multiplied by 50

In the example if a supplier scores 80 from the available 100 points this will equate to 40% by using the following calculation: Score/Total Points multiplied by 50 ($80/100 \times 50 = 40$)

The lowest score possible is 0 even if the price submitted is more than 100% greater than the lowest price.

This evaluation criteria will therefore not be subject to any averaging, as this is a mathematical scoring criteria, but will still be subject to a commercial review.

- 7.1.5. - 7.1.13. Bidders should read this document, Stage One: Overview Section. messages and the evaluation questionnaires carefully before completing the Response submission. Failure to comply with any of these instructions for completion and submission of the Submitted Response may result in the rejection of the Response. Bidders are advised therefore to acquaint themselves fully with the extent and nature of the services and contractual obligations. These instructions constitute the Conditions of Response. - 7.1.14. - 7.1.16. The Bidder shall not make contact with any other employee, agent or consultant of UK SBS or the Contracting Authority or any relevant OPB or Customer who are in any way connected with this procurement during the period of this procurement, unless instructed otherwise by the Contracting Authority.
- 7.1.17. The Contracting Authority shall not be committed to any course of action as a result of:

 - 7.3.1.3. Bidders shall not use any of the Information for any purpose other than for the purposes of submitting (or deciding whether to submit) a Response; and
 - 7.3.1.4. Bidders shall not undertake any publicity activity within any section of the media in relation to this procurement
- 7.3.2. Bidders may disclose, distribute or pass any of the Information to the Bidder's advisers, sub-contractors or to another person provided that either:

7.4. Freedom of information

7.8. Preparation of a Response

- 7.8.1. Bidders must obtain for themselves at their own responsibility and expense all information necessary for the preparation of Responses. Bidders are solely responsible for all costs, expenses and other liabilities arising in connection with the preparation and submission of their Response and all other stages of the selection and evaluation process.  - 7.9.9.2. Any request for a late Response to be considered must be emailed to the Buyer in [Section 3](#) in advance of 'the deadline' if a bidder believes their Response will be received late.
 - 7.9.9.3. The Contracting Authority reserves the right to accept or reject any late Response without justification to the affected Bidder and make no guarantee it will consider any request for a late Response to be considered.

- 7.11.2.1. makes any representation or warranty (express or implied) as to the accuracy, reasonableness or completeness of the RFP; or
 - 7.11.2.2. accepts any responsibility for the information contained in the RFP or for their fairness, accuracy or completeness of that information nor shall any of them be liable for any loss or damage (other than in respect of fraudulent misrepresentation) arising as a result of reliance on such information or any subsequent communication.
- 7.11.3.  - 7.12.1.3. enters into any agreement or arrangement with any other party that such other party shall refrain from submitting a Response; or
 - 7.12.1.4. enters into any agreement or arrangement with any other party as to the amount of any Response submitted; or
 - 7.12.1.5. offers or agrees to pay or give or does pay or give any sum or sums of money, inducement or valuable consideration directly or indirectly to

any party for doing or having done or causing or having caused to be done in relation to any other Response or proposed Response, any act or omission,
shall (without prejudice to any other civil remedies available to the Contracting Authority and without prejudice to any criminal liability which such conduct by a Bidder may attract) be disqualified.

7.13. No inducement or incentive

- 7.13.1. The RFP is issued on the basis that nothing contained in it shall constitute an inducement or incentive nor shall have in any other way persuaded a Bidder to submit a Response or enter into the Contract or any other contractual agreement.

7.14. Acceptance of the Contract

- 7.14.1. The Bidder in submitting the Response undertakes that in the event of the Response being accepted by the Contracting Authority and the Contracting Authority confirming in writing such acceptance to the Bidder, the Bidder will within 7 days of being called upon to do so by the Contracting Authority execute the Contract in the form set out in the Contract Terms or in such amended form as may subsequently be agreed.
- 7.14.2. The Contracting Authority shall be under no obligation to accept the lowest priced or any Response.

7.15. Queries relating to the Response

- 7.15.1. All requests for clarification about the requirements or the process of this procurement shall be made in through the e-sourcing tool unless where the e-sourcing tool is unavailable due to Delta eSourcing system maintenance or failure, in this instance all clarifications shall be by email to the contact defined in [Section 3](#).
- 7.15.2. The Contracting Authority will endeavour to answer all questions as quickly as possible but cannot guarantee a minimum response time.
- 7.15.3. In the event of a Bidder requiring assistance uploading a clarification to the e-sourcing portal they should use the contact details defined in [Section 3](#).
- 7.15.4. No further requests for clarifications will be accepted after 7 days prior to the date for submission of Responses.
- 7.15.5. In order to ensure equality of treatment of Bidders, the Contracting Authority intends to publish the questions and clarifications raised by Bidders together with the Contracting Authority's responses (but not the source of the questions) to all participants on a regular basis.
- 7.15.6. Bidders should indicate if a query is of a commercially sensitive nature – where disclosure of such query and the answer would or would be likely to prejudice its commercial interests. However, if the Contracting Authority at its sole discretion does not either; consider the query to be of a commercially confidential nature or one which all Bidders would potentially benefit from seeing both the query and the Contracting Authority's response, the Contracting Authority will:
- 7.15.6.1. invite the Bidder submitting the query to either declassify the query and allow the query along with the Contracting Authority's response to be circulated to all Bidders; or

- 7.15.6.2. request the Bidder, if it still considers the query to be of a commercially confidential nature, to withdraw the query prior to the end of the closing date and time for Bidder clarifications.
- 7.15.7. The Contracting Authority reserves the right not to respond to a request for clarification or to circulate such a request where it considers that the answer to that request would or would be likely to prejudice its commercial interests.

7.16. Amendments to Response Documents

- 7.16.1. At any time prior to the deadline for the receipt of Responses, the Contracting Authority may modify the RFP by amendment. Any such amendment will be numbered and dated and issued by the Contracting Authority to all prospective Bidders. In order to give prospective Bidders reasonable time in which to take the amendment into account in preparing their Responses, the Contracting Authority may, at its discretion, extend the time and/or date for receipt of Responses.

7.17. Modification and withdrawal

- 7.17.1. Bidders may modify their Response where allowable within the e-sourcing tool. No Response may be modified after the deadline for submission of Responses.
- 7.17.2. Bidders may withdraw their Response at any time prior the deadline for submission of Responses [or any other time prior to accepting the offer of a Contract]. The notice to withdraw the Response must be in writing and sent to the Contracting Authority by recorded delivery or equivalent service and delivered to the Head of Policy UK SBS at UK Shared Business Services Ltd, Procurement, Polaris House, North Star Avenue, Swindon, Wiltshire, SN2 1ET

7.18. Right to disqualify or reject

- 7.18.1. The Contracting Authority reserves the right to reject or disqualify a Bidder where
 - 7.18.1.1. the Bidder fails to comply fully with the requirements of this Request for Proposal or presents the response in a format contrary to the requirements of this document; and/or
 - 7.18.1.2. the Bidder is guilty of serious misrepresentation in relation to its Response; expression of interest; or the Response process; and/or
 - 7.18.1.3. there is a change in identity, control, financial standing or other factor impacting on the selection and/or evaluation process affecting the Bidder.

7.19. Right to cancel, clarify or vary the process

- 7.19.1. The Contracting Authority reserves the right to:
 - 7.19.1.1. cancel the evaluation process at any stage; and/or
 - 7.19.1.2. require the Bidder to clarify its Response in writing and/or provide additional information. (Failure to respond adequately may result in the Bidder not being selected),

7.20. Notification of award

- 7.20.1. The Contracting Authority will notify the successful Bidder of the Contract award in writing and will publish an Award Notice in Find a Tender in accordance with the Regulations within 30 days of the award of the contract.

7.20.2. As required by the Regulations all successful and unsuccessful Bidders will be provided with an email advising the outcome of the submission of their RFP response.

What makes a good bid – some simple do's 😊

DO:

Do comply with Procurement document instructions. Failure to do so may lead to disqualification.

Do provide the Bid on time, and in the required format. Remember that the date/time given for a response is the last date that it can be accepted; we are legally bound to disqualify late submissions. Responses received after the date indicated in the RFP shall not be considered by the Contracting Authority, unless the Bidder can justify that the reason for the delay, is solely attributable to the Contracting Authority

Do ensure you have read all the training materials to utilise e-sourcing tool prior to responding to this Bid. If you send your Bid by email or post it will be rejected.

Do use Microsoft Word, PowerPoint Excel 97-03 or compatible formats, or PDF unless agreed in writing by the Buyer. If you use another file format without our written permission, we may reject your Bid.

Do ensure you utilise the Delta eSourcing messaging system to raise any clarifications to our RFP. You should note that we will release the answer to the question to all Bidders and where we suspect the question contains confidential information, we may modify the content of the question to protect the anonymity of the Bidder or their proposed solution

Do answer the question, it is not enough simply to cross-reference to a 'policy', web page or another part of your Bid, the evaluation team have limited time to assess bids and if they can't find the answer, they can't score it.

Do consider who the Contracting Authority is and what they want – a generic answer does not necessarily meet every Contracting Authority's needs.

Do reference your documents correctly, specifically where supporting documentation is requested e.g. referencing the question/s they apply to.

Do provide clear, concise and ideally generic contact details; telephone numbers, e-mails and fax details.

Do complete all questions in the questionnaire or we may reject your Bid.

Do ensure that the Response and any documents accompanying it are in the English Language, the Contracting Authority reserve the right to disqualify any full or part responses that are not in English.

Do check and recheck your Bid before dispatch.

What makes a good bid – some simple do not's 😞

DO NOT

Do not cut and paste from a previous document and forget to change the previous details such as the previous buyer's name.

Do not attach 'glossy' brochures that have not been requested, they will not be read unless we have asked for them. Only send what has been requested and only send supplementary information if we have offered the opportunity so to do.

Do not share the Procurement documents, they may be confidential and should not be shared with anyone without the Buyers written permission.

Do not seek to influence the procurement process by requesting meetings or contacting UK SBS or the Contracting Authority to discuss your Bid. If your Bid requires clarification the Buyer will contact you. All information secured outside of formal Buyer communications shall have no Legal standing or worth and should not be relied upon.

Do not contact any UK SBS staff or the Contracting Authority staff without the Buyers written permission or we may reject your Bid.

Do not collude to fix or adjust the price or withdraw your Bid with another Party as we will reject your Bid.

Do not offer UK SBS or the Contracting Authority staff any inducement or we will reject your Bid.

Do not seek changes to the Bid after responses have been submitted and the deadline for Bids to be submitted has passed.

Do not cross reference answers to external websites or other parts of your Bid, the cross references and website links will not be considered.

Do not exceed word counts, the additional words will not be considered.

Do not make your Bid conditional on acceptance of your own Terms of Contract, as your Bid will be rejected.

Do not unless explicitly requested by the Contracting Authority either in the procurement documents or via a formal clarification from the Contracting Authority send your response by any way other than via e-sourcing tool. Responses received by any other method than requested will not be considered for the opportunity.

“Direct Award”	means the award of a Call Off Contract by application of the terms laid down in the Contract without re-opening competition
“Due Diligence Information”	means the background and supporting documents and information provided by the Contracting Authority for the purpose of better informing the Bidders responses to this Request for Proposal
"EIR"	mean the Environmental Information Regulations 2004 together with any guidance and/or codes of practice issued by the Information Commissioner or relevant Government department in relation to such regulations
