- The total contract price is £18,500 exclusive of Value Added Tax, £22,200 (including VAT).

On receipt of a signed copy, the Authority will arrange to add its signature and return a copy of the Agreement Letter for your file.

# Appendix A: Tender clarifications questions and response

The clarification questions (against the tender documentation) received by the Authority with responses it provided is summarised in the table below:

Ref	Question	Response
1	Is this part of the patient level data set all CHC system suppliers have to submit to NHS E or is this a separate piece of work?	This is a smaller separate piece of work, the Department of Health and Social Care (DHSC) is looking to improve its evidence base for policy development purposes and to do this are requesting a new data extraction from one system supplier which has CCG coverage of at least 60%. This project is expected to start in January 2022, whereas the NHS E project is much larger and set to go live later in 2022.
1	Would it not be easier to use the data set from all CHC system suppliers that we have had to develop and submit to NHS E?	This project is being run independently by the DHSC, given that this is not NHS E led or related to the national client level data set we are putting in place a new contract for a smaller project.
1	If it's something different are you proposing that the supplier, Like us are paid to sends this information to you directly rather than to NHS E?	This project is shorter and on a smaller scale compared to the CHC client level dataset run by NHS E; that data that is transferred to the DHSC will be used for policy development purposes and not the national level client level data set. The NHS E client level data is much larger, this project is requesting to extract only a small sub-set of data fields, a list is shown in the Service Description.
