- (1) THE ENVIRONMENT AGENCY ("EA") ("the Client"); and
- (2) Kier Integrated Services Ltd incorporated and registered in England and Wales with company number 00873179 whose registered office is at 2nd Floor, Optimum House, Clippers Quay, Salford, M50 3XP ("the Contractor").

BACKGROUND

- (A) The Client and the Contractor are party to a contract dated 03 July 2023 ("the Contract known as the Wareham Coastal Change The Moors at Arne Contract") for the creation of intertidal habitat and associated works. The Contract is the NEC4 Engineering & Construction conditions and related documents as amended, under the Collaborative Delivery Framework set up by the Environment Agency.
- (B) The conditions of contract for the work are the NEC4 Engineering & Construction Contract Main Option C with secondary options and amended by additional Z clauses, all as signed between the parties.
 - The Client wishes to implement the additional works specified in the amended Scope ENVIMSW002130-ATK-XX-3XX-RP-Z-000001 P07 10-10-2023 ECC4 Arne Moor DoV Scope
- (C) together with all core preliminaries relating to staff, welfare, vegetation management (post vegetation clearance) and biosecurity)
- (D) Consequently, the parties wish to amend the Contract as set out in this Deed with effect from 05/03/2024 (Variation Date).

1. **DEFINITIONS AND INTERPRETATION**

1.1 This deed is supplemental to and takes effect as an amendment to the Wareham Coastal Change The Moors at Arne (Arne Moor contract). References within the Arne Moor contract to "contract" and "work" or "works" shall be interpreted as meaning the Arne Moor contract as amended by this deed. Matters set out in this deed are subject to the terms Arne Moor contract as amended by this deed.

WAREHAM COASTAL CHANGE THE MOORS AT ARNE CONTRACT

- 1.2 Unless otherwise stated in this deed:
 - (a) All references within this Deed to clauses are to the clauses of the Arne Moor contract;
 - (b) Definitions and principals of interpretation set out or referred to in the Arne Moor contract apply to this Deed;
 - (c) References to Annexes are to the Annexes to this Deed which form part of this Deed
- 1.3 In this Deed the following expressions have the following meanings:
 - (a) Effective Date means the date of this Deed
 - (b) Wareham Coastal Change The Moors at Arne or Arne Moor contract means the contract entered into between the parties on 03 July 2023.
- 1.4 The terms of this Deed are effective from the Effective Date.

2 VARIATION TO WAREHAM COASTAL CHANGE THE MOORS AT ARNE

- 2.1 This Deed varies the Arne Moor contract in accordance with the Annexes to this Deed
- 2.2 The parties acknowledge that this deed constitutes a variation of the works that falls outside of Core Clause 6 of the contract.
- 2.3 Subject to the variations set out in this Deed, the Arne Moor contract continues in full force and effect.
- 2.4 With effect from the Variation Date the Parties agree the following amendments to the Contract:

The Scope	Annex One – Wareham Coastal Change The Moors at Arne DOV Scope is additional to the Scope of the Arne Moors contract in its entirety and any reference in the NEC4 ECC, the Contract and any other part of the contract shall be interpreted as meaning the Arne Moor scope and the scope appended here as Annex One.


