Award of framework Agreement for the supply of GSS23564: UKRI Oligonucleotide Synthesis and Nucleic Acid Sequencing Services.

Following your tender/ proposal for the supply of GSS23564: Oligonucleotide Synthesis and Nucleic Acid Sequencing Services to UKRI, we are pleased to award this framework agreement ("Agreement") to you for the following Lots / Sub Lots:

- Sub Lot 2.1 Custom Gene Fragment Synthesis (Less that 2000 base pairs)
- Sub Lot 2.2 Custom Gene Synthesis (2001 3000 base pairs)
- Sub Lot 2.3 Custom Gene Synthesis (3001 5000 base pairs)

This letter ("Award Letter") and its Schedule(s) set out the terms of the Agreement between:

- (1) United Kingdom Research and Innovation, a statutory corporation whose registered office is at Polaris House, North Star Avenue, Swindon, England, SN2 1FL ("UKRI"); and
- (2) Twist Bioscience, a company incorporated and registered in United States with company number 333-231239 and registered VAT number 644 3073 52 whose registered office is at 681 Gateway Blvd, South San Francisco, CA 4080 United States(the "Supplier")

(each a "Party" and together the "Parties").

Unless the context otherwise requires, capitalised expressions used in this Award Letter have the same meanings as in the terms and conditions of contract set out in Schedule 1 to this Award Letter (the "Conditions"). Please do not attach any Supplier terms and conditions to this Award Letter as they will not be accepted by UKRI and may delay conclusion of the Agreement.

The Agreement is a framework under which UKRI may from time to time procure Goods and/or Services from the Supplier. When UKRI wishes to do so, the Parties shall use all reasonable endeavours to agree in good faith a call-off contract ("Contract") in relation to those Goods and/or Services within such timeframes as are reasonable. Each Contract may be documented by a further award letter, another form of contractual document, or (in the case of simpler Contracts) the issuance by UKRI and acceptance by the Supplier of a Purchase Order.

For the purposes of the Agreement, UKRI and the Supplier agree as follows:

Term

- 1 Commencement Date: 22nd February 2024
- 2 Expiry Date: 21st February 2027
- 3 UKRI may extend this Agreement for a period of up to 1 year by giving not less than 6 months' notice in writing to the Supplier prior to the Expiry Date. The terms and conditions of this Agreement shall apply throughout any such extended period.

Description of Goods and/or Services

4 The Specification of the Goods and/or Services to be delivered is as set out in: i) Schedule 2; and/or ii) the relevant Contract.

Charges & Payment

- 5 The Charges for the Goods and/or Services shall be as set out in: i) Schedule 3; and/or ii) the relevant Contract.

- To avoid delay in payment it is important that the invoice is compliant and that it includes a valid PO Number, PO Number item number (if applicable) and the details (name and telephone number) of your UKRI contact (i.e. Agreement Manager). Non-compliant invoices will be sent back to you, which may lead to a delay in payment. Supplier's Liability

Pursuant to clause 21.4, the Supplier's Limit of Liability under this Agreement and/or any Contract shall be: 125% of the total aggregate Charges paid and payable to the Supplier under this Agreement and any Contract.

Insurances

- 7 The Supplier is <u>not required</u> to maintain the following insurance policies referred to in clause 20.1 of the Conditions:
 - (a) Professional Indemnity insurance for not less than £2 million per claim
 - loss, damage or destruction of any of UKRI's property under the custody and control of the Supplier, with a minimum sum insured of £5 million per claim;
