1. INTRODUCTION

1.1 The Authority; The Department for Education require the support and maintenance contract renewing for ArcGIS licences and the payment of an annual subscription fee for ArcGIS online licenses.

2. PURPOSE

2.1 Crown Commercial Service are running this sourcing activity on behalf of The Authority to purchase support and maintenance for the ArcGIS licences which are already operational within the Department for Education.

3. BACKGROUND TO THE AUTHORITY

3.1 The Authority is responsible for issues affecting people in education within England up to the age of 19. The software provides a geographic information service to policy teams in the Department; producing maps for ministers, special advisors and policy colleagues. The maps that are produced are included in numerous internal and external publications and are integral in helping Ministers reach decisions on academies and free schools.

4. BACKGROUND TO REQUIREMENT/OVERVIEW OF REQUIREMENT

4.1 The Authority currently has a requirement for an ArcGIS support and maintenance contract. This is to support users in troubleshooting software, receiving software updates and bug fixes and exploiting the capabilities of the software owned by the Department. In addition to the support and maintenance contract, in order to host GIS products on the web and explore interactive GIS solutions the Authority require the subscription for ArcGIS online renewing. This agreement is to cover a one year period.
