Joint Schedule 3 (Insurance Requirements)

1. The insurance you need to have

- 1.1 The Supplier shall take out and maintain, or procure the taking out and maintenance of the insurances as set out in the Annex to this Schedule, any additional insurances required under a Call-Off Contract (specified in the applicable Order Form) ("**Additional Insurances**") and any other insurances as may be required by applicable Law (together the "**Insurances**"). The Supplier shall ensure that each of the Insurances is effective no later than:
 - 1.1.1 the Framework Start Date in respect of those Insurances set out in the Annex to this Schedule and those required by applicable Law; and
 - 1.1.2 the Call-Off Contract Effective Date in respect of the Additional Insurances.
- 1.2 The Insurances shall be:
 - 1.2.1 maintained in accordance with Good Industry Practice;
 - 1.2.2 (so far as is reasonably practicable) on terms no less favourable than those generally available to a prudent contractor in respect of risks insured in the international insurance market from time to time;
 - 1.2.3 taken out and maintained with insurers of good financial standing and good repute in the international insurance market; and
 - 1.2.4 maintained for at least six (6) years after the End Date.
- 1.3 The Supplier shall ensure that the public and products liability policy contain an indemnity to principals clause under which the Relevant Authority shall be indemnified in respect of claims made against the Relevant Authority in respect of death or bodily injury or third party property damage arising out of or in connection with the Deliverables and for which the Supplier is legally liable.

2. How to manage the insurance

- 2.1 Without limiting the other provisions of this Contract, the Supplier shall:
 - 2.1.1 take or procure the taking of all reasonable risk management and risk control measures in relation to Deliverables as it would be reasonable to expect of a prudent contractor acting in accordance with Good Industry Practice, including the investigation and reports of relevant claims to insurers;
 - 2.1.2 promptly notify the insurers in writing of any relevant material fact under any Insurances of which the Supplier is or becomes aware; and
 - 2.1.3 hold all policies in respect of the Insurances and cause any insurance broker affecting the Insurances to hold any insurance slips and other

evidence of placing cover representing any of the Insurances to which it is a party.

3. What happens if you aren't insured

- 3.1 The Supplier shall not take any action or fail to take any action or (insofar as is reasonably within its power) permit anything to occur in relation to it which would entitle any insurer to refuse to pay any claim under any of the Insurances.
- 3.2 Where the Supplier has failed to purchase or maintain any of the Insurances in full force and effect, the Relevant Authority may elect (but shall not be obliged) following written notice to the Supplier to purchase the relevant Insurances and recover the reasonable premium and other reasonable costs incurred in connection therewith as a debt due from the Supplier.

4. Evidence of insurance you must provide

- 4.1 The Supplier shall upon the Start Date and within 15 Working Days after the renewal of each of the Insurances, provide evidence, in a form satisfactory to the Relevant Authority, that the Insurances are in force and effect and meet in full the requirements of this Schedule.

5. Making sure you are insured to the required amount

- 5.1 The Supplier shall ensure that any Insurances which are stated to have a minimum limit "in the aggregate" are maintained at all times for the minimum limit of indemnity specified in this Contract and if any claims are made which do not relate to this Contract then the Supplier shall notify the Relevant Authority and provide details of its proposed solution for maintaining the minimum limit of indemnity.

6. Cancelled Insurance

- 6.1 The Supplier shall notify the Relevant Authority in writing at least five (5) Working Days prior to the cancellation, suspension, termination or non-renewal of any of the Insurances.
- 6.2 The Supplier shall ensure that nothing is done which would entitle the relevant insurer to cancel, rescind or suspend any insurance or cover, or to treat any insurance, cover or claim as voided in whole or part. The Supplier shall use all reasonable endeavours to notify the Relevant Authority (subject to third party confidentiality obligations) as soon as practicable when it becomes aware of any relevant fact, circumstance or matter which has caused, or is reasonably likely to provide grounds to, the relevant insurer to give notice to cancel, rescind, suspend or void any insurance, or any cover or claim under any insurance in whole or in part.

7. Insurance claims

- 7.1 The Supplier shall promptly notify to insurers any matter arising from, or in relation to, the Deliverables, or each Contract for which it may be entitled to claim under any of the Insurances. In the event that the Relevant Authority receives a claim relating to or arising out of a Contract or the Deliverables,

the Supplier shall cooperate with the Relevant Authority and assist it in dealing with such claims including without limitation providing information and documentation in a timely manner.

- 7.2 Except where the Relevant Authority is the claimant party, the Supplier shall give the Relevant Authority notice within twenty (20) Working Days after any insurance claim in excess of 10% of the sum required to be insured pursuant to Paragraph 5.1 relating to or arising out of the provision of the Deliverables or this Contract on any of the Insurances or which, but for the application of the applicable policy excess, would be made on any of the Insurances and (if required by the Relevant Authority) full details of the incident giving rise to the claim.
- 7.3 Where any Insurance requires payment of a premium, the Supplier shall be liable for and shall promptly pay such premium.
- 7.4 Where any Insurance is subject to an excess or deductible below which the indemnity from insurers is excluded, the Supplier shall be liable for such excess or deductible. The Supplier shall not be entitled to recover from the Relevant Authority any sum paid by way of excess or deductible under the Insurances whether under the terms of this Contract or otherwise.

Joint Schedule 11 (Processing Data)

Definitions

- . In this Schedule, the following words shall have the following meanings and they shall supplement Joint Schedule 1 (Definitions):

“Processor Personnel” all directors, officers, employees, agents, consultants and suppliers of the Processor and/or of any Subprocessor engaged in the performance of its obligations under a Contract;

Status of the Controller

- . The Parties acknowledge that for the purposes of the Data Protection Legislation, the nature of the activity carried out by each of them in relation to their respective obligations under a Contract dictates the status of each party under the DPA 2018. A Party may act as:
 - () “Controller” in respect of the other Party who is “Processor”;
 - () “Processor” in respect of the other Party who is “Controller”;
 - () “Joint Controller” with the other Party;
 - () “Independent Controller” of the Personal Data where the other Party is also “Controller”,

in respect of certain Personal Data under a Contract and shall specify in Annex 1 (*Processing Personal Data*) which scenario they think shall apply in each situation.

Where one Party is Controller and the other Party its Processor

- . Where a Party is a Processor, the only Processing that it is authorised to do is listed in Annex 1 (*Processing Personal Data*) by the Controller.
- . The Processor shall notify the Controller immediately if it considers that any of the Controller’s instructions infringe the Data Protection Legislation.
- . The Processor shall provide all reasonable assistance to the Controller in the preparation of any Data Protection Impact Assessment prior to commencing any Processing. Such assistance may, at the discretion of the Controller, include:
 - () a systematic description of the envisaged Processing and the purpose of the Processing;
 - () an assessment of the necessity and proportionality of the Processing in relation to the Deliverables;

- () an assessment of the risks to the rights and freedoms of Data Subjects; and
- () the measures envisaged to address the risks, including safeguards, security measures and mechanisms to ensure the protection of Personal Data.
- . The Processor shall, in relation to any Personal Data Processed in connection with its obligations under the Contract:
 - () Process that Personal Data only in accordance with Annex 1 (*Processing Personal Data*), unless the Processor is required to do otherwise by Law. If it is so required the Processor shall notify the Controller before Processing the Personal Data unless prohibited by Law;
 - () ensure that it has in place Protective Measures, including in the case of the Supplier the measures set out in Clause 14.3 of the Core Terms, which the Controller may reasonably reject (but failure to reject shall not amount to approval by the Controller of the adequacy of the Protective Measures) having taken account of the:
 - () nature of the data to be protected;
 - () harm that might result from a Personal Data Breach;
 - () state of technological development; and
 - () cost of implementing any measures;
 - () ensure that :
 - () the Processor Personnel do not Process Personal Data except in accordance with the Contract (and in particular Annex 1 (*Processing Personal Data*));
 - () it takes all reasonable steps to ensure the reliability and integrity of any Processor Personnel who have access to the Personal Data and ensure that they:
 - () are aware of and comply with the Processor's duties under this Joint Schedule 11, Clauses 14 (*Data protection*), 15 (*What you must keep confidential*) and 16 (*When you can share information*) of the Core Terms;
 - () are subject to appropriate confidentiality undertakings with the Processor or any Subprocessor;
 - () are informed of the confidential nature of the Personal Data and do not publish, disclose or divulge any of the Personal Data to any third party unless directed in writing to do so by the Controller or as otherwise permitted by the Contract; and
 - () have undergone adequate training in the use, care, protection and handling of Personal Data;
 - () not transfer Personal Data outside of the UK or EU unless the prior written consent of the Controller has been obtained and the following conditions are fulfilled:
 - () the Controller or the Processor has provided appropriate

- safeguards in relation to the transfer (whether in accordance with UK GDPR Article 46 or LED Article 37) as determined by the Controller;
 - () the Data Subject has enforceable rights and effective legal remedies;
 - () the Processor complies with its obligations under the Data Protection Legislation by providing an adequate level of protection to any Personal Data that is transferred (or, if it is not so bound, uses its best endeavours to assist the Controller in meeting its obligations); and
 - () the Processor complies with any reasonable instructions notified to it in advance by the Controller with respect to the Processing of the Personal Data; and
- () at the written direction of the Controller, delete or return Personal Data (and any copies of it) to the Controller on termination of the Contract unless the Processor is required by Law to retain the Personal Data.
- . Subject to paragraph 8 of this Joint Schedule 11, the Processor shall notify the Controller immediately if in relation to it Processing Personal Data under or in connection with the Contract it:
 - () receives a Data Subject Access Request (or purported Data Subject Access Request);
 - () receives a request to rectify, block or erase any Personal Data;
 - () receives any other request, complaint or communication relating to either Party's obligations under the Data Protection Legislation;
 - () receives any communication from the Information Commissioner or any other regulatory authority in connection with Personal Data Processed under the Contract;
 - () receives a request from any third Party for disclosure of Personal Data where compliance with such request is required or purported to be required by Law; or
 - () becomes aware of a Personal Data Breach.
- . The Processor's obligation to notify under paragraph 7 of this Joint Schedule 11 shall include the provision of further information to the Controller, as details become available.
- . Taking into account the nature of the Processing, the Processor shall provide the Controller with assistance in relation to either Party's obligations under Data Protection Legislation and any complaint, communication or request made under paragraph 7 of this Joint Schedule 11 (and insofar as possible within the timescales reasonably required by the Controller) including by immediately providing:
 - () the Controller with full details and copies of the complaint, communication or request;

- () such assistance as is reasonably requested by the Controller to enable it to comply with a Data Subject Access Request within the relevant timescales set out in the Data Protection Legislation;
- () the Controller, at its request, with any Personal Data it holds in relation to a Data Subject;
- () assistance as requested by the Controller following any Personal Data Breach; and/or
- () assistance as requested by the Controller with respect to any request from the Information Commissioner's Office, or any consultation by the Controller with the Information Commissioner's Office.
- . The Processor shall maintain complete and accurate records and information to demonstrate its compliance with this Joint Schedule 11. This requirement does not apply where the Processor employs fewer than 250 staff, unless:
 - () the Controller determines that the Processing is not occasional;
 - () the Controller determines the Processing includes special categories of data as referred to in Article 9(1) of the UK GDPR or Personal Data relating to criminal convictions and offences referred to in Article 10 of the UK GDPR; or
 - () the Controller determines that the Processing is likely to result in a risk to the rights and freedoms of Data Subjects.
- . The Processor shall allow for audits of its Data Processing activity by the Controller or the Controller's designated auditor.
- . The Parties shall designate a Data Protection Officer if required by the Data Protection Legislation.
- . Before allowing any Subprocessor to Process any Personal Data related to the Contract, the Processor must:
 - () notify the Controller in writing of the intended Subprocessor and Processing;
 - () obtain the written consent of the Controller;
 - () enter into a written agreement with the Subprocessor which give effect to the terms set out in this Joint Schedule 11 such that they apply to the Subprocessor; and
 - () provide the Controller with such information regarding the Subprocessor as the Controller may reasonably require.
- . The Processor shall remain fully liable for all acts or omissions of any of its Subprocessors.
- . The Relevant Authority may, at any time on not less than thirty (30) Working Days' notice, revise this Joint Schedule 11 by replacing it with any applicable controller to processor standard clauses or similar terms forming part of an applicable certification scheme (which shall apply when incorporated by attachment to the Contract).

- . The Parties agree to take account of any guidance issued by the Information Commissioner's Office. The Relevant Authority may on not less than thirty (30) Working Days' notice to the Supplier amend the Contract to ensure that it complies with any guidance issued by the Information Commissioner's Office.

Where the Parties are Joint Controllers of Personal Data

- . In the event that the Parties are Joint Controllers in respect of Personal Data under the Contract, the Parties shall implement paragraphs that are necessary to comply with UK GDPR Article 26 based on the terms set out in Annex 2 to this Joint Schedule 11.

Independent Controllers of Personal Data

- . With respect to Personal Data provided by one Party to another Party for which each Party acts as Controller but which is not under the Joint Control of the Parties, each Party undertakes to comply with the applicable Data Protection Legislation in respect of their Processing of such Personal Data as Controller.
- . Each Party shall Process the Personal Data in compliance with its obligations under the Data Protection Legislation and not do anything to cause the other Party to be in breach of it.
- . Taking into account the state of the art, the costs of implementation and the nature, scope, context and purposes of Processing as well as the risk of varying likelihood and severity for the rights and freedoms of natural persons, each Party shall, with respect to its Processing of Personal Data as Independent Controller, implement and maintain appropriate technical and organisational measures to ensure a level of security appropriate to that risk, including, as appropriate, the measures referred to in Article 32(1)(a), (b), (c) and (d) of the UK GDPR, and the measures shall, at a minimum, comply with the

requirements of the Data Protection Legislation, including Article 32 of the UK GDPR.

- . A Party Processing Personal Data for the purposes of the Contract shall maintain a record of its Processing activities in accordance with Article 30 UK GDPR and shall make the record available to the other Party upon reasonable request.
- . Where a Party receives a request by any Data Subject to exercise any of their rights under the Data Protection Legislation in relation to the Personal Data provided to it by the other Party pursuant to the Contract (**“Request Recipient”**):
 - (i) the other Party shall provide any information and/or assistance as reasonably requested by the Request Recipient to help it respond to the request or correspondence, at the cost of the Request Recipient; or
 - (i) where the request or correspondence is directed to the other Party and/or relates to that other Party's Processing of the Personal Data, the Request Recipient will:
 - (i) promptly, and in any event within five (5) Working Days of receipt of the request or correspondence, inform the other Party that it has received the same and shall forward such request or correspondence to the other Party; and
 - (i) provide any information and/or assistance as reasonably requested by the other Party to help it respond to the request or correspondence in the timeframes specified by Data Protection Legislation.
- . Each Party shall promptly notify the other Party upon it becoming aware of any Personal Data Breach relating to Personal Data provided by the other Party pursuant to the Contract and shall:
 - (i) do all such things as reasonably necessary to assist the other Party in mitigating the effects of the Personal Data Breach;
 - (i) implement any measures necessary to restore the security of any compromised Personal Data;
 - (i) work with the other Party to make any required notifications to the Information Commissioner's Office and affected Data Subjects in accordance with the Data Protection Legislation (including the timeframes set out therein); and
 - (i) not do anything which may damage the reputation of the other Party or that Party's relationship with the relevant Data Subjects, save as required by Law.
- . Personal Data provided by one Party to the other Party may be used exclusively to exercise rights and obligations under the Contract as specified in Annex 1

- be written in plain English in language which is readily comprehensible to the staff of the Supplier and the Buyer engaged in the provision of the Deliverables and shall only reference documents which are in the possession of the Parties or whose location is otherwise specified in this Schedule.

4.3 Development of the Security Management Plan

- 4.3.1 Within twenty (20) Working Days after the Start Date and in accordance with Paragraph 4.4, the Supplier shall prepare and deliver to the Buyer for Approval a fully complete and up to date Security Management Plan which will be based on the draft Security Management Plan.

1.1 A forensic Accountant (FA) is required to consider the evidence in a legal case and produce a report as to the flow of money between the various parties and companies involved. This is to identify what has happened to the money that was obtained as a result of the alleged offending.

1.2 This is to support activity following a criminal investigation which has taken place in relation to a number of suspects. The investigation relates to a number of offences involving several companies. This is currently being reviewed with a view to potentially commencing a prosecution in the near future.

1.3 In addition to producing the report, the Forensic Accountant may also be required to present the report in legal proceedings (Court Case).

2. BACKGROUND TO THE CONTRACTING AUTHORITY

2.1 The Insolvency Service is an executive agency of the Department for Business and Trade (DBT). The Insolvency Service (INSS) has a number of responsibilities in relation to delivering economic confidence by supporting those in financial distress, maximising returns to creditors and tackling financial wrongdoing.

2.2 This particular statement of requirements concerns the work that the agency does in relation to tackling financial wrongdoing, and the work carried out by the Investigation and Enforcement Services (IES), and the Legal Services Directorate (LSD) within the agency.

3. BACKGROUND TO REQUIREMENT/OVERVIEW OF REQUIREMENT

3.1 IES are responsible for a range of investigation and enforcement activities both civil and criminal including investigating criminal offences. LSD undertakes civil and criminal proceedings including the prosecution of criminal offences.

3.2 A criminal investigation into several individuals has taken place that involves a number of companies.

3.3 This investigation concerns allegations that the business activities of one main individual and several of their associates repeatedly and systematically bought established companies before running them into the ground, such that within a short period following their acquisition, they began to fail and were forced into administration. In the process, it is alleged that company assets were stripped away, creditors went unpaid, and funds were dishonestly appropriated and diverted for the benefit of this individual and others. The investigation has focussed on a 'parent company' which it is alleged was the vehicle used to acquire control of those small-medium scale, established businesses. It then received funds from those businesses under its control and acted as a clearing facility for the funds, which were mainly paid to the lead individual.

3.4 Following the investigation in this matter, it is considered of great importance that a Forensic Accountant considers the relevant material and provides a report on the flow of money between the companies and individuals involved. Further, should this matter proceed to a criminal trial, then any such expert will also be required to give evidence at the trial and to present their findings with the assistance of graphics that will help a jury to understand the evidence. Any report should be prepared in compliance with Part 19 of the Criminal Procedure Rules

3.5 This report is required in order to complete the evidence in this case before a decision is made in relation to potential prosecution.

3.6 This report is an important part of the case and could potentially form a key piece of evidence should this matter proceed to prosecution.

5.1.5 Attend court to give evidence if required (excluding expert witness expenses)

5.2 The following are not in scope:

5.2.1 Expert witness expenses in relation to the costs of attending court. These will be paid separately in line with the Insolvency Service policy on witness expenses.

6. THE REQUIREMENT

6.1 The Forensic Accountant (FA) will be required to:

6.2 The above will need to be produced in compliance with Part 19 of the Criminal Procedure Rules 2020.

6.3 Experience of working in the Criminal Justice System and the Crown Courts will be required. This should include experience of preparing reports for use in criminal investigations and prosecutions as well as attending the Crown Court as an expert witness. It is expected that the FA will be familiar with criminal court procedure insofar as it relates to giving evidence as a witness.

6.4 Additionally, the FA will need to be familiar with their obligations as a prosecution expert in relation to disclosure, unused material and case management as set out in the guidance from the Crown Prosecution Service: Expert Guidance on Disclosure, Unused Material and Case Management | The Crown Prosecution Service

6.5 Any report and graphics will need to be produced within 10 weeks of instruction.

7. SUSTAINABILITY & SOCIAL VALUE OPPORTUNITIES

7.1 Government has made clear its determination to tackle modern slavery crimes, referring to them as “the greatest human rights issue of our time”. 7.3 The supply chain we rely on is global, as well as the risks within the UK we must understand the global risks relating to our Procurement activity. We need to work with our suppliers to map our supply chains, understand where Modern Slavery risks lie and work together to

address these. Details of any specific requirements in relation to Modern Slavery will be set out further in this statement of requirements below and aligned to our Terms and Conditions of Contracts. While questions relating to Modern Slavery are included in the Standard Selection Questionnaire, suppliers or supply chains with high-risk supply chains may be required by the Authority to complete the Modern Slavery Assessment Tool (MSAT), updating their response regularly with any changes. 9. SECURITY REQUIREMENTS

- 9.1 The location of the Services will be carried out remotely and all papers will be sent in a secure manner and in an electronic file via Egress for review.
- 9.2 Egress is secure tool hosted by a 3rd party and used by the Agency to exchange secure emails and documents (which can be voluminous in numbers or document size) with sanctioned parties (e.g. The Court Service, Police Authorities, or individuals or companies under investigation etc).
- 9.3 The evidence reviewed by the forensic accountant is to be treated as confidential and are not to be shared.
- 9.4 In terms of any report produced by the FA, the report may well be relied on as evidence in any criminal prosecution, and if it is not to be relied upon it may be disclosed to the defence. This will be done in line with rules around onward disclosure in these circumstances.
- 9.5 Any instructions provided by the lawyer with responsibility for this matter are to be treated as legally professionally privileged and are not to be shared.

11. AUTHORITY'S RESPONSIBILITIES

11.1 INSS will provide the relevant evidence for the forensic accountant to review on the same day as instruction.

11.2 INSS will review the report and provide any queries or questions on the report within 2 weeks of receiving the report.

11.3 INSS will provide details, guidance and/or information if there is a requirement to attend and summarise the report in a court case. INSS will provide details of when and where the case will be heard. Our Paralegal Officers will liaise with any FA required to attend court as a witness and answer any questions.

12. REPORTING

12.1 Any report produced must meet accessibility requirements and it is recommended that the report is produced using Arial Size 12 Font.

13. CONTRACT DURATION

13.1 The contract will run from the date of instruction until the conclusion of any potential criminal proceedings.

13.2 It is expected that the contract will run for a minimum period of 12 months. However dependent on the timings of any court case, availability may need to be outside of this 12-month period (if the FA is to act as witness in court). Many court cases are taking a significant time to be heard and often take well over a 12 months.

13.3 The FA will need to be available for the entirety of any court case if they are being relied upon as a witness, but dates to avoid will be considered when any trial is set.

16.4 All estimates should contain an hourly rate for reading and preparation.

16.5 Any future invoice should break down the work carried out and the time spent doing the work.

16.6 Prices are to be submitted via the agreed method to be detailed by INSS. Prices will exclude VAT.

17. PAYMENT

17.1 The Insolvency Service recognises the importance of prompt, fair and effective payment in all businesses. Being paid promptly for work done ensures businesses have a
