**1. Dependencies**

- 1.1. The dependencies of the Authority set out in this Annex A to Schedule 2 (*Authority Dependencies*) shall constitute the 'Authority Dependencies' under this Contract.
- 1.2. The dependencies specified within this Annex shall be provided to the Contractor free of charge, unless otherwise agreed between the Parties.

**2. Specific Obligations**

- 2.1. The Authority shall be responsible for performing or procuring the Authority Dependencies included in this annex by the stated Dependency Start Date.
- 2.2. The Parties shall use the pre-agreed, impact on service delivery and the commercial consequence, as the basis for negotiation on the level of relief from performance as a result of the Authority's failure to perform.
- 2.3. Each Authority Dependency have been categorised in importance and are indicated as either 1, 2 or 3 (1 being the highest priority).
