**CONTRACT FOR:** Economic Policy Incubator (EPI) Component of Accelerating Investment and Infrastructure (AiiN) Programme

With reference to the contractual letter dated 22 January 2016 whereby your firm was engaged to carry out the Terms of Reference as detailed at Section 3 therein, as most recently amended by the letter of 19 September 2017, I confirm that the UK Government wishes to make the following further amendments to the letter of 22 January 2016:

### **Section 1 – Form of Contract**

#### **3 – Commencement and Duration of the Services**

**DELETE** “31 March 2020” (“the End Date”) and **REPLACE** with “31 March 2022” (“the End Date”).

#### **4 – Financial Limit**

**DELETE** “£6,087,020” (“the Financial Limit”) and **REPLACE** with “£10,319,993” (“the Financial Limit”).

### **Section 5 – Schedule of Prices**

**DELETE** existing proformas and **REPLACE** with revised proformas which are enclosed and form part of this amendment.

Technical/Commercial Scale Up Proposals dated 28 February 2019 and revised on 30 April 2019 refer. Revised Commercial Proformas submitted on 04 June 2019 refer.

1. This amendment relates to (a) a time extension until 31 March 2022 and (b) an increase in the Financial Limit of the Contract by £4,232,973.
2. The time and cost extension is to facilitate the delivery of significant additional outcomes particularly by responding to the opportunities presented by Nepal's transition from a unitary to a federal system.

- 3. Please confirm in writing by signing and returning one copy of this letter that you accept the amendments set out herein.
- 4. Please note the provision in the contractual letter that the financial limit of the UK Government’s liability to the Consultants under this engagement shall not exceed the sum specified unless the amount of any such excess has been agreed by the Department for International Development in writing before the Consultants take any action which might result in the financial limit being exceeded.
