2. Following agreement of the Low Complexity trial process for this Modification, the Contractor submitted LOL Actual costs at Reference C. As a result the Authority hereby agrees to a contract price of Redacted Under FOIA 2000 Section 43 **ex VAT** which is pegged on the basis that the 2024 and 2025 labour hourly rates for Leonardo UK Limited may be subject to change should any revision be agreed between the Authority and the Contractor. All other costs are agreed as firm and will not be subject to change. This price is agreed without prejudice to any future negotiation on this or any other Ministry of Defence Contract.

3. To confirm your Acceptance of this Offer then please sign the MCF at the designated section and return the document to the Authority. Your Acceptance of the Authority's Offer must be unqualified and within 10 (ten) working days of the date of this Letter. If you do not accept the Authority's Offer within the period specified, then the Offer shall lapse.

4. When you have accepted the Offer, the Authority shall raise and notify you of the Purchase Order Number on CP&F against which you should then proceed with submitting your invoice for subsequent payment.
