- Paragraph 4, Financial Limit: Delete "£28,897,566" and replace with "£33,719,219".

- **3.** This contract amendment relates to the extension of the programme from 1<sup>st</sup> August 2015 to 30<sup>th</sup> April 2016 and the subsequent increase in costs associated with this. Justification and Financial Proposal dated 9<sup>th</sup> January 2015 refers.
- 4. As a result of this amendment DFID expects the following key deliverables to be fulfilled:-
  - We expect continued delivery of further tangible results on policy changes, improved accountability and improved space for citizens. During the extension SAVI should ensure all the current 89 and further case studies of results are clearly documented and work with partners to sustain those changes during the transition of governments in the States.

- Prepare for the transition to successor programme as follows:-
