

## Award of contract for the supply of APHA Transformation Programme

Following your tender/ proposal for the supply of APHA Transformation Programme to APHA (on behalf of Defra Group), we are pleased to award this contract to you.

For the purposes of the Agreement, the Authority and the Supplier agree as follows:

- 1. The Services shall be performed at a combination of at Authorities premise located at **a combination** and virtually. The Contract Manager will inform of the working location weekly.
- 2. The charges for the Services shall be as set out in Annex 3 dated 12<sup>th</sup> September 2022.

- 3. The specification of the Services to be supplied is as set out in Annex 2 dated 12<sup>th</sup> September 2022.
- 4. The Term shall commence on **17<sup>th</sup> October 2022** and the Expiry Date shall be **16<sup>th</sup> January 2023**, unless extended or subject to early termination.


