2. Introduction

2.1 Confidentiality

The contents of this request for proposals together with all other information, materials, specifications or other documents provided by Cycling UK, or prepared by the tenderers specifically for Cycling UK, shall be treated at all times as confidential by the tenderers. Tenderers shall not disclose any such information, materials, specifications or other documents to any third parties or to any other part of the tenderers´ group or use them for any purpose other than for the preparation and submission of a response to this request nor shall tenderers publicise Cycling UK´s name or the tender without the prior written consent of Cycling UK. Cycling UK in turn confirms that it shall treat all information provided to it by the tenderer as confidential and further confirms that such information will not be disclosed by Cycling UK to any third parties, other than to (i) members of Cycling UK committees and (ii) advisers and consultants to Cycling UK.

Tenderers shall ensure that all third parties to whom disclosure is made shall keep any such information, materials, specifications or other documents confidential and not disclose them to any other third party except as set out above.

Tenderers must seek the approval of Cycling UK before providing to third parties any information provided in confidence by Cycling UK or its professional advisers and must maintain a register of all employees and third parties who have or have had access to such information. If so requested by Cycling UK, tenderers must make such a register available for immediate inspection by Cycling UK or its duly authorised representatives. The sharing of this information with any third party subcontractor is also bound by the provisions.

3. Context and Background

3.1. Background to Cycling UK

Cycling UK is a membership charity who have championed the cause of Cycling for more than 140 years. This was formerly as the Cyclists Touring Club (CTC) and from 2015 as Cycling UK. We currently have around 71,000 members and 7,000 volunteers with a diverse range of stakeholders including activists, educators, employers, community groups and the wider cycling community to connect, equip and facilitate the cycling movement.

This is operationally delivered by 120 staff based across the country and from our Headquarters located in Guildford.

We are part way through delivery of a 5-year strategy which has a mission to enable millions of people to cycle through key strategic activities including:

- Organisationally we will grow and diversify our income and develop our organisation
- Grow a bigger, more diverse volunteer network
- Improve the way we engage with groups
- Expand our behaviour change programmes
- Collaborate more
- Influence a wider range of people
- Be more responsive to the needs of different places

The strategy is intended to support and further the delivery of our charitable Objects which are to:

- promote community participation in healthy recreation by promoting the amateur sport of cycling, cycle touring and associated amateur sports;
- preserve and protect the health and safety of the public by encouraging and facilitating cycling and the safety of cyclists;
- advance education by whatever means the trustees think fit, including the provision of cycling, training and educational activities related to cycling; and
- promote the conservation and protection of the environment.









3.2. Background to the Experience Project

As a partner on the EXPERIENCE tourism project, Cycling UK is developing new destinations to boost year-round cycle tourism in three pilot regions: Norfolk, Kent and Cornwall. Cycling UK is developing a new accreditation scheme for hospitality and accommodation businesses, Cycle Friendly Places, to help them better attract cyclists and respond to their needs. Within these pilot regions, we're proposing to develop 15 cycle hubs that will be centers for activity in the county.

EXPERIENCE is a €23.3 million project co-financed by the European Regional Development Fund (ERDF, €16 million) through the Interreg VA France (Channel) England Programme 2014-2020, boosting visitor numbers in six pilot regions across England and France.

EXPERIENCE aims to harness the experiential tourism trend by connecting tourists with the unique cultural, historical and natural identity of a place. Project partners in each pilot region are developing new off-season (October-March) activities and itineraries to boost tourism numbers and help local businesses attract tourists, generating 20 million new off-season visitors spending €1 billion across the Channel region by June 2023.

As part of the accreditation, Cycling UK are offering tourism businesses extensive parking and ancillary equipment to help them better attract and support customers arriving by bike or using one during their stay. We will be providing parking and ancillary products to businesses in the cycle hubs free of charge once businesses are accepted into the accreditation programme.

4.1. Equipment Required

4.2. Quantity required

We expect to require a maximum of:

- 45 Cycle lockers
- 45 Sheffield stands
- 45 Ground/Wall anchors
- 30 Fixed work stations

This will be across the entire project lifetime (until August 2022).

4.3. Budget

The maximum budget for this tender is £76,500 across all the items above, including VAT and delivery (and installation if required). We expect prospective partners to be able to deliver at a lower price point recognising the economies of scale.

We seek a partner who can provide the items specified above in single deliveries to individual businesses.

Cycling UK will purchase a bulk order and provide a monthly list of addresses to deliver the items to until our purchased amount is exhausted.

We prefer partners who can provide this fulfilment for Cycling UK.

4.4. Timeline for the project

We will place our first order by 20 July 2021, and we expect to continue ordering until August 2022 (or possibly longer)

4.5. Request for Proposal Process and Schedule

Cycling UK is happy to answer questions and/or provide clarification to interested suppliers prior to submission of proposals, and actively encourages such dialogue.

- 4) Other information. Please provide any further information you consider relevant to the proposal (250 words max)

5.2. Selection criteria:

The responses to this brief will be scored 0-4 on the following criteria:

- How closely the suggested equipment matches or exceeds the specification.
- Price
- Convenience of ordering and delivery logistics incl. lead times.
- Process and lead times for arranging installation, if offered, in the three counties.
