Clarification Point

In Annex A, reference 1.2.1, we refer a phased approach to remedial works. Since the tender was launched, the Museum has developed a partnership and has a series of related bookings that increase car park use overall. Therefore, we expect that we will need upto two thirds of occupancy at any single time and that a phased approach should instead look at 33/33/33 split, as opposed to 50/50.

When we are developing a remedial works plan, what longevity would you expect from our proposed submission? The Museum would expect any submission to safeguard against future degradation from heavy traffic and frequent turning, to last a minimum of five years.

Can you please clarify the use of the pricing tables, one and two on page 53 (Section 3.2.1).

The tables allow us to compare the cost of specific elements, although this is a standard document and used for a variety of tender opportunities. To aid you with your response, If any material is subject to change price or fluctuate or works be time specific please list these here with the appropriate maximums. You can also include the individual elements/items in table one. The overall completion price would then be listed in table two. For this type of tender we would only expect one line in table two.

Please can you confirm if attachments are included within Criterion 5 and Criterion 6 these will not be included within the word count for each question?
