- 2. The Firm Price value of this Contract is £19,025.00 (Nineteen Thousand and Twenty-Five Pounds Ex VAT).
- 3. You are requested to liaise with David Willoughby either by email (dwilloughby@dstl.gov.uk) or by telephone on 01980 955790 no less than 5 days prior to the intended delivery date. Delivery of the equipment shall take place no later than 28 February 2025. Upon reporting to the DSTL gatehouse all Contractor's personnel will need to produce either a valid passport or photo card driver's licence to verify their identity and provide the name and contact details of the person who will be taking the delivery.
- 4. Please note that during March and April 2025 there iwill be ongoing Construction works at the entrance to DSTL Porton Down. that will effect the routes to be taken in and out of DSTL Porton Down. In addition Winterslow Road Road that crosses Porton Down Ranges will be closed to all traffic from the junction of the A30 to Blackbarn Road. Annex A to this letter provides details of the routes to takeown over this period.
- 5. Payment will be made in accordance with the information provided on the enclosed Purchase Order.
- 6. If you wish to accept this Offer, please complete and sign the attached Acceptance of Offer of Contract 10 returning one signed pdf copy to me at the address shown above by post within 10 working days of the date of this Offer. Your acceptance of the Authority's Offer must be unqualified. If you do not accept the Authority's Offer within the period specified, then the Authority's Offer will lapse.

- 7. No Contract will come into existence until you have accepted the Authority's Offer in accordance with paragraph 6 above. Accordingly, prior to your unconditional acceptance of this Offer, the Authority shall not be responsible in any way whatsoever for any:
 - a. work undertaken by you; or
 - b. costs incurred by you.
- 8. When you have accepted the Authority's Offer in accordance with paragraph 4 above, you must proceed with the performance of the Contract.
- 9. The Authority may publish notification of the Contract and shall publish Contract documents under the FOI Act except where publishing such information would hinder law enforcement; would otherwise be contrary to the public interest; would prejudice the legitimate commercial interest of any person, or might prejudice fair competition in the supply chain.
- 10. If you wish to make a similar announcement you must seek approval from the named Commercial Officer.

Delivery Instructions for DSTL Porton Down during March and April 2025

Note 1: Deliveries and Contractors during construction

All arrivals

All deliveries and contractors must access via Manor Farm Road and report to Dstl Main Reception/Permit Control Office (PCO) (B460) as at present.

Vehicles must park in designated areas – these will be clearly signposted (including separate HGV parking).

Once passes are issued, vehicles up to and including large vans can access site via the service road behind Dstl Main Reception (B460) – Check Point 2. LGV and HGV will be directed to access site via Blackbarn Road. Escorts will be provided as at present.

All departures

Exit from 06:00 – 12:00 will be via the road running through Carpark E (B600) and onto Blackbarn Road – see attachment '6am-12-PTN-Traffic_Management' Map. No other vehicle exit route is available.

Exit from 12:00 – 18:00 will be via Silver Star gate and onto Blackbarn Road – see attachment '12-6pm-PTN-Traffic_Management' Map.

Larger vehicles and construction traffic can continue to exit site via the road running through Carpark E (B600) and turning left at Silver Star corner onto Blackbarn Road as per current arrangements.

- * Provision for pass return will be made on Blackbarn Road.
- * Contractors that need to re-visit the Permit Control Office (PCO) to clear documentation must re-access via Manor Farm Road.

Note 2: Advance Notice of Closure of Winterslow Road

The MOD section of Winterslow Road that crosses Porton Down Ranges will be closed to all traffic from the junction of the A30 to Blackbarn Road on the following dates - and during the prescribed hours as displayed in the table below.

If you can, please reschedule your delivery outside of the road closure period or factor that into your delivery route planning.

10 - 14 March

Closed each day 10:00 to 15:00

17 - 21 March

Closed each day 12:00 to 15:30 and evenings between 17:30 to 23:00

24 – 28 March

Closed each day 10:00 to 15:00

31 March - 04 April

Closed each day 10:00 to 15:00

The Dstl site entrance at Blackbarn Road and Manor Farm Road will not be impacted and are to remain open throughout.

Diversions have been agreed with Wiltshire Council:

The agreed suggested detour route for when this section of Winterslow Road is closed from Salisbury or the south/southeast is via the A338 through Winterbourne Dauntsey, West Gomeldon and Porton Village.

The suggested detour route from Andover or the northeast is via Palestine (B3084) and then Cholderton, Allington, Boscombe (A338) and Porton Village.

These detours maybe unsuitable for larger and high vehicles due to narrow roads and access under the bridge from PTN village.
