With reference to the contractual letter dated 04th October 2013 (as most recently amended by the letter dated 26th July 2016) whereby your firm was engaged to carry out the Terms of Reference as set out at Annex A of the contract, I confirm that the UK Government wishes to make the following further amendments to the letter of 04th October 2013 in accordance with your proposal dated 21st April 2017 and subsequent clarifications dated 06th June 2017.

Section 1, Para 3 – Commencement and Duration of the Services

Delete: The supplier shall start the services on 14th October 2013 ("the Start Date") and shall complete them by 13th October 2017 ("the End Date").

Insert: The supplier shall start the services on 14th October 2013 ("the Start Date") and shall complete them by 13th October 2018 ("the End Date").

Note: These dates supersede those proposed by Options Consultancy Services Ltd in Proposal dated 21st April 2017 as confirmed and agreed in email dated 26/06/17.

Insert: The Professional Indemnity insurance cover limit for the 12 month extension period (incorporated by way of Amendment Number 6) is £10M and must be maintained for the duration of the extension period.

2. This amendment relates to a revision to incorporate a twelve month extension to the contracted "End Date" in accordance with the PO5976 Terms and Conditions. This increases the overall financial limit by £2,376,505 with Professional Indemnity insurance cover revised accordingly. All other Terms and Conditions of this contract remain the unchanged.
