### Notes on usage pricing:

- These prices are valid from the introduction of Ofcom's new Non-Geographic pricing structure on 1<sup>st</sup> July 2015.
- For 084, 087, 09 & 118 numbers, the service charge price point for a given number will be defined in the BT Carrier price list.
- Prices are based on the call being terminated to an 01 or 02 number in the UK. If a call terminates to a UK mobile, an International number or another non-geographic number then an additional call record is generated that is charged at outgoing call rates.
- Prices apply to UK originated traffic terminating to UK geographic numbers (01/02). Prices for calls originating outside the UK may vary due to deductions / charges made before calls are passed to Vodafone.
- A PhonepayPlus levy (PP+ levy) is applicable to all outpayments on 09, 118 and 087 Service Charges above 7 pence/minute or 7 pence/call. The value of this levy is set annually by PhonepayPlus to fund the regulation of these premium rate services and is announced on their website. Vodafone is required to deduct this levy and pass it on. For the year 1st April 2015 to 31st March 2016, the levy is 0.6%.. The net prices are shown for 2015/16. In future years the gross prices in this price list will be used to calculate a net payment using the value of the levy that is prevailing at the time.
- Prices are in pence per minute and exclude VAT.
- Prices are valid for all times of day.
