1 Background

Scilly Linen offers a full commercial linen and laundry solution for hotels, guest houses, holiday homes and restaurants throughout the Isles of Scilly. We aim to remove the environmental and logistical consequences of shipping laundry to the mainland, as well as minimising any environmental impact on the islands. We achieve this by using a state-of-the-art Lagoon™ laundry system, the most technically advanced and environmentally friendly system available and the first water-based cleaning system to obtain the endorsement of Woolmark.
