System Performance Visibility, Health Monitoring and Data-led Decision-Making Products

Undertaking discovery, design, develop, deployment and sustainment phases; with the purpose of creating system wide performance frameworks, digital products, and governance in order to provide visibility of system performance and health and support improved decision making and system outcomes.

Alongside technical development and deployment, establishing system-level governance and operational ownership through business and behaviour change interventions. Support command level decision making to drive system thinking and in turn improved system performance and health, as well as improving data and MI quality and access in key areas, with the goals of driving policy and leading the system through integrated, transparent, and responsive insights.

Building general digital capability in key operational and quality assurance teams, to develop sustainability of products and lay the foundations for systems thinking within leadership and analytics teams.

Alongside the system level tooling, development of key "accelerator" products / work packages, in operational commands, to support delivery of accelerated improvement in areas of poor performance. Accelerators include the development of connected tooling and governance in an area of high value / criticality for operations and capabilities. The accelerator will involve the development of digital tooling, supported by associated capability build and governance and processes changes; with the objective of impacting operational decision making using flexible, intelligent and responsive in employing data and information and lay the foundations of System thinking in the operational command.
