Joint Schedule 11 (Processing Data)

Definitions

In this Schedule, the following words shall have the following meanings and 1. they shall supplement Joint Schedule 1 (Definitions):

"Processor Personnel"

all directors, officers, employees, agents, consultants and suppliers of the Processor and/or of any Subprocessor engaged in the performance of its obligations under a Contract;

Status of the Controller

 - harm that might result from a Personal Data Breach; (ii)
 - state of technological development; and (iii)
 - cost of implementing any measures; (iv)
- (c) ensure that:
 - the Processor Personnel do not Process Personal Data except in (i) accordance with the Contract (and in particular Annex 1 (Processing Personal Data));
 - it takes all reasonable steps to ensure the reliability and integrity (ii) of any Processor Personnel who have access to the Personal Data and ensure that they:
 - (A) are aware of and comply with the Processor's duties under this Joint Schedule 11, Clauses 14 (Data protection), 15 (What you must keep confidential) and 16 (When you can share information) of the Core Terms;
 - are subject to appropriate confidentiality undertakings with (B) the Processor or any Subprocessor;
 - are informed of the confidential nature of the Personal Data (C) and do not publish, disclose or divulge any of the Personal Data to any third party unless directed in writing to do so by the Controller or as otherwise permitted by the Contract;
 - have undergone adequate training in the use, care, (D) protection and handling of Personal Data;
- not transfer Personal Data outside of the UK or EU unless the prior written (d) consent of the Controller has been obtained and the following conditions are fulfilled:
 - the Controller or the Processor has provided appropriate (i) safeguards in relation to the transfer (whether in accordance with

- UK GDPR Article 46 or LED Article 37) as determined by the Controller:
- (ii) the Data Subject has enforceable rights and effective legal remedies;
- the Processor complies with its obligations under the Data (iii) Protection Legislation by providing an adequate level of protection to any Personal Data that is transferred (or, if it is not so bound, uses its best endeavours to assist the Controller in meeting its obligations); and
- (iv) the Processor complies with any reasonable instructions notified to it in advance by the Controller with respect to the Processing of the Personal Data; and
- at the written direction of the Controller, delete or return Personal Data (and any (e) copies of it) to the Controller on termination of the Contract unless the Processor is required by Law to retain the Personal Data.
- Subject to paragraph 8 of this Joint Schedule 11, the Processor shall notify the 7. Controller immediately if in relation to it Processing Personal Data under or in connection with the Contract it:
- receives a Data Subject Access Request (or purported Data Subject Access (a) Request);
- receives a request to rectify, block or erase any Personal Data; (b)
- receives any other request, complaint or communication relating to either (c) Party's obligations under the Data Protection Legislation;
- receives any communication from the Information Commissioner or any other (d) regulatory authority in connection with Personal Data Processed under the Contract:
- receives a request from any third Party for disclosure of Personal Data where (e) compliance with such request is required or purported to be required by Law; or
- becomes aware of a Personal Data Breach. (f)
- The Processor's obligation to notify under paragraph 7 of this Joint Schedule 8. 11 shall include the provision of further information to the Controller, as details become available.
- 9. Taking into account the nature of the Processing, the Processor shall provide the Controller with assistance in relation to either Party's obligations under Data Protection Legislation and any complaint, communication or request made under paragraph 7 of this Joint Schedule 11 (and insofar as possible within the timescales reasonably required by the Controller) including by immediately providing:
- the Controller with full details and copies of the complaint, communication or (a) request;
- such assistance as is reasonably requested by the Controller to enable it to (b)

- comply with a Data Subject Access Request within the relevant timescales set out in the Data Protection Legislation;
- (c) the Controller, at its request, with any Personal Data it holds in relation to a Data Subject;

- assistance as requested by the Controller with respect to any request from the (e) Information Commissioner's Office, or any consultation by the Controller with the Information Commissioner's Office.
- 10. The Processor shall maintain complete and accurate records and information to demonstrate its compliance with this Joint Schedule 11. This requirement does not apply where the Processor employs fewer than 250 staff, unless:
- the Controller determines that the Processing is not occasional; (a)
- the Controller determines the Processing includes special categories of data (b) as referred to in Article 9(1) of the UK GDPR or Personal Data relating to criminal convictions and offences referred to in Article 10 of the UK GDPR; or
- the Controller determines that the Processing is likely to result in a risk to the (c) rights and freedoms of Data Subjects.
- The Processor shall allow for audits of its Data Processing activity by the 11. Controller or the Controller's designated auditor.
- The Parties shall designate a Data Protection Officer if required by the Data 12. Protection Legislation.
- 13. Before allowing any Subprocessor to Process any Personal Data related to the Contract, the Processor must:
- notify the Controller in writing of the intended Subprocessor and Processing; (a)
