# A. Description of works

#### Overview

Woodley town council are inviting tenders for the installation of a complete CCTV surveillance system in Woodley Town Centre. The system will provide high quality image recording of identified areas with a wireless link to the Oakwood Centre building, where the recording unit will be situated. Appropriate software applications will be included for file sharing and remote viewing. Details of aftercare support, call out and maintenance information should also be included.

Camera coverage will include the main precinct area and some areas of adjoining road/pathways access areas.

We will require all works to meet the current regulations and standards and it must be stated in the tender submission how the proposal meets these requirements.

The Council intends to enter into a formal contract with the successful tenderer. This will be a JCT minor works with contractor's design.

#### <u>Technical requirements</u>

<ul> <li>Network video recorder with appropriate hard drive</li> <li>Appropriate wireless transmitter/receiver connection to town centre cameras</li> </ul>
Access to images via app for remote viewing
<ul> <li>Appropriate high quality cameras at locations to provide maximum coverage of defined areas. This includes the main precinct area and side road/walkway access points.</li> </ul>
<ul> <li>Cameras to be mounted on existing lamp columns where possible – not building mounted.</li> </ul>
Service/support package
<ul> <li>Speaker located at each camera providing audio connection from The Oakwood Centre. Capability to provide motion activated audio warning of CCTV surveillance and real-time audio connection from Oakwood Centre.</li> </ul>

# B. The site

Woodley Town Centre – shopping precinct Woodley Berkshire Grid reference:

Easting /Northing 476148 173191

The site is a mostly pedestrianised shopping precinct with a disabled car park area, children's play area, performance stage and walled garden. The site is not owned by the Town Council – it is owned by Wokingham Borough Council and permissions will be obtained to carry out the installation.

# C. Pricing

- detailed system specification and manufacturer information
- details of compliance with the appropriate British Standards relating to CCTV surveillance systems for public spaces
- Lead time and indication of potential start date and install duration
- Details of support, call out and ongoing maintenance
