2. GOODS AND SERVICES REQUIREMENTS

(2.1) Goods and/or Services **PURPOSE**

NHS Northamptonshire ICB GPIT estate has 222 End of Life (EOL) Wireless Access Points (WAPs) and some areas without Wi-Fi coverage. A project has been commissioned with NHS AGEM CSU to undertake replacements and improvements and a third-party provider is required to support the project.

BACKGROUND TO THE AUTHORITY

NHS AGEM CSU IT is contracted by NHS Northamptonshire ICB to provide IT infrastructure and support to all general practices across Northamptonshire estates, which consist of over 92 practice sites including branch sites.

BACKGROUND TO REQUIREMENT/OVERVIEW OF REQUIREMENT

As part of Wi-Fi Service Improvement Programme, Northamptonshire ICB have just finalised Phase 1 and have now commissioned AGEM CSU to undertake the project management of Phase 2.

Phase 2 has a requirement for a potential provider to provide the following services:

- Undertake surveys to locate all existing WAPs in the estate.
- Refreshing the EOL WAPs at GP practices.
- Following refresh undertake heat map reports to give coverage details at each site.
- Recommend Wi-Fi service improvement for any areas with limited or no coverage at each site.
- Provide asset list and WAP locations for each GP site.
- 6 month timeline.

THE REQUIREMENT

AGEM CSU will require a potential provider to provide resources and software to undertake the following:

- Potential provider to provide a project lead and attend project planning meetings with AGEM as per requirements.
- Potential provider to work with AGEM CSU project team to schedule visits to GP practice sites
- Potential provider to liaise and communicate with practices and project team to ensure they are kept up to date with progress as necessary.
- Potential provider to undertake survey to locate and record details of WAPs installed at each GP practice site.
- Potential provider to advise on the mounts required to fix the WAPs to wall/ceiling.
- Potential provider resource must have necessary equipment such drills and ladders to be able to install mounting brackets to walls and ceilings as required.
- Potential provider to refresh EOL WAPs this includes the removal of old devices, installation of new mount and device.

- Potential provider to support AGEM CSU project engineer with patching of refresh WAPs to ensure network connectivity.
- Potential provider to support the AGEM CSU project engineer to complete disposal tasks at each site.
- Potential provider must provide heat mapping software to undertake the coverage report.
- Potential provider to produce heat map report of all WAPs installed post refresh at each site within 5 working days to show Wi-Fi coverage at GP practice sites and highlight any black spots areas.
- Potential provider to produce recommendation report for Wi-Fi coverage enhancement for ICB consideration and approvals for each site.
- Potential provider to support AGEM CSU project engineer with UAT testing and troubleshooting network connection issues.
- Potential provider to provide asset list of WAPs with details of installed location.

The Potential provider must be able to

- Undertake the above required work where possible during practices normal working hours.
- Potential provider resource must have undertaken required ladder training.
- Potential provider and resource must have a minimum of 2 years' experience of working within NHS Primary Care sites.
- Potential provider and resource must have a minimum of 2 years' technical experience of providing cabling and Wi-Fi refresh and improvement projects.
- Potential provider resources must be flexible and adaptable to practices changing priorities whilst working in practice reducing impact to clinical areas.
- Potential provider must have Health & Safety processes in place to working at heights and maintenance work.
- The potential provider needs to be available to start the project immediately and complete within 6 months of being commissioned.
- Initial project kick-off meeting to be agreed ASAP and held within 7 days of completing the procurement.

AGEM CSU will provide onsite project engineer to support configuration and testing of WAPS to ensure network connectivity and internet access via approved wireless connections.

- Replacement or upgrade of POE network switches.
- Remediation of network infrastructure faults unrelated to Wi-Fi project.

Project engineer will be the projects point of contact at each site and responsible for configuring the WAPs, undertaking UAT and troubleshooting as required.

Potential provider to provide a fortnightly HLR report of progress to date, next planned work, outstanding tasks and update against risks, issues and milestones.
