Somerton Town Council appreciate receiving a fixed price quote for each of the sections detailed below.

	THE SPECIFICATION FOR MAINTENANCE FOR SOMERTON CEMETERY
1	Regular cutting of grass to ensure a tidy appearance at all time, with the grass length not exceeding 5cm
2	Removal of un-slightly grass cuttings on the same day as they are cut.
3	Strimming around the Cemetery boundary to maintain a tidy appearance and minimise invasive weed growth.
4	Strimming where necessary around graves to maintain a tidy appearance.
5	Supply and apply when necessary weed killer to graves and around to maintain the general tidy appearance of the cemetery.
6	Supply and apply when necessary weed / moss killer to paths / driveway to minimise build up of moss / weeds in the gravel.
7	Be aware of current and future legislation regarding chemicals to be used in the cemetery and their application.
8	Cut perimeter hedge cuttings and leave tidy after each cut.
9	Remove all hedge cuttings and leave tidy after each cut.
10	Pruning / cutting of trees where necessary (a) to enhance appearance of cemetery and (b) ensure there are no branches that can pose danger to the public.
11	Contractor to remove dead flowers and old wreaths from graves.
12	Contractor to make tidy graves when they have settled, in filling with top-soil and turfing over. (The time allowed for graves to settle will vary; Contractor will need to consult on any concerns o this nature with the Clerk of the Council who will then refer the matter to the Land & Property Committee).
13	Contractor responsible for the watering, pruning, removal and replacement of dead shrubs in the walls if the "Garden of Rest", (New shrubs provided by S.T.C.).
14	Contractor responsible for monitoring the need for maintenance or repairs to the walls of the "Garden of Rest". (Any agreed maintenance or repair cost to be agreed as a one off contract).
15	Contractor responsible for monitoring the need for maintenance or repair to the benches within the cemetery. (Any agreed maintenance or repair cost to be agreed as a one off contract).
16	Contractor to be responsible for provision of all the tools, protective wear, machinery and fuel fo use by their staff.
17	Contractor to be responsible to empty all litter bins.
18	Contractor to complete a basic topple test to report any memorials that are at risk of toppling over and damage every 6 months. Contractor must report on any issues to the Clerk's office.
19	Contractor to be responsible for all their staff insurances, health and safety legislation including COSHH whilst on S.T.C. property.
20	Contractor must report on any issues brought to their attention by members of the public. (In thi scenario the contractor must report the issue to the Clerk to the Council with immediate effect who will then refer the matter to the Land and Property Committee.).

Condition of Contract:

Somerton Town Council appreciate receiving a fixed price quote for each of the sections detailed below and visually represented in the map attached and subject to the contract terms and conditions.

Section 1:

Maintaining Grass Areas:

The maintenance of the grass areas at the Play Areas at Etsome Terrace, Great Western Lane including the separate tree planted grass area on the same estate, and Parkland Way sites, along with the land at Horsemill Lane, all identified on the locations plan provided.

The grass areas to be mown / strimmed at weekly intervals during the main growing season (March - October) approximately 35 cuts per year, ensuring a tidy appearance at all times with the grass length not exceeding 5cm. All necessary arisings need to be taken off site for disposal.

Section 2:

Rubbish/Litter Clearance

In conjunction with the grass cutting operations to collect and remove and lawfully dispose of all rubbish / litter at the three "play area" sites identified above as well as on the land at Horsemill Lane.

Section 3:

Work to Town Council Controlled Car Parks

<u>Unicorn, Brunel, Paddock House, Cox's Yard: due for expansion, and Market Place Car Park with the addition during the tendering period the addition of a Yarlington Car Park and The Half Moon Car Park.</u>

- Weed and tidy around base trees, disposing of arising.
- Sweep guttering of car parks, disposing of all litter / rubbish collected.


The work to the bases of the trees to be at least monthly.
