# **Background to Natural England**

Natural England (NE) is the Government's advisor on the natural environment. It provides practical advice, grounded in science, on how best to safeguard England's natural wealth for the benefit of everyone. Natural England's remit is to ensure sustainable stewardship of the land and sea so that people and nature can thrive. It is our responsibility to see that England's rich natural environment can adapt and survive intact for future generations to enjoy.

# **Background to the G7 Legacy Project for Nature Recovery**

The G7 Legacy Project for Nature Recovery (G7 LPNR) was announced by the Prime Minister at the G7 Summit in June 2021, as an ambitious nature recovery project looking to deliver a lasting legacy for nature, climate and people in Mid-Cornwall. Maps can be found in **Annex 1** 

The project is run and delivered by Natural England (NE), in its capacity as an armslength body of the Department for Environment, Food and Rural Affairs, and Cornwall Wildlife Trust (CWT). Defined as a 5-year project, the aims are ambitious and look to creating new nature rich places, restoring sites, species and landscape and engaging and empowering communities to work with nature for health wellbeing and future resilience. This is a legacy project and is looking to ensure sustainable nature recovery for years – not just the life of the G7 project.

During its first year, G7 LPNR funded 26 projects all of which will contribute to the overall objectives. These projects include social prescribing, marine bycatch reduction research, improved access to nature for communities, habitat restoration, no fence livestock trials and marine mapping. A further 10 projects are currently being funded in the 2<sup>nd</sup> year.

In June 2022, the G7 project aligned with the other 5 landscape-scale nature recovery projects set up by Natural England to drive nature recovery as part of its key shifts in the under the 2021/22 <u>Action Plan</u> and as part of the commitment in the <u>25 Year</u> <u>Environment Plan</u>.

Note also that Cornwall is an area that has a draft Local Nature Recovery Strategy.

The G7 project area is a flagship example of a varied mosaic landscape with a variety of landowners and land use. We would like to use this area for a case study on BNG as a driver for landscape scale conservation.

#### The key deliverables for this contract will be:

- Production of a <u>'Farm Scenarios Report'</u> summarising different approaches to BNG Unit provision, using minimum three case study farms typical of the project study area, outlining scenarios showing current baseline unit provision, maximum unit gain and best habitat unit gain ('right habitat in the right place')
- Produce a <u>'Landscape Analysis'</u> using the outcomes from the Farm Scenarios to estimate the extent and type of likely gain from BNG ie type of habitat creation or enhancement; and also to scope out potential for Statutory Credit projects
- Deliver the <u>Final Report</u> appraisal of the process, analysis of outcomes and recommendations for Natural England and G7 Project Leads, next steps for Statutory Credit project opportunity scoping.

## **Specification of Requirements**

This section sets out the contract requirements. Suppliers must explain how they will deliver the required outputs within the specified timeframe and to budget. They must further demonstrate that they have the required skills and experience. Information on how this will be evaluated can be found below under Quotation Submission.

This study will consider two mechanisms of BNG – the delivery of BNG through habitat creation and/or enhancement for the Biodiversity Offsetting market (ie where developers need to find off sites to deliver Net Gain away from the development location), and the Statutory Credits system (where the developer purchases Statutory Credits in lieu of delivering Net Gain – this fund is then used to finance stand-alone projects). It will use the G7 Nature Recovery Project as a landscape-scale case study, to see if a) using the latest version of the BNG metric, it is feasible to appraise the size of the opportunity that BNG presents for landowners in order to enable more useful consultation and engagement, and b) it is possible to gauge the contribution that BNG could make to progress towards nature recovery, green infrastructure and habitat creation targets.

The findings of this study will inform engagement and discussions with stakeholders, future project planning for investment readiness for nature recovery, and any need for more data and evidence gathering at the landscape scale.

#### **Deliverable 1 – Farm Scenarios Report**

Investigating different BNG Unit scenarios using representative case study farms in the project area will help in understanding the role that BNG might be able to play at

a landscape scale in delivering/incentivising habitat creation/management and nature recovery. Not just in the scale of the opportunity (eg how many hectares of land could BNG income be a driver for?) but also the specific types of land use and land management change that BNG could encourage.

For example, BNG might be an ineffective tool for incentivising creation of complex habitats like lowland heath, but very effective in encouraging enhancement of condition of neutral grassland. This will aid in placing BNG as a tool into perspective alongside other opportunities such as private finance, Agri-Environment, carbon credits etc – where BNG could play a role and where it will be less effective. Using case study farms from the project area will assist in conversations with landowners and farmers as it will demonstrate recognisable scenarios.

Assumptions that may need to be made will be the existing baseline BNG unit provision on a farm – this may need extrapolating from existing baseline data (ie conversion of phase 1 survey to UK Habitat categories), and also the optimal habitat opportunity for land parcels on the holding, but this can be derived from various data sources in consultation with the G7 project team.

This stage could also identify opportunities for habitat creation and restoration on a farm holding that aren't appropriate or viable through BNG, but might be more appropriate for the Statutory Credits mechanism.

#### Deliverable 2 – Landscape Analysis

The aim of the Landscape Analysis deliverable is to see if it is viable to extrapolate the learnings & assumptions from the farm outcomes (ie *this habitat shift is where BNG is effective & appropriate on these farms*) to the landscape scale, given the aims for habitat creation and management of the G7 Project. For example, if it has been shown that in general BNG is an effective mechanism for enhancement of neutral grassland habitat condition, what is the scale of the opportunity for that shift at the landscape-scale, and can we start engaging with a potential farmer cluster about the possible size of the habitat bank? E.g. providing 200 BNG units here in a cluster of 20 holdings... the learning from this stage will help us to engage with landowners in long-term business planning.

Building on the outputs of the Farm Scenarios, using available data for the project area, and stating assumptions made, this will test whether this is a robust and viable analysis to carry out for landscape-scale projects.

#### **Deliverable 3 – Final Report**

The Final Report will summarise all the assumptions made, the limitations, strengths and weaknesses of the methodology, the headline findings of the farm scale report with reference to positive habitat change opportunities both through 'normal' BNG and Statutory Credits mechanisms, the lessons learned for NE and G7 Project,

recommendations for messages to share with stakeholders and interested parties, for future communication/advice/interventions around Biodiversity Net Gain that would maximise positive outcomes for nature recovery and G7 Legacy project aims and avoid potential negative impacts for biodiversity and landscape; and next steps – for example how to assess what support might be needed to progress opportunities for Statutory Credits projects to a stage where they are investment-ready.

# **Contract Management**

All reports will be clearly presented, concise, written in plain English with a target audience of an educated lay person. Reports will be supplied by email in Microsoft Word 97-2003 and pdf formats.

It is NE's expectation that all final project reports are published, NE however reserves the right to determine if and how results should be published.

We will raise purchase orders to cover the cost of the services and will issue to the awarded supplier following contract award.

Payment can be made in two instalments, with 25% to be invoiced upon receipt of the inception note, and the remaining 75% to be invoiced upon agreement of the final deliverables.

# **Prices**

Prices must be submitted in  $\pounds$  sterling, inclusive of VAT. Prices must be submitted in an Excel spreadsheet. Bidders should note that as a guide the anticipated budget is  $\pounds$ 20K inclusive of VAT. This should be used as a guide to give an indication of the depth and breadth of the study and the resources required to complete the work.

It is anticipated that this contract will be awarded for a period of 3 months, with work substantially completed by 31<sup>st</sup> March 2023 Prices will remain fixed for the duration of the contract award period.

# **Quotation Submission**

Completed submissions should include the following items:

- evidence that you meet the quality criteria set out in the specification.
- your proposed pricing structure (to include name of staff, grade, day rate and total number of days allocated to each task and deliverable).
- your proposed workplan for the project
- Details of anything you need from the G7 project team to enable delivery.

Submissions will be reviewed and then evaluated as set out below:

- each criterion will be given a score from 0 to 100.
- the criteria scores will be weighted to create a final submission score.
- all of the final submission scores will be ranked.
- the field date will be confirmed.
- the agency with the highest weighted score for the chosen field date will be awarded the contract subject to the terms and conditions within the RFQ.

If the start date of the contract should substantially change, then agencies will be asked for their availability in the order of ranked final submission score. We will award

this contract in line with the most economically advantageous tender. Suppliers will be scored on price and quality:

- Price 50%
- Quality 50%


# **General Data Protection Regulations 2018**
