# CONTRACT FOR: Fund Manager for The Global Poverty Impact Fund (GPAF)

### **CONTRACT NUMBER: PO 5543**

With reference to the contractual letter dated 15<sup>th</sup> December 2010 as most recently amended by the letter dated 16<sup>th</sup> May 2014 whereby your firm Triple Line Consulting Limited (in a joint venture with Crown Agents Limited) was engaged to carry out the Terms of Reference as detailed in Section 3 therein, I confirm that the UK Government wishes to make the following further amendments to the contract:

### Section 1 – Form of contract

### Para 3: Commencement and duration of the services

Delete the current End Date of "31<sup>st</sup> March 2015" and INSERT "31<sup>st</sup> August 2015".

### Para 4: Financial Limit

DELETE the current paragraph which states "Payments under this contract shall not, in any circumstances exceed £5,063,574.20 exclusive of any government tax" and INSERT "Payments under this contract shall not, in any circumstances exceed £7,161,315.20 exclusive of any government tax"

### Section 3 – Terms of Reference

DELETE in toto the current Section 3 – Terms of Reference and REPLACE with the attached updated version

# Section 5 – Schedule of Prices

**DELETE** "Section 5, Schedule of Prices" in toto and **INSERT** "Section 5, Schedule of Prices" attached inclusive of Annex 2 and Annex 3.

2. These amendments relate to:

- An increase in the financial limit by £2,097,741.
- An extension to the contract end date of 5 months.
- The insertion of a revised Section 3 Terms of Reference
- The insertion of a revised Section 5 Schedule of Prices
