With reference to the Call-Off Contract between (1) **Netacea Limited** and (2) **NHS Digital** which commenced on 12 November 2020 as amended by Contract Amendment No: 01 dated 8th December 2020 and Contract Amendment No: 02 dated 21st September 2021 and Contract Amendment No: 03 dated 4th March 2022, both Parties have agreed to the following variation to the Call-Off Contract even though it is procured as a **Single Tender Award**.

The Call-Off Contract term will be extended for 6 months on a monthly rolling basis such extension to take effect on 12th October 2022 and end on 11th April 2023.

Reason for proposed change

The Buyer wishes to amend the scope of the Agreement, by adding up to 6 months of service platform on a rolling monthly service with 30 days termination notice.
