Department for Education, of Sanctuary Buildings, Great Smith Street, London, SW1P 3BT (hereinafter referred to as "**the Buyer**") & **Wonde Limited (08645640)** whose registered office is situated at 2 Kings Court, Newmarket, Suffolk, CB8 7SG (hereinafter referred to as "**the Supplier**")

1. The Contract is varied as follows:

1) The current end date of 16th January 2023 shall be extended to **16th January 2024**.

2) The total maximum contract value will be: **£570,000** excluding VAT. The upper limit to the value of this contract is hereby increased from £270,000 to £570,000 excluding VAT.

Services to be delivered in extension period: Further to the services agreed in the original order form signed 17th January 2022, [REDACTED] will form part of the requirements at a cost of an additional [REDACTED] per school per month as detailed in the tables below. The parties agree that the pricing below shall come into effect for existing approved schools at the point the Buyer requests such additional data fields through the Buyer's Wonde dashboard regardless of whether such school has approved the additional data fields. For all new schools, the pricing below will be the default pricing going forward
