Background

The Economic and Social Research Council (ESRC) is part of UK Research and Innovation (UKRI), an organisation that brings together the UK's seven research councils, Innovate UK, and Research England to maximise the contribution of each council and create the best environment for research and innovation to flourish. The ESRC is the UK's largest organisation for funding research on economic and social issues. It supports independent, high-quality research which has an impact on business, the public sector and civil society.

Research using administrative data has the potential to transform public services and increase productivity and innovation. The enormous volume and complexity of administrative data that is now being collected by government departments as a by-product of service delivery represents a significant resource within the UK which can be used to the mutual benefit of academic research, government, and society as a whole.

Following recommendations from an independent report in 2012, and approval of ring-fenced funding from BEIS. ESRC funded the £44m Administrative Data Research Network (ADRN) for a period of five years from 2013. The ADRN, which came to an end in autumn 2017, brought together experts from all over the UK to organise an infrastructure to allow social researchers to use administrative data in a safe setting, with the proper security measures in place. At the time, the ADRN was a new and innovative approach to a complex challenge and had mixed results. Where it was successful, particularly in the devolved administrations, it helped to confirm the great potential of using administrative data to deliver valuable research outputs to inform and change public policy and practice, improving outcomes.

In 2018, following consideration of the lessons learned, and discussions with a wide range of relevant stakeholders, including key leaders in this field, the ESRC developed a new pilot model for further investment in administrative data - Administrative Data Research UK (ADR UK). The pilot model, covering the period 2018-2021, incorporated significant changes. including a much more strategic approach, clearer leadership, the funding of devolved administrations and government departments, a partnership with the Office for National Statistics (ONS) in addition to funding for academic teams (Figure 2). Following the success of this pilot, in 2020 and 2021, BEIS and HMT approved £105m of further funding for a longterm investment into ADR UK, up to March 2026.




Figure 1. The ADR UK partnership structure

ADR UK is contributing to the UK becoming a global leader in big data infrastructure. ADR UK is working in partnership with ONS, the devolved administrations and a range of academic teams to strategically source and curate linked administrative data from UK and devolved government departments and make this securely accessible to researchers. In turn, ADR UK is driving the delivery of high-quality research and impact around prioritised policy themes in each of the four UK nations.

Access to administrative data is extremely valuable to research, facilitating a far more accurate and comprehensive picture of UK society than is possible without it. However, the greatest benefits from the use of administrative data for research come when data created by one government department or public service is linked to that from others. Linking data from across government is the essence of ADR UK's work. It enables researchers to study how different aspects of life interact with one another, enhancing our understanding of UK society and highlighting where change is needed to improve lives.

Academics and other researchers spend significant amounts of time and money on primary data collection. Access to administrative data can therefore be a major time and money saver, allowing researchers to use rich data that has already been collected and to invest greater resources elsewhere in the research process.

ADR UK also funds training and capacity building activities, including a cohort of PhD students and training courses on datasets to build up researchers' skills in utilising administrative data.




Figure 2. The ADR UK process

Existing evidence suggests that administrative data research has positive impacts in improving the lives of people. ADR UK's ultimate goal is to improve public service provision across the UK by enabling administrative data research that offers new and valuable insights into society and creates real-world change that makes a positive impact to life across the four nations. To accomplish this, ADR UK's efforts focus on achieving the following strategic objectives:

- Trust and sustainability: Build acceptance in government of the need to release data and lay foundations for a sustainable research resource by focusing on addressing major societal challenges.
- Research for public good: Deliver measurable public good for people with demonstrable impact arising from administrative data research that addresses UK's major societal challenges.
- Researcher access and support: Provide a seamless, transparent, coordinated, and secure researcher service that provides timely access to administrative data and support services for the wider research community to inform policy.
- Available data for research: Provide a highly useful long-term research resource, with high-quality, research-ready administrative data available to address major societal challenges and preserved for future reuse by researchers.

Aims and objectives of the study

The ESRC wants to procure an independent mid-term economic evaluation of the ADR UK programme. The overall aim of this work is to assess to what extent this investment has progressed in creating intended changes to achieve its strategic outcomes. After three years of implementation following the successful pilot phase, it is relevant to analyse ADR UK's added value towards transforming the use of public sector data in the academic and policymaking sectors. We also want to identify any learnings from delivery approach and processes to date.

Evaluation objectives are:

- Understanding to what extent ADR UK is delivering as intended and progressing in achieving its strategic outcomes as well as its economic benefits and social impacts.
- Learning what has and has not worked well in the implementation and delivery of ADR UK, including an articulation of the reasons, good practices that have been developed, and main bottlenecks.
- Providing recommendations on methods for the final impact evaluation (in 2026) and any additional metrics or other data that ADR UK should be collecting to facilitate this.

The starting point for this mid-term evaluation should be ADR UK's existing Theory of Change (ToC)¹ and corresponding monitoring and evaluation plan that identifies measurable outputs and outcomes. ADR UK have been regularly collecting monitoring information against a number of these output and outcome indicators and this information will be made available to the successful supplier. The first step for the evaluator will therefore be to validate (and potentially refresh) the ToC and identify gaps in the monitoring and outcome data that is required to address the evaluation objectives. These gaps will need to be filled through new data collection, likely including at a minimum consultation and / or surveys with key stakeholders and bibliometric analysis. In particular, we are keen to ensure that we have robust data around quantitative measurements of ADR UK's progress in achieving its outcomes, conduct counterfactual analyses to assess impacts, inform and guide the final impact evaluation at the end of the investment, and improve the general delivery and monitoring processes.

The proposed work should be able to answer the following evaluation questions.

Objective 1.

- According to the theoretical model, is ADR UK delivering the expected changes in transforming the access to public data and the use of research for policymaking? Are the assumptions still valid for the rest of the implementation period?
- Is the Theory of Change reflecting the way in which ADR UK should be enabling government to make policy that supports economic growth and better public services to improve people's lives?
- To what extent and how has ADR UK increased trust and sustainability among stakeholders in the need to release data?
- To what extent and how has ADR UK increased research to deliver measurable public good with demonstrable impact in addressing major societal challenges?
- To what extent and how has ADR UK increased researcher access and seamless service support?
- To what extent and how has ADR UK increased the availability of useful long-term and research-ready resources to address societal challenges?

- What knowledge, economic and social impacts from ADR UK can be evidenced from case studies?
- Are there any unintended spillovers, externalities or outcomes that were not expected as part of the implementation of ADR UK that are relevant to consider for future funding?

Objective 2.

- What elements of ADR UK's processes and implementation plan have worked well in influencing policy and what elements have room for improvement and how?
- What are the main bottlenecks researchers, data owners and policymakers have encountered to produce and use research outputs to address major societal challenges?
- How effective has ADR UK been in collecting monitoring information to inform the delivery process?
- How effective has ADR UK been in engaging with policymakers (Whitehall departments and devolved administrations) to link administrative data across sectors and geographies, make it available and use research outputs for public policy?
- How effective has ADR UK been in interacting with researchers to use public data to create knowledge and engage in partnerships to influence policymaking?
- To what extent will ADR UK's impact be sustained beyond its initial period of implementation, and what factors may influence or limit this?
- Considering the Critical Success Factors, how effective has ADR UK been in promoting the service and interacting with data owners and the research community?

Objective 3.

- To what extent are the current indicators in the ADR UK's monitoring and evaluation plan pertinent to measure the outcomes and impacts of the investment?
- To what extent is the data collected by ADR UK relevant and sufficient to assess the economic and social impacts of the programme?
- What evidence needs to be collected for ADR UK to be able to measure the economic and social impacts and which tools would be the most feasible to use?
- What is the feasibility of conducting a counterfactual analysis to measure the outcomes and impacts of ADR UK and what are the necessary conditions to perform it?

Approach and methodology

Approach

The mid-term evaluation requires a mix of process and impact evaluation of ADR UK's threeyear implementation. It is expected that this independent study would be comprised of three stages:

1. Review and validation of ADR UK's Theory of Change

The ESRC team has performed an initial review of the Theory of Change to analyse the theory connecting the activities and outputs of the programme with its outcomes

and final impacts. This included a refreshed set of indicators to measure the progress of the investment. It would be appropriate for the independent evaluator to first review and update, in coordination with ESRC'S ADR UK and Evaluation Teams, the suggested updates to the Theory of Change and related indicators, as well as the validity of current assumptions.

This first stage requires the evaluation supplier to:

- Review key documents related to ADR UK design and implementation of the last three years.
- Engage with the ADR UK and the Evaluation team to discuss, validate and/or suggest changes to the ToC or related indicators.
- Review and refine outcome and impact indicators that will enable us to measure whether ADR UK is achieving its intended outcomes and impacts. Indicators where a counterfactual analysis is possible should be prioritised.
- Propose approaches for robustly assessing impact, including identifying any outcomes that could be viably considered through a counterfactual assessment.
- Provide a clear detail of the nature of data needed to measure the chosen indicators, the conditions required for that, and anticipated alternatives when they are not possible to collect.
- Undertake a baseline review against the outcome and impact indicators agreed through the theory of change and validate their robustness.
- 2. Collection of new data required to robustly measure outcomes and evaluate the final impact of ADR UK

Drawing on findings from the first stage of the evaluation conducted by the independent evaluator would validate the relevance and need of identifying and defining additional sources of information to measure the outcomes and impacts of stage 1. It is expected that the supplier outlines the nature of this new evidence, identifies the processes to gather them, the main actors involved, related timelines, and the necessary conditions to make it sustainable beyond the current period of implementation.

This second stage requires the evaluation supplier to:

- Identify potential additional data sources to measure the indicators defined in Stage 1 prioritising those that could be used for a counterfactual analysis if possible.
- Suggest any improvements to ADR UK's data collection including an analysis
 of the most feasible methods to gather the evidence as well as the timeframe
 and a list of potential participants to take part in the process.
- Develop an analytical framework that will guide the collection and analysis of qualitative data through interviews, focus groups or other suitable tools.
- Develop questionnaire(s) to collect quantitative data with inputs of the ADR UK and Evaluation Teams.
- Engage with the ADR UK and Evaluation Teams to make sure there is a common understanding of how this evidence collection approach is sustainable and could be used or replicated for the final impact evaluation.

3. Analysis of ADR UK progress in achieving its outcomes and proposal of a final impact evaluation approach

This stage should collate and analyse data reviewed and collected through the evaluation's first stages to answer the evaluation guestions.

This third stage requires the evaluation supplier to:

- Conduct quantitative and qualitative analyses with the existing and new available information to evaluate to what extent ADR UK is achieving its intended outcomes and generating impact.
- Analyse the impact of a relevant set of case studies highlighting illustrative examples of sector impacts achieved through the investment.
- Propose approaches to estimate the economic and social impacts of ADR UK in the final evaluation and future funding scheme.
- Propose a set of research questions to guide the final economic and social impact evaluation of ADR UK, as well as recommendations for data collection to deliver the impact assessment.
- Inform decisions about the ongoing and future sustainability of ADR UK and how this investment scheme can support better engagement of policymakers and researchers to generate and use linked data to address policy issues.

Methodology

As the study is being conducted halfway through implementation, we expect the successful evaluator to first understand the main aspects, processes and initial results of the investment. For that, ESRC will make available the data and information generated by ADR UK during the three years of implementation, including outputs of the design process. This will assist the mid-term evaluation throughout the three stages outlined in the previous section and will be comprised at least of:

- ADR UK's final business case and annexes (e.g. Theory of Change, Strategic Case, Economic Appraisal, Monitoring and Evaluation plan, among others).
- Annual reports
- Up-to-date data on the delivery and monitoring indicators (when available)
- Database of the case studies directly and indirectly funded by ADR UK
- A list of useful contacts as a starting point for potential interviews
- Any other relevant report on ADR UK or their partnerships

Based on this and the previous analysis performed by the ADR UK and Evaluation Teams for the current procurement, the independent evaluator should propose a research approach and design that address the aim and research questions of the mid-term evaluation considering the suggested three stages. The mid-term evaluation should be undertaken in line with the broad principles set out in the Government's overarching appraisal, evaluation and quality-assurance frameworks as represented by the Green and Magenta Book, as well as the UKRI and ESRC's Monitoring and Evaluation frameworks.

We suggest the following evaluation approaches and methods to guide the mid-evaluation study:

a. Theory-based approach

This method explores the causal chain thought to create change by an investment in a certain context and by what means these changes occurred. Even though it does not provide precise estimates of the effect sizes, it is useful to determine if the actions within the intervention had an effect in the desired direction. This approach could use contribution analyses based on exploring evidence to examine if the investment's activities have contributed to observed outcomes in the Theory of Change.

b. Quasi-experimental approach

Statistical research methods would provide more robust impact evaluation results as intends to assess whether an impact has occurred or not using a counterfactual: observed outcomes from a group that did not receive the intervention/benefit of the investment, which can be compared to outcomes from the group that did receive it. This approach mostly relies on the quality and availability of systematic and comparable data to rigorously measure and quantify the impacts. Using this approach and the different methods and assumptions, would enable us to attribute any measured change to the investment.

c. Case study method

Case studies involve focusing in depth on a subset of an impact population that have been the recipients or beneficiaries of an investment (e.g. research projects) and provides a greater insight into outcomes and impacts This method may also collect quantitative data to assess impact and works well in combination with or supplementing other ones. Its findings can capture real-life situations in detail and help understand complex phenomena. However, careful consideration should be given to potential sample bias and generalise its findings to different context, as well as the criteria used to select cases in a context where they are used to communicate to stakeholders what has and has not worked.

d. Bibliometric analysis²

This approach consists of a quantitative analysis of scientific and scholarly publications and collaborations. This could provide supplementary information about research outputs and enables us to evaluate the impact of research schemes by assessing the productivity and influence of the research papers emerging from them, and how these have changed over time. Through benchmarking, we can also assess the relative citation impact of research papers relative to, for example, their research field or expected citation rate.

Where bibliometrics are used, authors should: clearly set out the source of all data and calculation methods used to support their assessments; appropriately account for variations and availability of information by field; and ensure these processes are transparent and accessible to those being evaluated.

It is anticipated that this study will require a combination of methods and analytical techniques which should be appropriately defined and clearly explained on the reasons of selection against answering the evaluation questions. We expect that any additional data

collection led by the independent evaluators will take into account what is already available and be designed to minimise extra burden on Whitehall departments, devolved administrations, Research Organisations, ONS, and/or ESRC, among others. They should also set out any proposed issues and be explicit on any limitations likely in answering the stated research questions. Where surveys, interviews, focus groups or other information collection methods are proposed, suppliers should explain the modality (e.g. online, inperson, paper-based, among others), define expected sample sizes, how they will be chosen, who will these include, and how responses will be maximised.

Evaluation suppliers are invited to outline how the mid-evaluation will be conducted in accordance with relevant data protection and security standards, including how they will safely store, use and destroy contact details of stakeholders, documentary sources shared about ADR UK and the additional information collected for reviewing purposes. ESRC will work together with the evaluation supplier to agree on a structure of the reports. Complementary deliverables include frameworks, questionnaires, datasets, any relevant estimations on analytical spreadsheets, programming files, and presentations.

Suppliers should also allow for an inception meeting and regular progress meetings. They should provide a summary of emerging findings from the quantitative and qualitative data collection work and analyses, followed by a presentation of initial findings. A final presentation to the ADR UK and Evaluation Teams is also expected end of October 2024.

Project management and quality assurance

The successful supplier will be expected to identify one named point of contact through whom all enquiries can be filtered. Where a consortium or sub-contractors are in place, ESRC-UKRI expects that they are included in relevant meetings and review points to ensure their full engagement in the project.  - (b) provide information to the Relevant Authority or to the Auditor and reasonable co-operation at their request.
- 6.5 Where the Audit of the Supplier is carried out by an Auditor, the Auditor shall be entitled to share any information obtained during the Audit with the Relevant Authority.
- 6.6 If the Supplier is not providing any of the Deliverables, or is unable to provide them, it must immediately:
 - (a) tell the Relevant Authority and give reasons;
 - (b) propose corrective action; and
 - (c) provide a deadline for completing the corrective action.
- 6.7 The Supplier must provide CCS with a Self Audit Certificate supported by an audit report at the end of each Contract Year. The report must contain:
 - (a) the methodology of the review;
 - (b) the sampling techniques applied; (c) details of any issues; and (d) any remedial action taken.
- 6.8 The Self Audit Certificate must be completed and signed by an auditor or senior member of the Supplier's management team that is qualified in either a relevant audit or financial discipline.

7. Supplier staff

- 7.1 The Supplier Staff involved in the performance of each Contract must:
 - (a) be appropriately trained and qualified;
 - (b) be vetted using Good Industry Practice and the Security Policy; and
 - (c) comply with all conduct requirements when on the Buyer's Premises.
- 7.2 Where a Buyer decides one of the Supplier's Staff is not suitable to work on a contract, the Supplier must replace them with a suitably qualified alternative.
- 7.3 If requested, the Supplier must replace any person whose acts or omissions have caused the Supplier to breach Clause 27.

- 7.4 The Supplier must provide a list of Supplier Staff needing to access the Buyer's Premises and say why access is required.
- 7.5 The Supplier indemnifies CCS and the Buyer against all claims brought by any person employed by the Supplier caused by an act or omission of the Supplier or any Supplier Staff.

Rights and protection

8.

- 8.1 The Supplier warrants and represents that:
 - (a) it has full capacity and authority to enter into and to perform each Contract;
 - (b) each Contract is executed by its authorised representative;
 - (c) it is a legally valid and existing organisation incorporated in the place it was formed;
 - (d) there are no known legal or regulatory actions or investigations before any court, administrative body or arbitration tribunal pending or threatened against it or its Affiliates that might affect its ability to perform each Contract;
 - (e) it maintains all necessary rights, authorisations, licences and consents to perform its obligations under each Contract;
 - (f) it does not have any contractual obligations which are likely to have a material adverse effect on its ability to perform each Contract;
 - (g) it is not impacted by an Insolvency Event; and (h) it will comply with each Order Contract.
- 8.2 The warranties and representations in Clauses 2.10 and 8.1 are repeated each time the Supplier provides Deliverables under the Contract.
- 8.3 The Supplier indemnifies both CCS and every Buyer against each of the following:
 - (a) wilful misconduct of the Supplier, Subcontractor and Supplier Staff that impacts the Contract; and (b) non-payment by the Supplier of any Tax or National Insurance.
- 8.4 All claims indemnified under this Contract must use Clause 26.
- 8.5 The description of any provision of this Contract as a warranty does not prevent CCS or a Buyer from exercising any termination right that it may have for breach of that clause by the Supplier.
- 8.6 If the Supplier becomes aware of a representation or warranty that becomes untrue or misleading, it must immediately notify CCS and every Buyer.
- 8.7 All third party warranties and indemnities covering the Deliverables must be assigned for the Buyer's benefit by the Supplier.

9. Intellectual Property Rights (IPRs)

9.1 Each Party keeps ownership of its own Existing IPRs. The Supplier gives the Buyer a non-exclusive, perpetual, royalty-free, irrevocable, transferable worldwide licence to use, change and sub-license the Supplier's Existing IPR to enable it to both:

- (a) receive and use the Deliverables; and
- (b) make use of the deliverables provided by a Replacement Supplier.
- 9.2 Any New IPR created under a Contract is owned by the Buyer. The Buyer gives the Supplier a licence to use any Existing IPRs and New IPRs for the purpose of fulfilling its obligations during the Contract Period.
- 9.3 Where a Party acquires ownership of IPRs incorrectly under this Contract it must do everything reasonably necessary to complete a transfer assigning them in writing to the other Party on request and at its own cost.
- 9.4 Neither Party has the right to use the other Party's IPRs, including any use of the other Party's names, logos or trademarks, except as provided in Clause 9 or otherwise agreed in writing.
- 9.5 If there is an IPR Claim, the Supplier indemnifies CCS and each Buyer against all losses, damages, costs or expenses (including professional fees and fines) incurred as a result.
- 9.6 If an IPR Claim is made or anticipated the Supplier must at its own expense and the Buyer's sole option, either:
 - (a) obtain for CCS and the Buyer the rights in Clause 9.1 and 9.2 without infringing any third party IPR; or
 - (b) replace or modify the relevant item with substitutes that do not infringe IPR without adversely affecting the functionality or performance of the Deliverables.
- 9.7 In spite of any other provisions of a Contract and for the avoidance of doubt, award of a Contract by the Buyer and placement of any contract task under it does not constitute an authorisation by the Crown under Sections 55 and 56 of the Patents Act 1977 or Section 12 of the Registered Designs Act 1949. The Supplier acknowledges that any authorisation by the Buyer under its statutory powers must be expressly provided in writing, with reference to the acts authorised and the specific IPR involved.

10. Ending the contract or any subcontract

10.1 Contract Period

10.1.1 The Contract takes effect on the Start Date and ends on the End Date or earlier if required by Law.

10.1.2 The Relevant Authority can extend the Contract for the Extension Period by giving the Supplier no less than 3 Months' written notice before the Contract expires.

10.2 Ending the contract without a reason

- 10.2.1 CCS has the right to terminate the DPS Contract at any time without reason by giving the Supplier at least 30 days' notice.
- 10.2.2 Each Buyer has the right to terminate their Order Contract at any time without reason by giving the Supplier not less than 90 days' written notice.

10.3 Rectification plan process

- 10.3.1 If there is a Default, the Relevant Authority may, without limiting its other rights, request that the Supplier provide a Rectification Plan.
- 10.3.2 When the Relevant Authority receives a requested Rectification Plan it can either:
 - (a) reject the Rectification Plan or revised Rectification Plan, giving reasons; or
 - (b) accept the Rectification Plan or revised Rectification Plan (without limiting its rights) and the Supplier must immediately start work on the actions in the Rectification Plan at its own cost, unless agreed otherwise by the Parties.
- 10.3.3 Where the Rectification Plan or revised Rectification Plan is rejected, the Relevant Authority:
 - (a) must give reasonable grounds for its decision; and
 - (b) may request that the Supplier provides a revised Rectification Plan within 5 Working Days.
- 10.3.4 If the Relevant Authority rejects any Rectification Plan, including any revised Rectification Plan, the Relevant Authority does not have to request a revised Rectification Plan before exercising its right to terminate its Contract under Clause 10.4.3(a).

10.4 When CCS or the buyer can end a contract

- 10.4.1 If any of the following events happen, the Relevant Authority has the right to immediately terminate its Contract by issuing a Termination Notice to the Supplier:
 - (a) there is a Supplier Insolvency Event;
 - (b) there is a Default that is not corrected in line with an accepted Rectification Plan;
 - (c) the Supplier does not provide a Rectification Plan within 10 days of the request;
 - (d) there is any material Default of the Contract;
 - (e) there is any material Default of any Joint Controller Agreement relating to any Contract;

- (f) there is a Default of Clauses 2.10, 9, 14, 15, 27, 32 or DPS Schedule 9 (Cyber Essentials) (where applicable) relating to any Contract;
- (g) there is a consistent repeated failure to meet the Performance Indicators in DPS Schedule 4 (DPS Management);
- (h) there is a Change of Control of the Supplier which is not pre-approved by the Relevant Authority in writing;
- (i) if the Relevant Authority discovers that the Supplier was in one of the situations in 57 (1) or 57(2) of the Regulations at the time the Contract was awarded; or
- (j) the Supplier or its Affiliates embarrass or bring CCS or the Buyer into disrepute or diminish the public trust in them.
- 10.4.2 CCS may terminate the DPS Contract if a Buyer terminates an Order Contract for any of the reasons listed in Clause 10.4.1.
- 10.4.3 If any of the following non-fault based events happen, the Relevant Authority has the right to immediately terminate its Contract by issuing a Termination Notice to the Supplier:
 - (a) the Relevant Authority rejects a Rectification Plan;
 - (b) there is a Variation which cannot be agreed using Clause 24 (Changing the contract) or resolved using Clause 34 (Resolving disputes);
 - (c) if there is a declaration of ineffectiveness in respect of any Variation; or (d) any of the events in 73 (1) (a) or (c) of the Regulations happen.

10.5 When the supplier can end the contract

The Supplier can issue a Reminder Notice if the Buyer does not pay an undisputed invoice on time. The Supplier can terminate an Order Contract if the Buyer fails to pay an undisputed invoiced sum due and worth over 10% of the annual Contract Value within 30 days of the date of the Reminder Notice.

10.6 What happens if the contract ends

- 10.6.1 Where a Party terminates a Contract under any of Clauses 10.2.1, 10.2.2, 10.4.1, 10.4.2, 10.4.3, 10.5 or 20.2 or a Contract expires all of the following apply:
 - (a) The Buyer's payment obligations under the terminated Contract stop immediately.
 - (b) Accumulated rights of the Parties are not affected.
 - (c) The Supplier must promptly repay to the Buyer any and all Charges the Buyer has paid in advance in respect of Deliverables not provided by the Supplier as at the End Date.
 - (d) The Supplier must promptly delete or return the Government Data except where required to retain copies by Law.
 - (e) The Supplier must promptly return any of CCS or the Buyer's property provided under the terminated Contract.

- (f) The Supplier must, at no cost to CCS or the Buyer, co-operate fully in the handover and reprocurement (including to a Replacement Supplier).
- 10.6.2 In addition to the consequences of termination listed in Clause 10.6.1, where the Relevant Authority terminates a Contract under Clause 10.4.1 the Supplier is also responsible for the Relevant Authority's reasonable costs of procuring Replacement Deliverables for the rest of the Contract Period.
- 10.6.3 In addition to the consequences of termination listed in Clause 10.6.1, if either the Relevant Authority terminates a Contract under Clause 10.2.1 or 10.2.2 or a Supplier terminates an Order Contract under Clause 10.5:
 - (a) the Buyer must promptly pay all outstanding Charges incurred to the Supplier; and
 - (b) the Buyer must pay the Supplier reasonable committed and unavoidable Losses as long as the Supplier provides a fully itemised and costed schedule with evidence the maximum value of this payment is limited to the total sum payable to the Supplier if the Contract had not been terminated.
- 10.6.4 In addition to the consequences of termination listed in Clause 10.6.1, where a Party terminates under Clause 20.2 each Party must cover its own Losses.
- 10.6.5 The following Clauses survive the termination or expiry of each Contract: 3.2.10, 4.2, 6, 7.5, 9, 11, 12.2, 14, 15, 16, 17, 18, 31.3, 34, 35 and any Clauses and Schedules which are expressly or by implication intended to continue.

10.7 Partially ending and suspending the contract

- 10.7.1 Where CCS has the right to terminate the DPS Contract it can suspend the Supplier's ability to accept Orders (for any period) and the Supplier cannot enter into any new Order Contracts during this period. If this happens, the Supplier must still meet its obligations under any existing Order Contracts that have already been signed.
- 10.7.2 Where CCS has the right to terminate a DPS Contract it is entitled to terminate all or part of it.
- 10.7.3 Where the Buyer has the right to terminate an Order Contract it can terminate or suspend (for any period), all or part of it. If the Buyer suspends a Contract it can provide the Deliverables itself or buy them from a third party.
- 10.7.4 The Relevant Authority can only partially terminate or suspend a Contract if the remaining parts of that Contract can still be used to effectively deliver the intended purpose.
- 10.7.5 The Parties must agree any necessary Variation required by Clause 10.7 using the Variation Procedure, but the Supplier may not either:

- (a) reject the Variation; or
- (b) increase the Charges, except where the right to partial termination is under Clause 10.2.
- 10.7.6 The Buyer can still use other rights available, or subsequently available to it if it acts on its rights under Clause 10.7.

10.8 When subcontracts can be ended

At the Buyer's request, the Supplier must terminate any Subcontracts in any of the following events:

- (a) there is a Change of Control of a Subcontractor which is not pre-approved by the Relevant Authority in writing;
- (b) the acts or omissions of the Subcontractor have caused or materially contributed to a right of termination under Clause 10.4; or
- (c) a Subcontractor or its Affiliates embarrasses or brings into disrepute or diminishes the public trust in the Relevant Authority.

11. How much you can be held responsible for

- 11.1 Each Party's total aggregate liability in each Contract Year under this DPS Contract (whether in tort, contract or otherwise) is no more than £1,000,000.
- 11.2 Each Party's total aggregate liability in each Contract Year under each Order Contract (whether in tort, contract or otherwise) is no more than one hundred and twenty five percent (125%) of the Estimated Yearly Charges unless specified in the Order Form.
- 11.3 No Party is liable to the other for:
 - (a) any indirect Losses; or
 - (b) Loss of profits, turnover, savings, business opportunities or damage to goodwill (in each case whether direct or indirect).
- 11.4 In spite of Clause 11.1 and 11.2, neither Party limits or excludes any of the following:
 - (a) its liability for death or personal injury caused by its negligence, or that of its employees, agents or Subcontractors;
 - (b) its liability for bribery or fraud or fraudulent misrepresentation by it or its employees;
 - (c) any liability that cannot be excluded or limited by Law;
 - (d) its obligation to pay the required Management Levy or Default Management Levy.

- 11.5 In spite of Clauses 11.1 and 11.2, the Supplier does not limit or exclude its liability for any indemnity given under Clauses 7.5, 8.3(b), 9.5, 31.3 or Order Schedule 2 (Staff Transfer) of a Contract.
- 11.6 In spite of Clauses 11.1, 11.2 but subject to Clauses 11.3 and 11.4, the Supplier's aggregate liability in each and any Contract Year under each Contract under Clause 14.8 shall in no event exceed the Data Protection Liability Cap.
- 11.7 Each Party must use all reasonable endeavours to mitigate any Loss or damage which it suffers under or in connection with each Contract, including any indemnities.
- 11.8 When calculating the Supplier's liability under Clause 11.1 or 11.2 the following items will not be taken into consideration:
 - (a) Deductions; and
 - (b) any items specified in Clauses 11.5 or 11.6.
- 11.9 If more than one Supplier is party to a Contract, each Supplier Party is jointly and severally liable for their obligations under that Contract.

12. Obeying the law

- 12.1 The Supplier must use reasonable endeavours to comply with the provisions of Joint Schedule 5 (Corporate Social Responsibility).
- 12.2 To the extent that it arises as a result of a Default by the Supplier, the Supplier indemnifies the Relevant Authority against any fine or penalty incurred by the Relevant Authority pursuant to Law and any costs incurred by the Relevant Authority in defending any proceedings which result in such fine or penalty.
- 12.3 The Supplier must appoint a Compliance Officer who must be responsible for ensuring that the Supplier complies with Law, Clause 12.1 and Clauses 27 to 32.

13. Insurance

The Supplier must, at its own cost, obtain and maintain the Required Insurances in Joint Schedule 3 (Insurance Requirements) and any Additional Insurances in the Order Form.

14. Data protection

- 14.1 The Supplier must process Personal Data and ensure that Supplier Staff process Personal Data only in accordance with Joint Schedule 11 (Processing Data).
- 14.2 The Supplier must not remove any ownership or security notices in or relating to the Government Data.

14.3 The Supplier must make accessible back-ups of all Government Data, stored in an agreed off-site location and send the Buyer copies every 6 Months.

- 14.4 The Supplier must ensure that any Supplier system holding any Government Data, including back-up data, is a secure system that complies with the Security Policy and any applicable Security Management Plan.
- 14.5 If at any time the Supplier suspects or has reason to believe that the Government Data provided under a Contract is corrupted, lost or sufficiently degraded, then the Supplier must notify the Relevant Authority and immediately suggest remedial action.
- 14.6 If the Government Data is corrupted, lost or sufficiently degraded so as to be unusable the Relevant Authority may either or both:
 - (a) tell the Supplier to restore or get restored Government Data as soon as practical but no later than 5 Working Days from the date that the Relevant Authority receives notice, or the Supplier finds out about the issue, whichever is earlier; and/or
 - (b) restore the Government Data itself or using a third party.
- 14.7 The Supplier must pay each Party's reasonable costs of complying with Clause 14.6 unless CCS or the Buyer is at fault.
- 14.8 The Supplier:
 - (a) must provide the Relevant Authority with all Government Data in an agreed open format within 10 Working Days of a written request;
 - (b) must have documented processes to guarantee prompt availability of Government Data if the Supplier stops trading;
 - (c) must securely destroy all Storage Media that has held Government Data at the end of life of that media using Good Industry Practice;
 - (d) securely erase all Government Data and any copies it holds when asked to do so by CCS or the Buyer unless required by Law to retain it; and
 - (e) indemnifies CCS and each Buyer against any and all Losses incurred if the Supplier breaches Clause 14 and any Data Protection Legislation.

15. What you must keep confidential

- 15.1 Each Party must:
 - (a) keep all Confidential Information it receives confidential and secure;

- (b) except as expressly set out in the Contract at Clauses 15.2 to 15.4 or elsewhere in the Contract, not disclose, use or exploit the Disclosing Party's Confidential Information without the Disclosing Party's prior written consent; and
- (c) immediately notify the Disclosing Party if it suspects unauthorised access, copying, use or disclosure of the Confidential Information.
- 15.2 In spite of Clause 15.1, a Party may disclose Confidential Information which it receives from the Disclosing Party in any of the following instances:
 - (a) where disclosure is required by applicable Law or by a court with the relevant jurisdiction if, to the extent not prohibited by Law, the Recipient Party notifies the Disclosing Party of the full circumstances, the affected Confidential Information and extent of the disclosure;
 - (b) if the Recipient Party already had the information without obligation of confidentiality before it was disclosed by the Disclosing Party;
 - (c) if the information was given to it by a third party without obligation of confidentiality;
 - (d) if the information was in the public domain at the time of the disclosure;
 - (e) if the information was independently developed without access to the Disclosing Party's Confidential Information;
 - (f) on a confidential basis, to its auditors;
 - (g) on a confidential basis, to its professional advisers on a need-to-know basis; or
 - (h) to the Serious Fraud Office where the Recipient Party has reasonable grounds to believe that the Disclosing Party is involved in activity that may be a criminal offence under the Bribery Act 2010.
- 15.3 In spite of Clause 15.1, the Supplier may disclose Confidential Information on a confidential basis to Supplier Staff on a need-to-know basis to allow the Supplier to meet its obligations under the Contract. The Supplier Staff must enter into a direct confidentiality agreement with the Relevant Authority at its request.
- 15.4 In spite of Clause 15.1, CCS or the Buyer may disclose Confidential Information in any of the following cases:
 - (a) on a confidential basis to the employees, agents, consultants and contractors of CCS or the Buyer;
 - (b) on a confidential basis to any other Central Government Body, any successor body to a Central Government Body or any company that CCS or the Buyer transfers or proposes to transfer all or any part of its business to;
 - (c) if CCS or the Buyer (acting reasonably) considers disclosure necessary or appropriate to carry out its public functions;
 - (d) where requested by Parliament; or (e) under Clauses 4.7 and 16.

- 15.5 For the purposes of Clauses 15.2 to 15.4 references to disclosure on a confidential basis means disclosure under a confidentiality agreement or arrangement including terms as strict as those required in Clause 15.
- 15.6 Transparency Information is not Confidential Information.
- 15.7 The Supplier must not make any press announcement or publicise the Contracts or any part of them in any way, without the prior written consent of the Relevant Authority and must take all reasonable steps to ensure that Supplier Staff do not either.

16. When you can share information

- 16.1 The Supplier must tell the Relevant Authority within 48 hours if it receives a Request For Information.
- 16.2 Within five (5) Working Days of the Buyer's request the Supplier must give CCS and each Buyer full cooperation and information needed so the Buyer can:
 - (a) publish the Transparency Information;
 - (b) comply with any Freedom of Information Act (FOIA) request; and/or (c) comply with any Environmental Information Regulations (EIR) request.

16.3 The Relevant Authority may talk to the Supplier to help it decide whether to publish information under Clause 16. However, the extent, content and format of the disclosure is the Relevant Authority's decision in its absolute discretion.

17. Invalid parts of the contract

If any part of a Contract is prohibited by Law or judged by a court to be unlawful, void or unenforceable, it must be read as if it was removed from that Contract as much as required and rendered ineffective as far as possible without affecting the rest of the Contract, whether it is valid or enforceable.

18. No other terms apply

The provisions incorporated into each Contract are the entire agreement between the Parties. The Contract replaces all previous statements, agreements and any course of dealings made between the Parties, whether written or oral, in relation to its subject matter. No other provisions apply.

19. Other people's rights in a contract

No third parties may use the Contracts (Rights of Third Parties) Act 1999 (CRTPA) to enforce any term of the Contract unless stated (referring to CRTPA) in the Contract. This does not affect third party rights and remedies that exist independently from CRTPA.

20. Circumstances beyond your control

- 20.1 Any Party affected by a Force Majeure Event is excused from performing its obligations under a Contract while the inability to perform continues, if it both:
 - (a) provides a Force Majeure Notice to the other Party; and
 - (b) uses all reasonable measures practical to reduce the impact of the Force Majeure Event.
- 20.2 Either Party can partially or fully terminate the affected Contract if the provision of the Deliverables is materially affected by a Force Majeure Event which lasts for 90 days continuously.

21. Relationships created by the contract

No Contract creates a partnership, joint venture or employment relationship. The Supplier must represent themselves accordingly and ensure others do so.

22. Giving up contract rights

A partial or full waiver or relaxation of the terms of a Contract is only valid if it is stated to be a waiver in writing to the other Party.

23. Transferring responsibilities

- 23.1 The Supplier cannot assign, novate or transfer a Contract or any part of a Contract without the Relevant Authority's written consent.
- 23.2 The Relevant Authority can assign, novate or transfer its Contract or any part of it to any Central Government Body, public or private sector body which performs the functions of the Relevant Authority.
- 23.3 When CCS or the Buyer uses its rights under Clause 23.2 the Supplier must enter into a novation agreement in the form that CCS or the Buyer specifies.
- 23.4 The Supplier can terminate a Contract novated under Clause 23.2 to a private sector body that is experiencing an Insolvency Event.
- 23.5 The Supplier remains responsible for all acts and omissions of the Supplier Staff as if they were its own.
- 23.6 If CCS or the Buyer asks the Supplier for details about Subcontractors, the Supplier must provide details of Subcontractors at all levels of the supply chain including:

- (a) their name;
- (b) the scope of their appointment; and
- (c) the duration of their appointment.

24. Changing the contract

- 24.1 Either Party can request a Variation which is only effective if agreed in writing and signed by both Parties.
- 24.2 The Supplier must provide an Impact Assessment either:
 - (a) with the Variation Form, where the Supplier requests the Variation; or
 - (b) within the time limits included in a Variation Form requested by CCS or the Buyer.
- 24.3 If the Variation cannot be agreed or resolved by the Parties, CCS or the Buyer can either:
 - (a) agree that the Contract continues without the Variation; or
 - (b) terminate the affected Contract, unless in the case of an Order Contract, the Supplier has already provided part or all of the provision of the Deliverables, or where the Supplier can show evidence of substantial work being carried out to provide them; or
 - (c) refer the Dispute to be resolved using Clause 34 (Resolving Disputes).
- 24.4 CCS and the Buyer are not required to accept a Variation request made by the Supplier.
- 24.5 If there is a General Change in Law, the Supplier must bear the risk of the change and is not entitled to ask for an increase to the DPS Pricing or the Charges.
- 24.6 If there is a Specific Change in Law or one is likely to happen during the Contract Period the Supplier must give CCS and the Buyer notice of the likely effects of the changes as soon as reasonably practical. They must also say if they think any Variation is needed either to the Deliverables, DPS Pricing or a Contract and provide evidence:
 - (a) that the Supplier has kept costs as low as possible, including in Subcontractor costs; and
 - (b) of how it has affected the Supplier's costs.
- 24.7 Any change in the DPS Pricing or relief from the Supplier's obligations because of a Specific Change in Law must be implemented using Clauses 24.1 to 24.4.
- 24.8 For 101(5) of the Regulations, if the Court declares any Variation ineffective, the Parties agree that their mutual rights and obligations will be regulated by the terms of the Contract as they existed immediately prior to that Variation and as if the Parties had never entered into that Variation.

25. How to communicate about the contract

- 25.1 All notices under the Contract must be in writing and are considered effective on the Working Day of delivery as long as they are delivered before 5:00pm on a Working Day. Otherwise the notice is effective on the next Working Day. An email is effective at 9:00am on the first Working Day after sending unless an error message is received.
- 25.2 Notices to CCS must be sent to the CCS Authorised Representative's address or email address indicated on the Platform.
- 25.3 Notices to the Buyer must be sent to the Buyer Authorised Representative's address or email address in the Order Form.
- 25.4 This Clause does not apply to the service of legal proceedings or any documents in any legal action, arbitration or dispute resolution.

26. Dealing with claims

- 26.1 If a Beneficiary is notified of a Claim then it must notify the Indemnifier as soon as reasonably practical and no later than 10 Working Days.
- 26.2 At the Indemnifier's cost the Beneficiary must both:
 - (a) allow the Indemnifier to conduct all negotiations and proceedings to do with a Claim; and
 - (b) give the Indemnifier reasonable assistance with the claim if requested.
- 26.3 The Beneficiary must not make admissions about the Claim without the prior written consent of the Indemnifier which can not be unreasonably withheld or delayed.
- 26.4 The Indemnifier must consider and defend the Claim diligently using competent legal advisors and in a way that does not damage the Beneficiary's reputation.
- 26.5 The Indemnifier must not settle or compromise any Claim without the Beneficiary's prior written consent which it must not unreasonably withhold or delay.
- 26.6 Each Beneficiary must take all reasonable steps to minimise and mitigate any losses that it suffers because of the Claim.
- 26.7 If the Indemnifier pays the Beneficiary money under an indemnity and the Beneficiary later recovers money which is directly related to the Claim, the Beneficiary must immediately repay the Indemnifier the lesser of either:

(a) the sum recovered minus any legitimate amount spent by the Beneficiary when recovering this money; or

(b) the amount the Indemnifier paid the Beneficiary for the Claim.

27. Preventing fraud, bribery and corruption

- 27.1 The Supplier must not during any Contract Period:
 - (a) commit a Prohibited Act or any other criminal offence in the Regulations 57(1) and 57(2); or
 - (b) do or allow anything which would cause CCS or the Buyer, including any of their employees, consultants, contractors, Subcontractors or agents to breach any of the Relevant Requirements or incur any liability under them.
- 27.2 The Supplier must during the Contract Period:
 - (a) create, maintain and enforce adequate policies and procedures to ensure it complies with the Relevant Requirements to prevent a Prohibited Act and require its Subcontractors to do the same;
 - (b) keep full records to show it has complied with its obligations under Clause 27 and give copies to CCS or the Buyer on request; and
 - (c) if required by the Relevant Authority, within 20 Working Days of the Start Date of the relevant Contract, and then annually, certify in writing to the Relevant Authority, that they have complied with Clause 27, including compliance of Supplier Staff, and provide reasonable supporting evidence of this on request, including its policies and procedures.
- 27.3 The Supplier must immediately notify CCS and the Buyer if it becomes aware of any breach of Clauses 27.1 or 27.2 or has any reason to think that it, or any of the Supplier Staff, has either:
 - (a) been investigated or prosecuted for an alleged Prohibited Act;
 - (b) been debarred, suspended, proposed for suspension or debarment, or is otherwise ineligible to take part in procurement programmes or contracts because of a Prohibited Act by any government department or agency;
 - (c) received a request or demand for any undue financial or other advantage of any kind related to a Contract; or
 - (d) suspected that any person or Party directly or indirectly related to a Contract has committed or attempted to commit a Prohibited Act.
- 27.4 If the Supplier notifies CCS or the Buyer as required by Clause 27.3, the Supplier must respond promptly to their further enquiries, co-operate with any investigation and allow the Audit of any books, records and relevant documentation.
- 27.5 In any notice the Supplier gives under Clause 27.3 it must specify the:

- (a) Prohibited Act;
- (b) identity of the Party who it thinks has committed the Prohibited Act; and
- (c) action it has decided to take.

28. Equality, diversity and human rights

- 28.1 The Supplier must follow all applicable equality Law when they perform their obligations under the Contract, including:
 - (a) protections against discrimination on the grounds of race, sex, gender reassignment, religion or belief, disability, sexual orientation, pregnancy, maternity, age or otherwise; and
 - (b) any other requirements and instructions which CCS or the Buyer reasonably imposes related to equality Law.
- 28.2 The Supplier must take all necessary steps, and inform CCS or the Buyer of the steps taken, to prevent anything that is considered to be unlawful discrimination by any court or tribunal, or the Equality and Human Rights Commission (or any successor organisation) when working on a Contract.

29. Health and safety

- 29.1 The Supplier must perform its obligations meeting the requirements of:
 - (a) all applicable Law regarding health and safety; and
 - (b) the Buyer's current health and safety policy while at the Buyer's Premises, as provided to the Supplier.
- 29.2 The Supplier and the Buyer must as soon as possible notify the other of any health and safety incidents or material hazards they are aware of at the Buyer Premises that relate to the performance of a Contract.

30. Environment

- 30.1 When working on Site the Supplier must perform its obligations under the Buyer's current Environmental Policy, which the Buyer must provide.
- 30.2 The Supplier must ensure that Supplier Staff are aware of the Buyer's Environmental Policy.

31. Tax

31.1 The Supplier must not breach any Tax or social security obligations and must enter into a binding agreement to pay any late contributions due, including where applicable, any interest or any fines. CCS

and the Buyer cannot terminate a Contract where the Supplier has not paid a minor Tax or social security contribution.

- 31.2 Where the Charges payable under a Contract with the Buyer are or are likely to exceed £5 million at any point during the relevant Contract Period, and an Occasion of Tax Non-Compliance occurs, the Supplier must notify CCS and the Buyer of it within 5 Working Days including:
 - (a) the steps that the Supplier is taking to address the Occasion of Tax Non-Compliance and any mitigating factors that it considers relevant; and
 - (b) other information relating to the Occasion of Tax Non-Compliance that CCS and the Buyer may reasonably need.
- 31.3 Where the Supplier or any Supplier Staff are liable to be taxed or to pay National Insurance contributions in the UK relating to payment received under an Order Contract, the Supplier must both:
 - (a) comply with the Income Tax (Earnings and Pensions) Act 2003 and all other statutes and regulations relating to income tax, the Social Security Contributions and Benefits Act 1992 (including IR35) and National Insurance contributions; and
 - (b) indemnify the Buyer against any Income Tax, National Insurance and social security contributions and any other liability, deduction, contribution, assessment or claim arising from or made during or after the Contract Period in connection with the provision of the Deliverables by the Supplier or any of the Supplier Staff.
- 31.4 If any of the Supplier Staff are Workers who receive payment relating to the Deliverables, then the Supplier must ensure that its contract with the Worker contains the following requirements:
 - (a) the Buyer may, at any time during the Contract Period, request that the Worker provides information which demonstrates they comply with Clause 31.3, or why those requirements do not apply, the Buyer can specify the information the Worker must provide and the deadline for responding;
 - (b) the Worker's contract may be terminated at the Buyer's request if the Worker fails to provide the information requested by the Buyer within the time specified by the Buyer;
 - (c) the Worker's contract may be terminated at the Buyer's request if the Worker provides information which the Buyer considers is not good enough to demonstrate how it complies with Clause 31.3 or confirms that the Worker is not complying with those requirements; and
 - (d) the Buyer may supply any information they receive from the Worker to HMRC for revenue collection and management.

32. Conflict of interest

- 32.1 The Supplier must take action to ensure that neither the Supplier nor the Supplier Staff are placed in the position of an actual or potential Conflict of Interest.
- 32.2 The Supplier must promptly notify and provide details to CCS and each Buyer if a Conflict of Interest happens or is expected to happen.
- 32.3 CCS and each Buyer can terminate its Contract immediately by giving notice in writing to the Supplier or take any steps it thinks are necessary where there is or may be an actual or potential Conflict of Interest.

33. Reporting a breach of the contract

- 33.1 As soon as it is aware of it the Supplier and Supplier Staff must report to CCS or the Buyer any actual or suspected breach of:
 - (a) Law;
 - (b) Clause 12.1; or
 - (c) Clauses 27 to 32.
- 33.2 The Supplier must not retaliate against any of the Supplier Staff who in good faith reports a breach listed in Clause 33.1 to the Buyer or a Prescribed Person.

34. Resolving disputes

- 34.1 If there is a Dispute, the senior representatives of the Parties who have authority to settle the Dispute will, within 28 days of a written request from the other Party, meet in good faith to resolve the Dispute.
- 34.2 If the Dispute is not resolved at that meeting, the Parties can attempt to settle it by mediation using the Centre for Effective Dispute Resolution (CEDR) Model Mediation Procedure current at the time of the Dispute. If the Parties cannot agree on a mediator, the mediator will be nominated by CEDR. If either Party does not wish to use, or continue to use mediation, or mediation does not resolve the Dispute, the Dispute must be resolved using Clauses 34.3 to 34.5.
- 34.3 Unless the Relevant Authority refers the Dispute to arbitration using Clause 34.4, the Parties irrevocably agree that the courts of England and Wales have the exclusive jurisdiction to:
 - (a) determine the Dispute;
 - (b) grant interim remedies; and/or
 - (c) grant any other provisional or protective relief.

- 34.4 The Supplier agrees that the Relevant Authority has the exclusive right to refer any Dispute to be finally resolved by arbitration under the London Court of International Arbitration Rules current at the time of the Dispute. There will be only one arbitrator. The seat or legal place of the arbitration will be London and the proceedings will be in English.
- 34.5 The Relevant Authority has the right to refer a Dispute to arbitration even if the Supplier has started or has attempted to start court proceedings under Clause 34.3, unless the Relevant Authority has agreed to the court proceedings or participated in them. Even if court proceedings have started, the Parties must do everything necessary to ensure that the court proceedings are stayed in favour of any arbitration proceedings if they are started under Clause 34.4.
- 34.6 The Supplier cannot suspend the performance of a Contract during any Dispute.

35. Which law applies

This Contract and any Disputes arising out of, or connected to it, are governed by English law.
