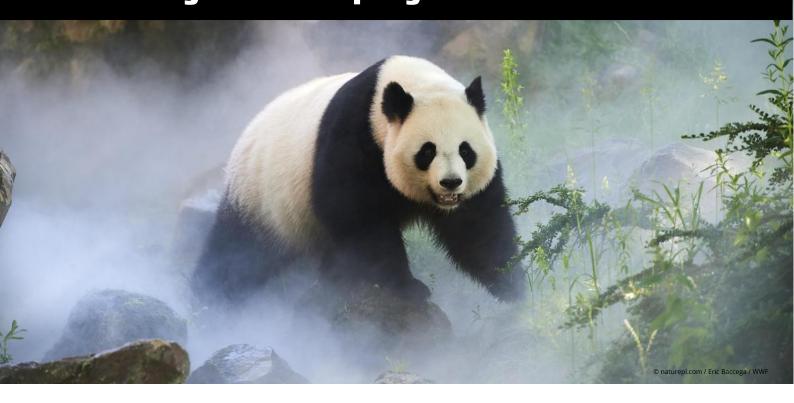

CONTEXT

WWF

In addition to funding and managing countless conservation projects throughout the world, WWF continues to lobby governments and policymakers, conduct research, influence education systems, and work with business and industry to address global threats to the planet by seeking long-term solutions.

PURPOSE & BACKGROUND

The purpose of this Request for Proposal (RFP) is to contract for a duration of 6 months, with a research consultant / consultancy company that will provide research and report writing services for WWF-UK.

WWF-UK is conducting this piece of work to inform efforts to support pangolin conservation and address illegal wildlife trade affecting South Asia. This will support one of WWF UK's key results under its current strategy period; to address drivers of biodiversity loss and 'ensure we are on track for populations of our priority species in our priority places to be stable or increasing by 2030'.

Asia's pangolins continue to be threatened by demand for their scales, used in traditional medicine, and for their meat consumed as a luxury dish. Despite being listed in Appendix I of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), regulation of trafficking across international borders remains a problem. A lack of information regarding the trade routes used, and inadequate use of the available legal tools to deter trafficking, are thought to be key obstacles to countering this crime. The border areas and main shipping routes in the South Asian region of India, Nepal and Pakistan are of serious concern for pangolin trafficking and are the focus of this Proposal.

WWF has a strategic focus on pangolins in the region and the outputs linked to this Proposal will inform these activities as well as those of the wider community seeking to address IWT affecting South Asia.

The key objectives for this project are

Goal: To guide conservation actions to address illegal trade in pangolins affecting South Asia with a focus on India, Nepal and Pakistan's border regions



Objectives

- 1. To characterise patterns and drivers of pangolin trade in South Asia.
- 2. To characterise and international trade routes and hubs of pangolin trafficking in South Asia (detailing any linkages to China, if present).
- 3. To provide an analysis of seizure data to provide insights to the effort made to prevent trafficking of pangolins in this region.
- 4. To provide an overview of relevant policy and regulation relevant to illegal trade in pangolins in these jurisdictions.
- 5. To develop recommendations for WWF and other stakeholders to enhance collaborative efforts in the region to eliminate the illegal pangolin trade.

REQUIREMENTS

The researcher(s) are expected to have:

- A background in pangolin conservation, wildlife trade/crime monitoring and efforts to address illegal wildlife trade.
- A working knowledge of pangolin conservation and trade issues, wildlife crime, wildlife trade and associated stakeholders and actors in South Asia.
- Experience of undertaking research projects that,
 - Gather, analyse and synthesize wildlife trade/crime data.
 - Conduct analyses of policy and regulation in relation to wildlife trade/crime.
 - Produce high quality scientific reports and papers.
 - Engage a range of different stakeholders (including government agencies, NGOs and law enforcement) and tailor engagement and research with these different groups in an appropriate way.

The researcher(s) will be expected to carry out desk-based research that will include sourcing and analysing pangolin seizure data, review of any relevant related publications and a review of relevant policy and regulations. This will be complemented by stakeholder interviews which will include key staff from WWF Offices in region (details provided by WWF UK contact). These findings will be the subject of synthesis alongside development of recommendations for action.

OUTCOME MATERIAL

WWF-UK's provider will:



- 1. Produce a synthesis report that responds to the objectives, detailing the methodology applied, results of the data gathering and seizure analysis, review of drivers, policy analysis and recommendations.
- 2. Work with WWF UK and regional offices, as appropriate to disseminate findings and communicate these to key stakeholders.
- 3. Produce a manuscript for submission to a peer-reviewed publication on the records of pangolin trafficking, seizures and prosecutions involving key border areas of India, Nepal and Pakistan, complete with recommendations for future actions. This should include co-authorship for WWF regional colleagues and other local stakeholders where appropriate and standard authorship criteria have been met.

All materials and reports will need to be:

- Written in English
- Presented in Microsoft word and pdf format
- The report will be proofread, to ensure that it is free of spelling mistakes and typos and is formatted correctly.

The final report should:

- The report should be approximately 25-30 pages long, to be mutually agreed, including an executive summary.
- A draft version of the report in Microsoft word format should be provided to WWF UK for review, with feedback addressed prior to finalisation.
- The report will contain text / infographics / illustrations / photographs as appropriate. An example of similar report (albeit longer than proposed for this tender) is.

- Propose your high-level approach and methodology for the study
- Please outline your forecasted completion date for the project and attach a high-level timeline.
- Please describe how you provide updates, track progress and ensure success of the project? Explain the mechanisms in place for providing regular updates and tracking progress against agreed objectives

Scope & Outcome Material

- Describe how your proposed report fits our required outcome.
- Confirm your capability to produce the outcome material listed in the requirements above.

FINANCIAL PROPOSAL

Pricing must be clearly labelled in Pounds Sterling (£) and be inclusive of all costs except Value Added Tax.

- Please evidence value for money, we are looking for competitive pricing for expertise.
- Fees need to be clear and structured, fully broken down and itemised.
- If you offer NGO discount, please show this within your pricing.
- A pricing chart will need to be submitted. Please state day / hourly rates and price per project element, ideally with capped fees.
 - On the top line please input the total cost for the project, along with how many team members will be involved and forecasted days for the entirety of the project.
 - Each line should show the different project elements / activities, the team members working on each activity, days allocated to each activity, the day rate for the team member and total cost per activity.
 - If there are multiple activities, that can be grouped together, please provide a total line per grouped activity,
 - Should there be a need for travel please include this as a separate line, under the activity it applies to.

All proposals will be evaluated on total cost and service levels which provide optimal benefit to WWF-UK.

The following criteria will be used for evaluation:

- 1- Financial and Terms Proposal 45%
- Total cost of the proposal
- Contractual terms
- 2- Services Proposal 45%
- Alignment between WWF-UK requirement and the vendor's capacity
- 3- Company Profile and Values including sustainability approach 10%
- Evidence that the vendor is proactively reducing their impact on the planet.
