#### 1. INTRODUCTION

- 1.1. The Contract Price is to be established in accordance with the Single Source Contract Regulations 2014 ("SSCR").
- 1.2. In accordance with Schedule A (Statement of Work) the Synthetic Training Service is due to commence on 1<sup>st</sup> May 2021 against the Statement of Training Requirement (SOTR) for the first 5 (five) years and three months.
- 1.3. The Contract will consist of 4 (four) separate Pricing Periods (PPs), with major Contract review points ahead of issuing the Request for Proposal (RFP) for a follow-on PP. The first PP is for 4 (five) years and 11 months. Thereafter, PPs 2 and 3 will last for 5 (five) years each and PP4 will last for 4 (four) years. The Authority shall agree firm prices for the first PP upon Contract Award (CA).
- 1.4. For each Contract Year (CY) the Contractor shall meet the Statement of Training Requirement (SOTR) by providing the Authority with a Training Plan (TP). The TP provides a schedule for meeting the SOTR. This process is detailed in Annex E (Booking and Change Process) within Schedule A Statement of Work (SoW).
- 1.5. The Contract is a Qualifying Defence Contract (QDC) under SSCR, and all future PP proposals must be compliant with SSCR.

#### 2. PRICING PERIODS

2.1 The Pricing Periods (PP) are set out as follows:

Pricing Period 1 – Transition (PP1)	1 May 21 – 31 Mar 26
Pricing Period 2 (PP2)	1 Apr 26 – 31 Mar 31
Pricing Period 3 (PP3)	1 Apr 31 – 31 Mar 36
Pricing Period 4 (PP4)	1 Apr 36 – 31 Mar 40

2.2 PP shall be priced in accordance with the procedure at paragraph 3.

#### 3. PRICING MECHANISMS

- 3.1 The first PP of the Contract shall be priced using a monthly core price based on the PP1 SOTR. The monthly core price shall be constructed as follows:
- 3.1.1 The Authority shall issue the most likely SOTR that sets the requirement for PP1. The Contractor shall use the White Ticket model to calculate the resources required to fulfil the level of training requested in the SOTR. This White Ticket shall be agreed by both parties as the Approved Baseline of resources required to fulfil the SOTR. This will provide the basis of the Training Plan that contains the mutually agreed schedule to deliver the agreed courses. The firm priced Training Plan for PP1 is outlined in Annex A Table 1 of this Schedule P and forms the basis of the firm price Monthly Payment Plan outlined in Annex C Table 1 of this Schedule P. If

the Authority subsequently requests changes to the SOTR that causes the White Ticket resource to increase over the Approved Baseline, the Authority will have the option to either further amend the updated SOTR to be accommodated within the Approved Baseline or to request the Contractor proceed with a RfQ (request for quotation) for additional tasks, in accordance with the change procedure outlined in section 8.15 of the Terms and Conditions. The Contractor's response to the RfQ will provide the pricing that is required to uplift the monthly payment to fulfil the Additional Tasking requested.

- 3.1.2 The Contractor requests that the Authority acknowledges the investment required to setup and fulfil the services that are considered non-recurring effort and excluded from the recurring services provided monthly and recovered through the firm price Monthly Payment Plan. As such, the contractor has requested and it is agreed that milestone payments be in addition to the monthly payment plan outlined in Annex C Table 1 of this Schedule P to align with when these non-recurring goods or services shall be provided to the Authority. When the relevant milestone has been achieved by the Contractor, the Contractor shall submit evidence of the achievement to the Authority and the Authority shall confirm acceptance of the milestone in order for the Contractor to issue the invoice for payment. The milestones, along with indicative achievement dates, have been priced and provided in Annex C Table 2 of this Schedule P.
- 3.1.3 With sole respect to the construction of the new facility and installation of training devices, the Contractor shall not be entitled to claim payment from the Authority that is directly attributed to an increase in the Contractor's lease costs to its Subcontractor until such time that the Contractor has declared to the Authority, that the facility has been constructed and accepted and devices have been installed and accepted in accordance with this Contract. The current scheduled date for this declaration is May 2023. The Contractor shall propose an amendment to this payment schedule corresponding to any forecast or actual delay of this declaration to reflect the adjustment in payment profile. No adjustment of the payment profile in accordance with this Condition shall act to increase or decrease the total Firm Price agreed for the Pricing Period.
- 3.1.4 With sole respect to the support services that deliver maintenance, repair and servicing with obsolescence provision of the WEST / MLGT devices, the Contractor shall not be entitled to claim payment from the Authority that is directly attributed to an increase in the Contractor's lease costs to its Subcontractor (identified as an individual service line within the agreement between Contract and Subcontractor under "WEST / MLGT ISS Maintenance") until such time that the Contractor has declared to the Authority, that the facility has been constructed and accepted and devices have been installed and accepted in accordance with this Contract. The current scheduled date for this declaration is May 2023. The Contractor shall propose an amendment to this payment schedule corresponding to any forecast or actual change of this declaration to reflect the adjustment in payment profile and any corresponding adjustment to the agreed Firm prices. Any agreement to adjust the Firm prices shall be agreed in accordance with the Contract Change process at Condition 8.15 (Contract Change) and shall not come into effect any earlier than the end of the final calendar month of Contract Year following the Contractor's declaration made in accordance with this condition.

- 3.1.5 With sole respect to the delivery of new training courses,, the Contractor shall not be entitled to claim payment from the Authority that is directly attributed to training delivery until such time that the Contractor has declared to the Authority that training courses are ready for delivery in accordance with this Contract. The current scheduled date for this declaration is October 2023. The Contractor shall propose an amendment to this payment schedule corresponding to any forecast or actual delay of this declaration to reflect the adjustment in payment profile. No adjustment of the payment profile in accordance with this Condition shall act to increase or decrease the total Firm Price agreed for the Pricing Period.
- 3.1.6 The Contractor acknowledges the importance of course quality and acceptance, and device accreditation, to allow the Authority to fulfil operational requirements. As such, the Authority agrees to include a [REDACTED] incentive for the Contractor to deliver Green performance in respect of KPI 3a and 3b, in accordance with Schedule K and step 5 of the SSRO 6-step contract profit rate calculation. The incentive appraisal shall be conducted by the Authority, on an annual basis, in December or the final month of the Term as appropriate.
- 3.2 The Authority shall request Indicative Prices for subsequent PPs to be agreed within the RFP process detailed in section 4 below.
- 3.3 The table below has been provided to demonstrate how the price shall be calculated:

# SOR Item Number 4 - Additional Tasks Contracted under the Tasking Arrangement

3.4 Tasks shall be placed in accordance with Condition 8.15 of the Contract and Part D (Course Provision and Scheduling) of Schedule A (Statement of Work) and priced in accordance with ICOP-approved rates. There are anticipated to be three types of changes under this line item. Firstly, where the Authority requires more resources above the Approved Baseline that are already firm priced and secondly where the Authority requires use of STE. Thirdly, any Additional Tasking required by the Authority, including but not limited to block upgrades or courseware upgrades not specified in Schedule A. The first two scenarios are explained below:

#### **Call Off of Additional Courses**

3.5 To enable the call-off of additional resources required which are in addition to those agreed within the Approved Baseline that is incorporated into the TP during any PP; the Authority shall complete the Tasking Form at Schedule H of the Contract. The Contractor will review the Tasking Form and complete an Impact Assessment that will include a proposal response to the Tasking Form as well as a Firm Price. The Firm Price for the additional tasking will be priced in accordance with SSCR. The additional courses requested will follow the change procedures outlined in section 8.15 of the Contract Terms & Conditions and be mutually agreed and incorporated into the TP. The Impact Assessment will only include an uplift of resources for the period requested by the Authority and will not be considered a permanent perpetual uplift of the Approved Baseline, unless otherwise agreed.

#### **Use of STE**

3.6 Where the Authority requires the usage of STE outside of the agreed TP the Authority shall complete the Tasking Form at Schedule H to the Contract.

#### **Third Party Rebate Mechanism**

- 3.7 The Authority shall pay the Contractor monthly in arrears in accordance with section 3. As the assumption of the original Approved Baseline assumes that the Shared Costs will be covered by the firm price for the contract duration, it is recognised that any additional Third Party usage will require a rebate to the Authority for the Shared Costs covered by Third Parties by a prorated calculation.
- 3.8 REDACTED

[REDACTED] REDACTED [REDACTED] 3.9 Incremental Authority Cost Rebates shall apply only if the following occurs:

- 3.9.1 the updated Authority SOTR resource requirement falls below the Approved Baseline for the pricing period;
- 3.9.2 the Authority confirm in writing that the Approved Baseline is higher than the training requirement for the current submitted and approved SOTR;
- 3.9.3 Any Third Parties have requested courses over and above the assumed training plan and are able to utilise the excess capacity.

[REDACTED] 3.9.5 The Contractor reserves the right to increase employment of instructors at its sole discretion.

- 3.9.6 Any additional payments due to the Contractor as a result of increased Authority demand for instructors above the Approved Baseline shall be managed in accordance with the Contract Change Process at Condition 8.15 (Contract Change) of the Terms and Conditions of Contract.
- 3.10 REDACTED
- 3.11 If there is no additional Third Party usage for the year, the Authority will not receive a rebate for the associated year.
- 3.12 The Contractor shall report Third Party STE hours and instructor utilisation to the Authority annually in arrears as part of the annual reconciliation process. The first reconciliation shall be provided to the Authority no later than 31 March 2022.
- 3.13 Third party course prices will follow the same assumptions used in the White Ticket for the Authority, with updates as required to accommodate any discrepancies in assumptions. For the avoidance of doubt, Third Party course prices will not invoke any state aid concerns or put the Authority at risk of aiding Third Parties.

#### 4. AGREEMENT OF FUTURE PRICING PERIODS (PP2 - 4)

- 4.1 The Authority will issue a RFP no later than 12 months before the end of the current PP, requesting from the Contractor a firm priced proposal for delivering the SOTR in the next PP. The RFP shall include, in respect of the follow-on PP:
- 4.1.1 any changes the Authority wishes to make to the Contract;
- 4.1.2 the timetable for the Contractor to submit any clarifications, conduct any negotiations with the Authority, and submit its proposal and;
- 4.1.3 the most likely SOTR for the entire PP.
- 4.1.4 consideration of continuous improvement and innovation (8.23 of the contract terms and conditions refers).
- 4.2 In response to the RFP, the Contractor shall submit a firm priced proposal in accordance with SSCR, and the timetable and requirements specified in the RFP, (which shall not be less than a period of 12 weeks). The Contractor shall provide a firm pricing at Annexes A and B to Schedule P for the entire PP. Any changes will be managed within the process outlined within paragraph 5.1.9 of Schedule A (Statement of Work) and the Contract Change Condition at 8.15 of the Contract Terms and Conditions.
- 4.3 If requested by the Authority, the Contractor shall provide any additional information required and/or shall consider revising the proposal in accordance with Authority feedback and resubmitting their proposal to the Authority. If the proposal is approved by the Authority, it shall be incorporated into the Contract in accordance with Contract Change Condition at 8.15.
- 4.4 If the Authority does not consider the proposal compliant in any respect with the Contract, the Parties shall:

- 4.4.1 negotiate to resolve any disagreements in accordance with Condition 8.5 (Dispute Resolution) of the Contract Terms and Conditions and DEFCON 530 (Dispute Resolution (English Law)); and/or
- 4.4.2 where the disagreement is not resolved by negotiation within 60 calendar days then:
- 4.4.2.1 to the extent that the disagreement, or any element of the disagreement, relates to a matter on which the Single Source Regulatory Office (SSRO) may give a determination pursuant to the Defence Reform Act (DRA) or the SSCRs, it shall be referred to the SSRO for a determination; and
- 4.4.2.2 any other aspect of the disagreement shall continue to be resolved in accordance with Condition 8.5 (Dispute Resolution) and DEFCON 530 (Dispute Resolution (English Law));
- 4.4.3 Upon resolution of the dispute, the Contractor shall produce a revised proposal reflecting the outcome of such resolution (if required), and such revised proposal shall be incorporated into the Contract in accordance with Contract Change Condition at 8.15.

#### 5. PAYMENT

- 5.1. The Contractor shall be entitled to invoice the Authority for the Total Monthly Payment in respect of each Monthly Performance Payment for the Term of the Contract from Contract Commencement Date plus any milestone payments due in accordance with this Schedule P.
- 5.2. Payments made under this Contract shall be made in accordance with the currency denominated in the pricing tabled at Annex C to this Schedule P. This includes payments in both Great British Pounds (GBP) and United States Dollars (USD).
- 5.3. The Monthly Performance Payment portion of the Total Monthly Payment respect of each relevant Monthly Performance Payment period (n) shall be calculated using the following formula:
