Section 4 – Specification and about this procurement

Executive Summary

UK Shared Business Services Ltd (UK SBS) on behalf of The Department for Business, Energy and Industrial Strategy (BEIS), wishes to establish a Framework for the provision of Energy and Climate Change Behavioural Science Services as per the specification below.

UK SBS is managing this procurement process in accordance with the Public Contracts Regulations 2015 (as may be amended from time to time) (the “Regulations”).

This is a Services Framework being procured under the Open OJEU Procedure regulations.

The duration of this Framework will be 26 Months (From award until the 31st March 2023).

It is intended that there will be 3 suppliers awarded to this Framework. These awarded suppliers will be ranked 1st, 2nd, and 3rd based off the scores awarded from this completion of this procurement.

As and when requirements are identified, Call-Off Contracts will be awarded based on the Framework ranking, with Supplier 1 being offered first, then moving to Supplier 2, and finally Supplier 3. An example of the Call-Off Contract template that will be issued with details of the requirements when they become available is provided in Appendix B.

This RFP sets out details of the Framework Contract and expectations of any successful supplier.

1. Background

Behavioural science provides vital insight regarding the responses of citizens, consumers, businesses, and other groups to government policies. Many energy and climate change policies particularly require, and indeed encourage, individuals to change their behaviour in response to incentives, regulation, and other measures - behavioural insights can help to maximise the impacts of these.

Insights from behavioural science are important to ensure that proposed policies, market incentives, and other interventions will elicit the desired response from consumers and businesses. In addition, advice from behavioural scientists could help to improve policy development and maximise the effectiveness of policy interventions.

At present, the pace of policy work in a number of energy and climate change teams is rapid, particularly in light of the context of the economic recovery from Covid-19, in which BEIS is rapidly developing policies to stimulate clean growth to aid this recovery. There are also a number of policy areas related to net zero and fuel poverty that are of high priority for BEIS (e.g. heat, energy efficiency policies, smart technologies) and rely upon behavioural change – indeed, the Committee on Climate Change estimate that over 60% of the emissions reduction required to reach net zero will need some form of behaviour change. One key challenge (especially within the current context) is ensuring behavioural science insights are taken into account at the right point within the policy development process. A Framework with fast paced call-off contract awards will enable behavioural science evidence to be gathered and disseminated rapidly, maximising impact on policy

development. There are also a number of ad hoc behavioural evidence needs that can emerge at short notice.

In addition, many opportunities to apply behavioural science expertise (e.g. applying behavioural science techniques to interrogate and improve policy proposals) are also for smaller behavioural science tasks which do not warrant the disproportionate amount of time/resources taken to procure them. This Framework is intended to enable BEIS to gain behavioural science insight within an appropriate timeframe to feed into policy development, while minimising the resources required to commission this work.

Overall, we anticipate this contract will lead to greater utilisation of behavioural science insight within the development of energy and climate policy, helping to improve their effectiveness and uptake by the public and businesses.

2. Aims and Objectives of the Framework

The overarching aim of the Framework is to maximise the effectiveness of energy/climate policy by ensuring that they are informed by behavioural science. BEIS wish to have access to expertise in applying behavioural science to improve policy **and** subject matter expertise/understanding of behavioural/societal change.

The Framework contract will be used to inform energy/climate change policy across BEIS. In particular, the Framework contract will be used to improve the implementation and design of planned policies, propose ideas for new initiatives, support with methodological design, and fulfil ad hoc behaviour change evidence needs. A few examples of projects and policies that could be informed by this work include:

- Supporting the rapid development and implementation of clean recovery policies (e.g. testing messages, simplifying consumer journeys, and stress-testing policy ideas from a behavioural science perspective).
- Domestic energy efficiency policies will increasingly have to persuade households to install more intrusive measures, as well as more measures per home, so applying behavioural science techniques to inform, and maximise the effectiveness of, policies will be increasingly important.
- To reach net zero there will need to be a low carbon heating transition which will require significant changes in heating technologies and other remedial measures. Behavioural science work could help to understand what supplementary 'softer initiatives' could be launched alongside measures such as economic incentives and regulation (as well as inform the practical implementation of these measures).
- Rapid experiments to test different policy options to understand public support and / or potential behavioural responses.
- Specific ad hoc tasks such as identifying softer initiatives that we could implement to maximise the emission reduction potential of home working. These tasks can be highly diverse and may require the ability to bring in a range of skillsets (e.g. whole system modelling, systems thinking).
- In addition, the awarded Supplier(s) will be able to provide BEIS with behavioural insights training, which will improve our ability to apply behavioural science insights to the policy development process, leading to lasting improvements in BEIS capability in this area.

The overall outcome of the Framework and subsequent Call-off Contracts would therefore be greater input of behavioural science into energy and climate policy formulation, resulting in more effective policies.

3. Suggested Methodology

There are a wide variety of potential behavioural science projects which we anticipate the Framework will cover, broadly including:

1. **Improving the design and implementation of proposed policies.** We will require the Supplier(s) to develop and rapidly apply behavioural science techniques to specific policies that may be implemented. Examples could include: Providing expert behavioural review of policy proposals and/or systematically reviewing policy proposals through behavioural science techniques; Application of the behavioural science frameworks to understand behavioural barriers and interventions (e.g. the COM-B/Behaviour Change Wheel framework); Detailed user/behavioural journey mapping for different groups; Identifying how nudges and behavioural cues could improve the implementation of a policy; Trialling different communication and implementation techniques; experiments to test different policy ideas against each other, and broader 'Stress-testing' of policy ideas.
2. **Identifying new interventions to help deliver behaviour change.** The Supplier(s) should be able to identify interventions that could help to deliver behaviour change in key policy areas relating to net zero. This could involve using behavioural insight frameworks to diagnose the key barriers and opportunities for behavioural change and developing long lists of a range of policy options to help facilitate behaviour change that can be considered for implementation by policy teams.
For instance, DfT have recently carried out a similar study to this for electric vehicles which developed a list of 'high potential' behaviourally informed interventions which address all the key barriers to uptake, and could sit alongside economic incentives/infrastructure to accelerate EV adoption.¹
3. **Upskilling and guidance** across energy/climate policy teams and social researchers/those with more expertise in behavioural change. We envisage the contractor could provide expert training to existing social researchers to improve their skillsets as well as more basic training to wider policy teams and analysts. The Supplier(s) could also be asked to develop simple guidance and toolkits that can be used to apply behavioural insight techniques at all stages of the policy cycle. This will build understanding of where, and how, behavioural science can add value to energy/climate policy.
4. **Methodological advice and design:** We may require the Supplier(s) to provide expert advice, including developing methodologies to support piloting and trialling of behavioural related interventions, as well as providing peer review and expert insight into relevant analytical and social research taking place.

The framework is non-exclusive, and individual works requirements will be procured on an as and when required basis. BEIS is unable to guarantee the volume and value of allocated

work. Individual projects will be commissioned on fixed costs for projects and not estimated rates or day rates as per usual government procurement. BEIS reserve the right to commission behavioural science work outside of this Framework.

In terms of more specific requirements from bidders:

- The scope of potential behavioural science research activities under this Framework is broad. Therefore, we require the team to have a wide breadth of skills and experience in a wide range of social research techniques, in addition to their expertise in behavioural science.
- We require the team to have a strong working knowledge of, and experience in, energy and climate change policy. To this end, we would strongly encourage/expect bids from consortia to incorporate academics and / or other experts that have expert understanding of behavioural and social practice research in relevant areas to enhance the team's expertise. It is also recommended that bidders offer flexibility to identify, and work with, experts on specific projects if the core team does not have subject matter expertise for a particular project. Although the overwhelming majority of projects will be within the energy and climate change space, there may be projects outside of this scope (e.g. relating the work of the Department for Environment, Food & Rural Affairs), although subject matter expertise will not be required in these cases.
- The team should be able to work flexibly, begin new projects at short notice, and work to tight timescales where required, in order to input behavioural science insights into policy development when necessary.
- The Framework will run until 31st March 2023.
- We will also likely require (although cannot guarantee) the Supplier(s) to carry out an annual review (or 'stocktaking' report) of their work at the end of each financial year to ensure that the Supplier(s) is providing BEIS with high quality, value for money outputs. This should include a review of any work carried out for BEIS, as well as a review of wider insights from emergent literature or behavioural science evidence and the implications of this for policy in BEIS. This report will be used as the basis for continuing with the contract through to the next year.
- The Framework will have a maximum value cap of £450,000 across its duration. However, as noted above, there is no commitment from BEIS that it will spend this or any amount of money through the Framework.

4. Deliverables

Outputs produced through individual Call-Off Contracts will vary on a project by project basis. These may include reports, training materials, presentation materials, and other products.

Data outputs

BEIS may wish to request the underlying data for research outputs, particularly quantitative research (e.g. tables and crosstabs for surveys). The Supplier(s) is required to be able to provide this at request.

Quality assurance

BEIS may wish to request quality assurance logs for major research outputs. The Supplier(s) is required to be able to provide this at request.

Publication

Some of the outputs produced under this Framework may be published on gov.uk; therefore, the supplier(s) should be prepared to produce publication standard work. Whether project outputs will be published will be decided on a project by project basis.

Commissioning of individual projects (Call-Offs)

Within BEIS, there will be a common process which all projects will undergo to act as quality assurance before requests to provide a proposal for work are submitted to the Supplier(s). This will be a two-part process:

- 1) All applications are submitted to the Energy Social Research Branch team, which manages the Framework. A member of the team will carry out a light-touch assessment of the application.
- 2) Following feedback, the application is then sent to a sub-committee of more senior analysts who will assess project applications and will ensure the project is suitable before they can be approved and sent to the Supplier in order of Framework ranking.

Once the proposed project is submitted to the Supplier in ranked position 1, a response will be required from the Supplier within a maximum of five working days. Should the Supplier in ranked position 1 advise that they are unable to provide the Services required, BEIS will issue the proposed project to Supplier 2. A response from Supplier 2 would be required within a maximum of five working days. Should Supplier 2 advise that they are unable to provide the Services required, BEIS will issue the proposed project to Supplier 3. A response from Supplier 3 would be required within a maximum of five working days.

For clarity, should a supplier fail to respond by the 5th working day, the contracting authority will deem that they are not interested in the requirement and will therefore by default, offer out the opportunity to the next supplier.

Once the proposal has been accepted by BEIS and a Call-Off Contract signed, BEIS would expect work to begin within two working days.

5. Framework Award

In order to provide a fair and transparent process for awarding Supplier(s) to this Framework we will be asking for potential Suppliers to provide 'approach' response to the following.

1. How you would go about supporting each of the four broad points:
 - i) techniques to improve the design of existing policies and regulation.
 - ii) techniques to identify a range of new policies and interventions that policy teams may wish to consider.
 - iii) how you would provide upskilling/guidance and the things this would cover.
 - iv) how you would provide methodological support (and in what areas)?

2. How you would approach the following three hypothetical projects. For each project, we require a summary outlining:
- How you would approach the issue – the key questions and considerations.
 - The key methods that would be used and why.
 - The outputs/materials you would produce.
 - A price breakdown including total cost, staff days and seniority.

The hypothetical projects are as follows:

- 1) A team in BEIS that works on low carbon heating would like to understand how the existing policy landscape could be improved, including the potential for new policy initiatives or interventions alongside subsidies and regulation. How would you use behavioural science to support this team in its objective?
- 2) BEIS wants to carry out a roll-out of 'behaviour change MOTs' across BEIS energy/climate policies. These would, for each policy area, review the current policy landscape through a behavioural science lens, assess the future change that is needed in the sector/policy area (e.g. % of the population taking up a technology or behaviour), identify barriers to change, and make recommendations for how behavioural insights could be used to help achieve these objectives. For example, reviewing the energy efficiency policy landscape, their long-term policy objectives, and assessing if/where new interventions are needed to achieve these objectives. **[Please address the points above (including the price breakdown) for carrying out one 'behavioural MOT']**
- 3) A team of analysts (~12 people) in BEIS, who specialise in social research and customer insights, would like specialist training on behavioural science methods, so that they can further help policy teams across the department apply behavioural science to key policy issues. The team has some familiarity with behavioural science, but no formal training. Please explain how you would deliver a 1- or 2-day training course for such a team and what content this would cover.

Quality assurance

Suppliers are asked to provide details of their quality assurance processes at each stage during a project. Suppliers may wish to highlight the quality assurance processes they would undergo within a project as part of their response to one (or more) of the three hypothetical projects above.

As part of your submission, we also request bidders to outline their expected management of the contract, including processes to be followed by the contractor's organisation upon the submission of a commission by BEIS.

Terms and Conditions

Bidders are to note that any requested modifications to the Contracting Authority Terms and Conditions on the grounds of statutory and legal matters only, shall be raised as a formal clarification during the permitted clarification period.

Section 5 – Evaluation model

5.1. Introduction

- 5.1.1. The evaluation process will be conducted to ensure that Bids are evaluated fairly to ascertain the bidders who can demonstrate the required skills qualities, technical ability and capacity, commercial stability and experience to ensure successful performance of the Contract.
- 5.1.2. The evaluation team may comprise staff from UK SBS and the Contracting Authority, and any specific external stakeholders the Contracting Authority deem required

5.2. Evaluation of Bids

- 5.2.1. Evaluation of Bids shall be based on a Selection questionnaire and Award criteria as clearly defined in the e-sourcing tool.

- 5.3.2. Each Mandatory pass / fail question includes a clear definition of the requirements of a successful response to the question.
- 5.3.3. The evaluation model below shall be used for this RFP which will be determined to two decimal places.
- 5.3.4. Questions marked 'for information only' do not contribute to the scoring model.
- 5.3.5. During the evaluation stage, the intention is that only Bidders who achieve a Pass of all the Mandatory and Discretionary requirements of the RFP will be considered for award stage evaluation.

5.4. AWARD questionnaire

Award Evaluation of criteria

Non-Price elements

Each question will be evaluated on a score from 0 to 100, which shall be subjected to a multiplier to reflect the percentage of the evaluation criteria allocated to that question.

Where an evaluation criterion is worth 20% then the 0-100 score achieved will be multiplied by 20%.

Example if a Bidder scores 60 from the available 100 points this will equate to 12% by using the following calculation:

All questions will be scored based on the above mechanism. Please be aware that there may be multiple evaluators. If so, their individual scores will be averaged (mean) to determine your final score as follows:

Your final score will $(60+40+80+60) \div 4 = 60$

 Where the scoring criterion is worth 50% then the 0-100 score achieved will be multiplied by 50

In the example if a supplier scores 80 from the available 100 points this will equate to 40% by using the following calculation: Score/Total Points multiplied by 50 (80/100 x 50 = 40)

The lowest score possible is 0 even if the price submitted is more than 100% greater than the lowest price.

 - 7.11.2.2. accepts any responsibility for the information contained in the RFP or for their fairness, accuracy or completeness of that information nor shall any of them be liable for any loss or damage (other than in respect of fraudulent misrepresentation) arising as a result of reliance on such information or any subsequent communication.
- 7.11.3. Any persons considering making a decision to enter into contractual relationships with the Contracting Authority and/or, as applicable, relevant OPB following receipt of the RFP should make their own investigations and their own independent assessment of the Contracting Authority and/or, as applicable, relevant OPB and its requirements for the services and should seek their own professional financial and legal advice. For the avoidance of doubt the provision of clarification or further information in relation to the RFP or any other associated documents (including the Schedules) is only authorised to be provided following a query made in accordance with Paragraph 7.15 of this RFP.

7.12. Collusive behaviour

- 7.12.1. Any Bidder who:
- 7.12.1.1. fixes or adjusts the amount of its Response by or in accordance with any agreement or arrangement with any other party; or
 - 7.12.1.2. communicates to any party other than UK SBS, the Contracting Authority or, as applicable, relevant OPB the amount or approximate amount of its proposed Response or information which would enable the amount or approximate amount to be calculated (except where such disclosure is made in confidence in order to obtain quotations necessary for the preparation of the Response or insurance or any necessary security); or
 - 7.12.1.3. enters into any agreement or arrangement with any other party that such other party shall refrain from submitting a Response; or
 - 7.12.1.4. enters into any agreement or arrangement with any other party as to the amount of any Response submitted; or
 - 7.12.1.5. offers or agrees to pay or give or does pay or give any sum or sums of money, inducement or valuable consideration directly or indirectly to any party for doing or having done or causing or having caused to be done in relation to any other Response or proposed Response, any act or omission,
- shall (without prejudice to any other civil remedies available to the Contracting Authority and without prejudice to any criminal liability which such conduct by a Bidder may attract) be disqualified.

7.13. No inducement or incentive

- 7.13.1. The RFP is issued on the basis that nothing contained in it shall constitute an inducement or incentive nor shall have in any other way persuaded a Bidder to submit a Response or enter into the Contract or any other contractual agreement.

7.14. Acceptance of the Contract

- 7.14.1. The Bidder in submitting the Response undertakes that in the event of the Response being accepted by the Contracting Authority and the Contracting Authority confirming in writing such acceptance to the Bidder, the Bidder will within 7 days of being called upon to do so by the Contracting Authority execute the Contract in the form set out in the Contract Terms or in such amended form as may subsequently be agreed.
- 7.14.2. The Contracting Authority shall be under no obligation to accept the lowest priced or any Response.

7.15. Queries relating to the Response

- 7.15.1. All requests for clarification about the requirements or the process of this procurement shall be made in through the e-sourcing tool unless where the e-sourcing tool is unavailable due to Delta eSourcing system maintenance or failure, in this instance all clarifications shall be by email to the contact defined in [Section 3](#).
- 7.15.2. The Contracting Authority will endeavour to answer all questions as quickly as possible but cannot guarantee a minimum response time.
- 7.15.3. In the event of a Bidder requiring assistance uploading a clarification to the e-sourcing portal they should use the contact details defined in [Section 3](#).
- 7.15.4. No further requests for clarifications will be accepted after the 14th December 2020.
- 7.15.5. In order to ensure equality of treatment of Bidders, the Contracting Authority intends to publish the questions and clarifications raised by Bidders together with the Contracting Authority's responses (but not the source of the questions) to all participants on a regular basis.
- 7.15.6. Bidders should indicate if a query is of a commercially sensitive nature – where disclosure of such query and the answer would or would be likely to prejudice its commercial interests. However, if the Contracting Authority at its sole discretion does not either; consider the query to be of a commercially confidential nature or one which all Bidders would potentially benefit from seeing both the query and the Contracting Authority's response, the Contracting Authority will:
- 7.15.6.1. invite the Bidder submitting the query to either declassify the query and allow the query along with the Contracting Authority's response to be circulated to all Bidders; or
 - 7.15.6.2. request the Bidder, if it still considers the query to be of a commercially confidential nature, to withdraw the query prior to the end of the closing date and time for Bidder clarifications.
- 7.15.7. The Contracting Authority reserves the right not to respond to a request for clarification or to circulate such a request where it considers that the answer to that request would or would be likely to prejudice its commercial interests.

7.16. Amendments to Response Documents

- 7.16.1. At any time prior to the deadline for the receipt of Responses, the Contracting Authority may modify the RFP by amendment. Any such amendment will be numbered and dated and issued by the Contracting Authority to all prospective Bidders. In order to give prospective Bidders reasonable time in which to take the amendment into account in preparing their Responses, the Contracting Authority may, at its discretion, extend the time and/or date for receipt of Responses.

7.17. Modification and withdrawal

- 7.17.1. Bidders may modify their Response where allowable within the e-sourcing tool. No Response may be modified after the deadline for submission of Responses.
- 7.17.2. Bidders may withdraw their Response at any time prior the deadline for submission of Responses [or any other time prior to accepting the offer of a Contract]. The notice to withdraw the Response must be in writing and sent to the Contracting Authority by recorded delivery or equivalent service and delivered to the Head of Policy UK SBS at UK Shared Business Services Ltd, Procurement, Polaris House, North Star Avenue, Swindon, Wiltshire, SN2 1ET

7.18. Right to disqualify or reject

- 7.18.1. The Contracting Authority reserves the right to reject or disqualify a Bidder where
- 7.18.1.1. the Bidder fails to comply fully with the requirements of this Request for Proposal or presents the response in a format contrary to the requirements of this document; and/or
 - 7.18.1.2. the Bidder is guilty of serious misrepresentation in relation to its Response; expression of interest; or the Response process; and/or
 - 7.18.1.3. there is a change in identity, control, financial standing or other factor impacting on the selection and/or evaluation process affecting the Bidder.

7.19. Right to cancel, clarify or vary the process

- 7.19.1. The Contracting Authority reserves the right to:
- 7.19.1.1. cancel the evaluation process at any stage; and/or
 - 7.19.1.2. require the Bidder to clarify its Response in writing and/or provide additional information. (Failure to respond adequately may result in the Bidder not being selected),

7.20. Notification of award

- 7.20.1. The Contracting Authority will notify the successful Bidder of the Contract award in writing and will publish an Award Notice in the Official Journal of the European Union in accordance with the Regulations within 30 days of the award of the contract.
- 7.20.2. As required by the Regulations all successful and unsuccessful Bidders will be provided with an email advising the outcome of the submission of their RFP response.
