



Waveney District Council is seeking a suitably qualified Contractor to undertake and be responsible for all Works necessary to supply and install a sprinkler system in its residential, occupied tower block at St Peters Court, Lowestoft.

As part of the Invitation to Bid process the Council will be placing great emphasis on the previous experience/expertise of Bidders in undertaking works similar to those it requires in respect of St Peters Court, together with Health and Safety. Bidders will be required to meet a minimum threshold score of “Satisfactory” in respect of the following sections of the contract award criteria:

- Health and Safety
- Comparable Experience/Expertise

The following items will be “Pass/Fail” criteria:

- Membership of British Automatic Fire Sprinkler Association (BAFSA) or Residential Sprinkler Association or equivalent organisation(s)
- Sprinkler system proposed to be accredited by a third party organisation such as Loss Prevention Certification Board (LPCB) or FIRAS or equivalent organisation(s)
