- 1. The United Kingdom of Great Britain and Northern Ireland, together with its Overseas Territories and Crown Dependencies, represented by The Secretary of State for Health and Social Care acting as part of the Crown through the Department of Health and Social Care of 39 Victoria St, Westminster, London SW1H 0EU ("the Contracting Authority"), represented for the purposes of signing this specific contract by Hadebe Simeon, Senior Manager, Vaccines and Medicines Counter Measures Team, Commercial Directorate.
- 2. Gilead Sciences Ltd, a private limited company registered in England (company number: 02543818, VAT number GB792402037) with its registered address at 280 High Holborn, London, WC1V 7EE ("the Contractor"), represented for the purposes of signing this specific contract by Véronique Walsh, General Manager of Gilead Sciences Ltd.

HAVE AGREED

ARTICLE 1. SUBJECT MATTER

- 1.1 This specific contract implements framework contract No SANTE/2020/C3/048, signed by the parties on 7 October 2020 ("FWC").
- 1.2 In accordance with the provisions set out in the FWC and in this specific contract and its annexes, which form an integral part of it:

the Contracting Authority will purchase and the Contractor will supply the following minimum quantities of Veklury under this Specific Contract No 10 as follows:

If in accordance with Article I.10 of the FWC the number of vials per Contracting Authority is determined based on the allocation criteria described in Annex I to the FWC (tender specifications part 2, point 2.1), the Contractor shall supply the quantity specified in this specific contract, provided it does not exceed the number of vials for the Contracting Authority communicated by the European Commission to the Contractor based on Article I.10 of the FWC.

1.3 All such quantities of Veklury will be supplied within the following time limit: the amount set out on an order (submitted in accordance with Section 5 below) shall be delivered seven (7) days from the date of receipt of the corresponding order from the Contracting Authority, unless agreed differently in writing between the Contracting Authority and the Contractor.

ARTICLE 2. ENTRY INTO FORCE AND DURATION

- 2.1 This specific contract enters into force on the date on which the last party signs it.
- 2.2 The performance of the contract starts from the date of the last signature to this specific contract.
- 2.3 The duration of the contract must not extend beyond 7 July 2022. The parties may extend the duration by written agreement before it elapses and before expiry of the FWC.

ARTICLE 3. PRICE

3.1 The price payable under this specific contract is:

Gilead will invoice Contracting Authority monthly for product ordered by those public bodies or organisations for which the Contracting Authority is responsible and which it notifies to the Contractor in the proceeding 7 days. VAT will be charged in addition, if applicable.

5.2 Reporting

Gilead will supply the Contracting Authority with a weekly report showing cumulative orders to date versus the vial allocation for those public bodies or organisations for which the Contracting

Authority is responsible and which it notifies to the Contractor.
