The FCO are establishing the UKNSF as a grants scheme for the community and voluntary sector. This grant funding would be used by organisations to support UKNs to complete the full process required to register/apply for residence by the deadline in their Member State (MS) of residence.

The **purpose** of this exercise is:

- 1. To gauge **level of interest** in the UKNSF from potential bidders.

#### **UK Nationals in the EU**

There are estimated to be over 1 million UK nationals (UKNs) in the EU/EFTA states. The UK Government has reached an agreement with the EU on citizens' rights that will protect those UKNs resident in the EU by the end of the planned implementation period on 31 December 2020. Under this agreement, States would be able to opt for either a constitutive or declaratory registration scheme.

In the event that the UK leaves the EU without a deal, States have passed or drafted legislation to protect the rights of UKNs. The details of this legislation vary by State. In most cases, UKNs may need to be registered, or re-registered, or apply for residency, in their States of residence in order to be able to continue to legally reside in their host States.

Many UKNs will already be informed about the need to register or apply for residency through a range of MS, UK Government and wider outreach and communication activity. However, there is a risk that some UKNs may remain unaware that they should register and/or may struggle to undertake the registration process within stipulated timeframes.

The FCO are looking to initiate a grants scheme enabling organisations to provide practical support to UKNs to complete the full process required to register/apply for residence by the deadline in their MS of residence.

For the purposes of this grant award process, there will be one level of award:

• £90,000 and above – the minimum award will be ninety thousand pounds (£90,000), inclusive of irreclaimable VAT.

The financial stability of organisations is a key eligibility criteria and will be assessed as part of the evaluation process.

The <u>key outcome</u> for the UKNSF is for funded organisations to <u>provide a service that</u> <u>leads to the successful registration or application for residency status of UKNs living in EU/EFTA states.</u> Funded organisations will be expected to be able to demonstrate that their work has led to successful applications.
