## Section 4 – Specification and about this procurement

#### 1. Introduction

Across UK Research and Innovation (UKRI) overseas field work and travel is increasing, with the work often involving visits to remote or underdeveloped locations, representing a significant area of risk to be managed.

In 2019 UKRI had 2549 employees/representatives travelling internationally, often making multiple trips. This totals 3646 flights in approximately 120 countries. Please see **Appendix A** for details regarding the airport destinations.

Currently travel support and advice is provided by three separate contractors, Control Risk Group (CRG) providing security advice to the Natural Environment Research Council (NERC), who are part of UKRI, CHUBB providing travel insurance cover across UKRI and Corporate Travel Management (North) (CTM) Limited providing UKRI booking services and some information on the location of travellers.

The proposed service would provide a platform for co-ordinating all international travel and field work risk management across UKRI Research Councils. The service would need to provide comprehensive, single point of contact, pre-travel medical and security advice, training and security. Medical support whilst "in country" is required and this would also include the management of international incidents and emergencies affecting UKRI employees.

The service is required to enhance the existing risk management processes across in UKRI for overseas fieldwork and travel and provide a more robust emergency incident response process. It is also required to support the delivery of effective Health and Safety management in UKRI as defined in the UKRI Health and Safety Policy (**Appendix B**).

The service would need the capability to transfer data from the existing travel booking system, currently CTM (Corporate Travel Management (North) Limited) and contracts of overseas travel insurance held by UKRI such as with CHUBB.

#### 2. Aims and Objectives

The aim is to provide a one stop service for the risk management of overseas field work and provide a single point of contact solution for travellers and managers.

- 2.1. To improve international travel and field work safety with increased access to pretravel risk assessment, planning tools and information
- 2.2. Improve the provision of training for employees working overseas in relation to health, security and cultural issues
- 2.3. Provide the ability to keep employees informed of any emerging or changing medical and security risks while overseas and providing options for assistance.
- 2.4. Provide UKRI with the ability to communicate with and manage travellers in terms of location tracking and communications e.g. mobile app.

2.5. Improve the ability to manage emergency incidents and coordinate actions and communications with other support suppliers such as CTM and CHUBB.

#### 3. Background to the Requirement

Within UKRI the Natural Environment Research Council (NERC) have had a service contract with International SOS/CRG for travel security advice for several years.

As per the introduction, the amount of overseas travel has increased for UKRI substantially with the introduction of additional Overseas Development funding for research activities overseas.

Travellers are broadly split into people attending international conferences, usually in well-developed counties and cities and those that undertake practical fieldwork in often remote locations in underdeveloped countries. We can, on occasion, work in areas rated as "high risk" by the UK Foreign Office and International SOS/CRG.

UKRI has a corporate policy (Appendix C) and procedure for the planning and risk assessment of overseas travel and fieldwork. Individual Research Councils have internal arrangements to deliver the UKRI corporate policy.

Travel bookings are currently made through CTM by the line manager and the field work risk assessment and planning is managed by the individual travellers and their line management. Professional Health & Safety advisors can also be involved.

## 4. Scope

The scope of the service would include all employees travelling and working overseas for UKRI. This would include students and researchers from other organisations working with/ on UKRI Research Councils managed projects.

Excluded from the scope would be employees working in Antarctica and other Arctic regions where the travel is managed by the British Antarctic Survey (BAS) <a href="https://www.bas.ac.uk/">https://www.bas.ac.uk/</a>, but would include employees traveling to and from Antarctic gateway locations such as South Africa, Falklands and South America. BAS will manage travel support from the gateways to Antarctica/Arctic stations.

#### 5. Requirement

## **Medical Support**

- 1. Individual country medical risk ratings for pre-trip planning.
- 2. Medical advice and information for specific countries to aid pre-trip planning.
- 3. Provide a single point of contact for medical assistance to travellers while overseas providing support as appropriate i.e. online, by phone, video link or face to face in country.
- 4. Access to pre-approved clinicians and clinics in country.
- 5. Organise and deliver medical repatriation where necessary, including prompt communication of proposed plan and timescale.
- 6. Medical/security alerts for employees working overseas and UK based line management.

#### **Risk and Security Services**

- 1. Security risk ratings and advice for individual countries, or areas within those countries, to aid pre-trip planning, including access to information on terrorism and violence.
- 2. Ability to advise on and if necessary manage kidnap/hostage and ransom situations.
- 3. Provide real time information on major or local disruptive events for employees overseas and a single point of contact for security information.
- 4. Ability to review and provide specific advice on pre-travel risk assessments from UKRI Research Councils.
- 5. Provide country specific travel information (Country briefing notes, security risk areas, safe hotels etc) in hard copy or electronically online materials to aid trip planning.
- 6. Provide information on local political situations, recent history, corruption, and local crimes.
- 7. Provision of security service, if required, for high risk travel destinations.

#### **Travel Tracking and Communications**

An electronic travel management and tracking/location system

- 1. That can support data feeds from multiple platforms i.e. HR, Travel booking, insurance systems.
- 2. That has the ability to capture multiple types of travel, including air, rail, ground transport and hotels.
- 3. That has the ability for an individual to input travel segments which are not booked through approved channels.
- 4. That can identify travellers by other parameters such as flight number, hotel, event, risk ratings.
- 5. That can provide reporting capabilities with reports generated and able to be downloaded in Excel.
- 6. That provides 2-way communication/messaging with employees or groups of employees while in country.
- 7. That can provide a country risk rating and access to 24/7/365 global threat monitoring and be able to issue threat alerts.
- 8. That is able to identify travellers affected by a specific threat alert and communicate with them and their line managers, for example by email, SMS or through a mobile app.
- 9. That covers all the confidential and legal requirements related to the travel tracking tool and data management
- 10. Ability to communicate with employees via with a range of mobile devices such as mobile phones, satellite phones and Spot trackers.

#### **Pre-Travel Services and Support**

1. Provide a range of training courses or training materials, either by e-learning or face-to-face, covering travel safety, health, personal security and culture, which may be taken up as and when required.

#### Other Capabilities

- 2. A company infrastructure that would be available to us 24/7/365 worldwide in terms of offices, clinics, alarm centres, etc.
- 3. Sufficient expertise and skill levels of employees to support our account and technical teams in place to provide these services.
- 4. Sufficient expertise and logistical capability to manage and co-ordinate an emergency incident response such as a medical evacuation
- 5. Provide 24/7 access to intelligence analysts/subject matter experts for Travel Managers/Security Managers
- 6. Have backup/contingency/disaster recovery plans for your operations centres to ensure effective business continuity and maintained service delivery notwithstanding local or regional disruption.
- 7. Be able to set up billing arrangements with other partners such as travel insurance providers.
- 8. A dedicated account manager who will be our single point of contact and can provide quarterly account review meetings together with a support team that can be contacted by both telephone and email in normal working hours i.e. Monday to Friday 09:00 17;00 excluding public holidays.

#### **Implementation Support and Training**

- 1. Provide support and training on the use of any travel management tools to UKRI travel co-ordinators and key staff involved in managing overseas travel (approximately 100 people,) at up to 10 UKRI locations across the UK (expected to include UKRI London, MRC London, Polaris House Swindon, Cambridge BAS and MRC, BGS Keyworth and Edinburgh, STFC Didcot and Daresbury).
- Provide initial familiarisation training to UKRI travellers at each of the locations listed. This can be through a series of initial briefing sessions and possibly online in the future. Numbers would vary at each location but could be of the order of 100 people at each location.

#### **Estimated timescale**

It is recognised that some activities may be able to run in parallel across all UKRI Research Centres.

Week 1 – 2 Pre-start administration between UKRI and contractor –Confirm billing and invoicing arrangements. Arrange travel data input from UKRI travel booking system.

Week 2 – 6 System Set Up for each UKRI Research Council – Direct billing (e.g one off costs, medical treatments) agreements and procedures, identify UKRI Authorised persons (liaise with supplier about system set up, or to authorise relevant supplier interventions in event of emergency or support situations) and establish contact lists for each centre, agree operational procedures for each centre.

#### Week 6 – 10 Communications and Training in each UKRI Research Council –

All Research Councils to be up and running with the service by week 10 of the contract.

Total value of the contract over the 3 years shall not exceed £270,000.00 ex VAT, comprising three annual subscriptions from commencement of the Contract.

UKRI do not guarantee spend under this contract as it is dependent upon usage.

#### **Terms and Conditions**

Bidders are to note that any requested modifications to the Contracting Authority Terms and Conditions on the grounds of statutory and legal matters only, shall be raised as a formal clarification during the permitted clarification period.

Subject matter of the processing	The processing is needed so that the supplier can work with UKRI in managing the safety and security of employees working overseas on travel and fieldwork activities.
Duration of the processing	The processing would be for the duration of the contract, currently proposed to be three years from date of contract issue.
Nature and purposes of the processing	The processing would include collecting and storing employee data, retrieving the data when they travelled overseas as necessary. The data would be obtained from UKRI direct or through any UKRI travel booking system, held and processed in a software system that manages travel itineraries and has the ability to communicate with employees overseas by email or SMS. The information on this software would be available to the employee and their line manager and the supplier.

- 5.3.5. Questions marked 'for information only' do not contribute to the scoring model.
- 5.3.6. During the evaluation stage, the intention is that only Bidders who achieve a Pass of all the Mandatory and Discretionary requirements of the RFP will be considered for award stage evaluation.

#### **Award Evaluation of criteria**

#### **Non-Price elements**

Each question will be evaluated on a score from 0 to 100, which shall be subjected to a multiplier to reflect the percentage of the evaluation criteria allocated to that question.

Where an evaluation criterion is worth 20% then the 0-100 score achieved will be multiplied by 20%.

Example if a Bidder scores 60 from the available 100 points this will equate to 12% by using the following calculation:

Score = {weighting percentage} x {bidder's score} = 20% x 60 = 12

The same logic will be applied to groups of questions which equate to a single evaluation criterion.

The 0-100 score shall be based on (unless otherwise stated within the question):

0	The Question is not answered, or the response is completely unacceptable.
10	Extremely poor response – they have completely missed the point of the question.
20	Very poor response and not wholly acceptable. Requires major revision to the response to make it acceptable. Only partially answers the requirement, with major deficiencies and little relevant detail proposed.
40	Poor response only partially satisfying the award question requirements with deficiencies apparent. Some useful evidence provided but response falls well short of expectations. Low probability of being a capable supplier.
60	Response is acceptable but remains basic and could have been expanded upon. Response is sufficient but does not inspire.
80	Good response which describes their capabilities in detail which provides high levels of assurance consistent with a quality provider. The response includes a full description of techniques and measurements currently employed.
100	Response is exceptional and clearly demonstrates they are capable of meeting the requirement. No significant weaknesses noted. The response is compelling in its description of techniques and measurements currently employed, providing full assurance consistent with a quality provider.

All questions will be scored based on the above mechanism. Please be aware that there may be multiple evaluators. If so, their individual scores will be averaged (mean) to determine your final score as follows:

#### Example

Evaluator 1 scored your bid as 60

Evaluator 2 scored your bid as 40

Evaluator 3 scored your bid as 80

Evaluator 4 scored your bid as 60

Your final score will  $(60+40+80+60) \div 4 = 60$ 

#### **Price elements** will be evaluated on the following criteria.

The lowest price for a response which meets the pass criteria shall score 100.

All other bids shall be scored on a pro rata basis in relation to the lowest price. The score is then subject to a multiplier to reflect the percentage value of the price criterion.

For example - Bid 1 £100,000 scores 100.

Bid 2 £120,000 differential of £20,000 or 20% remove 20% from price scores 80

Bid 3 £150,000 differential £50,000 remove 50% from price scores 50.

Bid 4 £175.000 differential £75.000 remove 75% from price scores 25.

Bid 5 £200,000 differential £100,000 remove 100% from price scores 0.

Bid 6 £300,000 differential £200,000 remove 100% from price scores 0.

Where the scoring criterion is worth 50% then the 0-100 score achieved will be multiplied by 50

In the example if a supplier scores 80 from the available 100 points this will equate to 40% by using the following calculation: Score/Total Points multiplied by  $50 (80/100 \times 50 = 40)$ 

The lowest score possible is 0 even if the price submitted is more than 100% greater than the lowest price.

#### 5.5. Evaluation process

#### 5.5.1. The evaluation process will feature some, if not all, the following phases

- 7.1.4. The Bidder shall indemnify and keep indemnified UK SBS and the Contracting Authority against all actions, claims, demands, proceedings, damages, costs, losses, charges and expenses whatsoever in respect of any breach by the Bidder of this document.
- 7.1.5. If there is any doubt with regard to the ambiguity of any question or content contained in this questionnaire then PLEASE ASK a clarification question, but please ensure that your question is via the formal clarification process in writing to the UK SBS representative nominated. - 7.1.16. The Bidder shall not make contact with any other employee, agent or consultant of UK SBS or the Contracting Authority or any relevant OPB or Customer who are in any way connected with this procurement during the period of this procurement, unless instructed otherwise by the Contracting Authority.
- 7.1.17. The Contracting Authority shall not be committed to any course of action as a result of:

  - 7.3.1.3. Bidders shall not use any of the Information for any purpose other than for the purposes of submitting (or deciding whether to submit) a Response: and
  - 7.3.1.4. Bidders shall not undertake any publicity activity within any section of the media in relation to this procurement
- 7.3.2. Bidders may disclose, distribute or pass any of the Information to the Bidder's advisers, sub-contractors or to another person provided that either:
  - 7.3.2.1. This is done for the sole purpose of enabling a Response to be submitted and the person receiving the Information undertakes in writing to keep the Information confidential on the same terms as if that person were the Bidder; or

#### 7.4. Freedom of information

- 7.4.1. In accordance with the obligations and duties placed upon public authorities by the Freedom of Information Act 2000 (the 'FoIA') and the Environmental Information Regulations 2004 (the 'EIR') (each as amended from time to time), UK SBS and the Contracting Authority may be required to disclose information submitted by the Bidder to the to the Contracting Authority.
- 7.4.2. In respect of any information submitted by a Bidder that it considers to be commercially sensitive the Bidder should complete the Freedom of Information declaration question defined in the Question FOI1.2.
- 7.4.3. Where a Bidder identifies information as commercially sensitive, the Contracting Authority will endeavour to maintain confidentiality. - 7.7.3. Bidders should be mindful that the designated Contact should <u>not under any</u> <u>circumstances</u> be sent a copy of their Response outside of the e-sourcing tool. Failure to follow this requirement will result in disqualification of the Response.
- 7.8. Preparation of a Response
- 7.8.1. Bidders must obtain for themselves at their own responsibility and expense all information necessary for the preparation of Responses. Bidders are solely responsible for all costs, expenses and other liabilities arising in connection with the preparation and submission of their Response and all other stages of the selection and evaluation process. Under no circumstances will UK SBS or the Contracting Authority, or any of their advisers, be liable for any such costs, expenses or liabilities borne by Bidders or their sub-contractors, suppliers or advisers in this process.
- 7.8.2. Bidders are required to complete and provide all information required by the Contracting Authority in accordance with the Conditions of Response and the Request for Proposal. Responses received by any other method than requested will not be considered for the opportunity.

  - 7.9.9.1. The Bidder must demonstrate irrefutable evidence in writing they have made best endeavours to ensure the Response was received on time and that the issue was beyond their control.
  - 7.9.9.2. Any request for a late Response to be considered must be emailed to the Buyer in <u>Section 3</u> in advance of 'the deadline' if a bidder believes their Response will be received late.
  - 7.9.9.3. The Contracting Authority reserves the right to accept or reject any late Response without justification to the affected Bidder and make no guarantee it will consider any request for a late Response to be considered.
- 7.9.10. Do not seek changes to the Bid after responses have been submitted and the deadline (date and time) for receipt of responses has passed.

#### 7.10. Canvassing

7.10.1. Any Bidder who directly or indirectly canvasses any employee, or agent of UK SBS, the Contracting Authority or its members or any relevant OPB or any of its employees concerning the establishment of the Contract or who directly or indirectly obtains or

attempts to obtain information from any such officer, member, employee or agent or concerning any other Bidder, Response or proposed Response will be disqualified.

#### 7.11. Disclaimers

- 7.11.1. Whilst the information in this RFP, Due Diligence Information and supporting documents has been prepared in good faith, it does not purport to be comprehensive nor has it been independently verified.
- 7.11.2. Neither UK SBS, the Contracting Authority, nor any relevant OPB's nor their advisors, nor their respective directors, officers, members, partners, employees, other staff or agents:
  - 7.11.2.1. makes any representation or warranty (express or implied) as to the accuracy, reasonableness or completeness of the RFP; or
  - 7.11.2.2. accepts any responsibility for the information contained in the RFP or for their fairness, accuracy or completeness of that information nor shall any of them be liable for any loss or damage (other than in respect of fraudulent misrepresentation) arising as a result of reliance on such information or any subsequent communication.
- 7.11.3. Any persons considering making a decision to enter into contractual relationships with the Contracting Authority and/or, as applicable, relevant OPB following receipt of the RFP should make their own investigations and their own independent assessment of the Contracting Authority and/or, as applicable, relevant OPB and its requirements for the services and should seek their own professional financial and legal advice. #### 7.12.1. Any Bidder who:

- 7.12.1.2. communicates to any party other than UK SBS, the Contracting Authority or, as applicable, relevant OPB the amount or approximate amount of its proposed Response or information which would enable the amount or approximate amount to be calculated (except where such disclosure is made in confidence in order to obtain quotations necessary for the preparation of the Response or insurance or any necessary security); or
- 7.12.1.3. enters into any agreement or arrangement with any other party that such other party shall refrain from submitting a Response; or
- 7.12.1.4. enters into any agreement or arrangement with any other party as to the amount of any Response submitted; or
- 7.12.1.5. offers or agrees to pay or give or does pay or give any sum or sums of money, inducement or valuable consideration directly or indirectly to any party for doing or having done or causing or having caused to be done in relation to any other Response or proposed Response, any act or omission,

shall (without prejudice to any other civil remedies available to the Contracting Authority and without prejudice to any criminal liability which such conduct by a Bidder may attract) be disqualified.

#### 7.13. No inducement or incentive

7.13.1. The RFP is issued on the basis that nothing contained in it shall constitute an inducement or incentive nor shall have in any other way persuaded a Bidder to submit a Response or enter into the Contract or any other contractual agreement.

#### 7.14. Acceptance of the Contract

- 7.14.1. The Bidder in submitting the Response undertakes that in the event of the Response being accepted by the Contracting Authority and the Contracting Authority confirming in writing such acceptance to the Bidder, the Bidder will within 7 days of being called upon to do so by the Contracting Authority execute the Contract in the form set out in the Contract Terms or in such amended form as may subsequently be agreed.
- 7.14.2. The Contracting Authority shall be under no obligation to accept the lowest priced or any Response.

#### 7.15. Queries relating to the Response

- 7.15.1. All requests for clarification about the requirements or the process of this procurement shall be made in through the e-sourcing tool unless where the e-sourcing tool is unavailable due to Delta eSourcing system maintenance or failure, in this instance all clarifications shall be by email to the contact defined in <a href="Section 3">Section 3</a>.
- 7.15.2. The Contracting Authority will endeavour to answer all questions as quickly as possible but cannot guarantee a minimum response time.
- 7.15.3. In the event of a Bidder requiring assistance uploading a clarification to the esourcing portal they should use the contact details defined in <u>Section 3</u>.
- 7.15.4. No further requests for clarifications will be accepted after 7days prior to the date for submission of Responses.

In order to give prospective Bidders reasonable time in which to take the amendment into account in preparing their Responses, the Contracting Authority may, at its discretion, extend the time and/or date for receipt of Responses.

#### 7.17. Modification and withdrawal

- 7.17.1. Bidders may modify their Response where allowable within the e-sourcing tool. No Response may be modified after the deadline for submission of Responses.
- 7.17.2. Bidders may withdraw their Response at any time prior the deadline for submission of Responses [or any other time prior to accepting the offer of a Contract]. The notice to withdraw the Response must be in writing and sent to the Contracting Authority by recorded delivery or equivalent service and delivered to the Head of Policy UK SBS at UK Shared Business Services Ltd, Procurement, Polaris House, North Star Avenue, Swindon, Wiltshire, SN2 1ET

#### 7.18. Right to disqualify or reject

- 7.18.1. The Contracting Authority reserves the right to reject or disqualify a Bidder where
  - 7.18.1.1. the Bidder fails to comply fully with the requirements of this Request for Proposal or presents the response in a format contrary to the requirements of this document; and/or
  - 7.18.1.2. the Bidder is guilty of serious misrepresentation in relation to its Response; expression of interest; or the Response process; and/or
  - 7.18.1.3. there is a change in identity, control, financial standing or other factor impacting on the selection and/or evaluation process affecting the Bidder.

#### 7.19. Right to cancel, clarify or vary the process

- 7.19.1. The Contracting Authority reserves the right to:
  - 7.19.1.1. cancel the evaluation process at any stage; and/or
  - 7.19.1.2. require the Bidder to clarify its Response in writing and/or provide additional information. (Failure to respond adequately may result in the Bidder not being selected).

#### 7.20. Notification of award

- 7.20.1. The Contracting Authority will notify the successful Bidder of the Contract award in writing and will publish an Award Notice in the Official Journal of the European Union in accordance with the Regulations within 30 days of the award of the contract.
- 7.20.2. As required by the Regulations all successful and unsuccessful Bidders will be provided with an email advising the outcome of the submission of their RFP response.

"Contracting Bodies"	means the Contracting Authority and any other contracting authorities described in the OJEU Contract Notice
"Contracting Authority"	A public body regulated under the Public Contracts Regulations on whose behalf the procuremetn is being run
"Customer"	means the legal entity (or entities) for which any Contract agreed will be made accessable to.
"Due Diligence Information"	means the background and supporting documents and information provided by the Contracting Authority for the purpose of better informing the Bidders responses to this Request for Proposal
"EIR"	mean the Environmental Information Regulations 2004 together with any guidance and/or codes of practice issued by the Information Commissioner or relevant Government department in relation to such regulations
"FolA"	means the Freedom of Information Act 2000 and any subordinate legislation made under such Act from time to time together with any guidance and/or codes of practice issued by the Information Commissioner or relevant Government department in relation to such legislation
"Lot"	means a discrete sub-division of the requirements
