THIS CONTRACT is made

BETWEEN: The Secretary of State for International Development at the

Department for International Development, [Insert Address] ("DFID");

AND : Mott Macdonald Limited trading as Cambridge Education

("Supplier") whose principal place of business, or, where the Supplier is a company, whose registered office is situate at Mott MacDonald House, 8-10 Sydenham Road, Croydon, CR0 2EE, UK (registered in England: number 1243967)

(together "the Parties").

WHEREAS:

- 3.1. **A.** DFID requires the Supplier to provide the services as defined in Section 3 (the "Services") to The Tanzanian Ministry of Education and Vocational Training (MoEVT) and Prime Minister's Office Regional Administration & Local Government (PMO-RALG), targeted upon the Education Ministry Delivery Unit (MDU) (the "Recipient"); and
- **B.** the Supplier has agreed to provide the Services on the terms and conditions set out in this Contract.

2. Contract Signature

If the Original Form of Contract is not returned to the Contract Officer (as identified in Section 4) duly completed (including the applicable Purchase Order Number at the top of Section 1),





and signed and dated on behalf of the Supplier within **15 working days** of the date of signature on behalf of DFID, DFID will be entitled, at its sole discretion, to declare this Contract void.

No payment will be made to the Supplier under this Contract until a copy of the Form of Contract, signed on behalf of the Supplier, is returned to the Contract Officer.

3. Commencement and Duration of the Services

The Supplier shall start the Services on 18th May 2015 (the "Start Date") and shall complete them by 31st July 2018 (the "End Date") unless this Contract is terminated earlier in accordance with its terms and conditions.

4. Financial Limit
